## Commission blocks effort on landfill

### Walter Hill operation could have moved here

Commissioners voted unanimously Saturday, April 15 to block any effort to move Rutherford County's landfill operation to Cannon County.

"If you pass this resolution, no one can build a landfill here without the County Commission's permission," County Executive Mike Gannon told the commissioners.

Commissioner Mark Barker moved and Jim Bush seconded the motion to adopt Resolution 2016-9 to Adopt the Jackson Law.

The Jackson Law requires local approval by the county and the municipality, if any, in which a landfill is to be located that will accept municipal and county solid waste and household garbage. This law also establishes procedures for the granting of this approval.

Originally passed by Cannon County in 1992, the Jackson Law was recently amended, making it necessary for the Commission to readopt it.

Gannon said Cannon officials recently learned that Allied Waste and Rutherford County were considering a plan to move their Walter Hill operation here.

Rutherford County could buy land in Cannon County and move the operation here. The Locke Creek area was suggested by Rutherford County's CTAS representative, Gannon said.

"If push comes to shove, they will move it to Cannon and not back to the Walter Hill area," the county executive said.

Commissioner Glenn Steakley, who represents Cannon County on a four-county solid waste panel, said he recently asked Rutherford County's representative about the possible plan.

"He didn't deny it," Steakley said.

In addition to handling all the trash from Rutherford County and Murfreesboro, the Allied Waste landfill also buries all the trash from Metro Nashville and other communities as well.

The Commission quickly passed the measure by nine votes. Commissioner Todd Hollandsworth was absent. A two-thirds majority was required.

In other action, the County Commission appointed Robert D. Bush as Cannon County Historian. Bush's selection was endorsed by the Cannon County Historical Society. See LANDFILL, Page 9

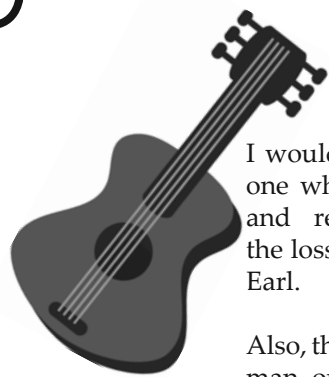
### American Conservative Union Foundation Awards Rep. Mark Pody with "Award for Conservative Excellence" for Standing for Conservative Principles

## Back to Basics - Low Maintenance Flower Garden Care

Grow a beautiful flower garden with minimal care by investing a bit of time at the start of the season to reduce on-going care.

Always match flowers to the growing conditions and the care you are willing to provide. Low maintenance plants need minimal or no deadheading and staking. This means you'll be growing good-looking plants with little effort on your part. And if the plants are suited to the growing conditions and resistant to common pests you'll be doing less work managing insect and disease problems. Further reduce your workload by selecting self cleaning or free flowering annuals and perennials and those bred for long bloom and compact growth. You'll enjoy more colorful flowers with less pruning and grooming.

Ageratum, angelonia, calibrochoa and many of the newer petunia cultivars are just a few of the annuals that do not need regular deadheading for continual bloom. Include perennials like willow amsonia, bugbane, Solomon seal, turtlehead and sedum autumn joy for lower maintenance and big results.

Prepare the soil and provide proper fertilization before planting. Work several inches of compost or other organic matter into the top 8 to 12 inches of soil to improve drainage and water holding ability. Incorporate a low nitrogen organic fertilizer like Milorganite (milorganite.com) at the same time. The slow release formulation provides needed nutrients throughout most if not all of the season. Plus, it promotes slow steady growth that won't interfere with flowering, is less susceptible to pests and is more drought tolerant.

Properly space the plants, making sure they have sufficient room to reach their full size. Overcrowding means you will be thinning or dividing plants more often or battling disease problems instead of enjoying the full beauty the plants provide.

Consider removing flowers on annuals at planting. This allows plants to focus energy on establishing roots instead of flowers. Can't bear to do this? Then remove the flowers on every other plant or every other row. Then a week or two later remove the flowers on the remaining plants. You will soon be rewarded with full compact plants that will produce more flowers throughout the season.

Pinch back long and leggy transplants. Use a hard pinch to remove the tip and several inches of stem. Use your pruners or fingers to remove stems just above a set of leaves. The remaining plant will still look good while you wait for new leaves and stems to grow and produce new blooms.

Encourage branching on single stemmed plants with a soft pinch. Remove just the uppermost portion of the stem where the leaves and tip are starting to develop. Soon you will have a well branched plant and more blossoms. Improve plant posture and reduce the need for staking with early season pruning. Keep mums and asters compact by pinching them back to six inches throughout June to encourage compact growth. Eliminate floppy growth and the need for staking on late bloomers like Boltonia, Autumn Joy sedum, Russian sage and Heliopsis

Revive catmint and perennial salvia that flop open in the center with pruning. Cut flopping plants back halfway once or twice a season as needed.

And don't forget to mulch. Covering the soil surface with an inch or two of shredded leaves, evergreen needles/pine straw or other organic material will conserve moisture, suppress weeds and improve the soil as they decompose.

Always water new plantings often enough to keep the top few inches of soil moist. Once established water thoroughly and only as needed. This encourages drought tolerant roots, so you'll need to do less watering in the future.

With proper planning, plant selection and soil preparation you can keep your ongoing care to a minimum. That means more time to relax and enjoy your beautiful garden.

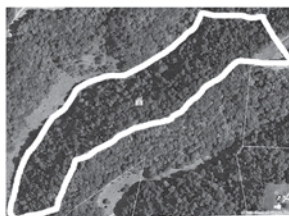

# A little history about Uriah Stone

Maybe the name Uriah Stone tickles something in your memory? But more likely, not, unless your name is Col. Jim Stone.

Uriah was perhaps the first white man to travel up the stream now named in his honor. Yes, Stones River is named after this long hunter and Col. Jim is his descendant.

In 1767, a party of white hunters passed through the area.

Col. James Smith, of Pennsylvania, explored what was later called the Cumberland country during the summer of 1766. The following is an extract from his journal:

"I set out about the last of June, 1766, and went in the first place to the Holston River, and from there I travelled westwardly in company with Joshua Horton, Uriah Stone, William Baker and James Smith, who came from near Carlisle, Pennsylvania.

"We explored the country south of Kentucky. We also explored the Cumberland and Tennessee Rivers from Stone's River down to the Ohio. Stone's River is a South branch of the Cumberland and empties into it above Nashville. We gave it this name in our Journal in May, 1767, after one of my fellow travellers, Mr. Uriah Stone, and I am told it retains the same name unto this day."

While little is known about Uriah Stone, he predated the first settlers in the area and carried tales of this bountiful, uninhabited land with him when he returned to North Carolina. It was 14 years, however, before the first settlers arrived.

Between the naming of Stones River and the arrival of the first settlers in Middle Tennessee, Stone hunted along the river bearing his name with a French trader, who managed to steal his boat and furs.

Stone returned to what now is known as the Cumberland valley in 1769 along with fellow hunters Kasper Mansker, Isaac and Abraham Bledsoe, Joseph Drake and Robert Crockett. Although Crockett was killed, the various trails, salt licks and camping spots identified by the 1766 and 1769 expeditions would later help guide the first white settlers to the Middle Tennessee area.

Uriah Stone was the father of at least two sons, William Stone and

Archibald Stone.

When settlers lead by John Donelson moved to "Fort Nashborough" Indians moving up Stones River posed serious concerns.

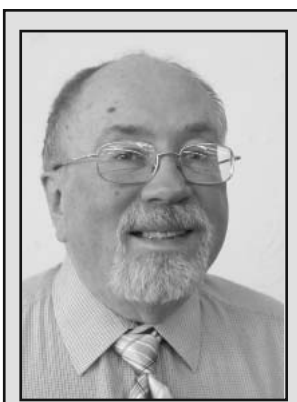
In the spring of 1780, Donelson knew Nashville area pioneers seriously needed to plant a corn crop to insure their survival. Rounding a bend in the Cumberland, Donelson discovered what he was looking for near the confluence of the Cumberland and Stones rivers.

Donelson docked his boat along Stones River at a spot still called Clover Bottom. The family quickly built dug-in shelters on the bluff overlooking the river. Harassment from the Indians, and heavy rains, caused the Donelson family to move to Mansker's Fort for protection. But by fall, the don was ready to pick and John Donelson sent word to Fort Nashborough.

Men from the fort harvested the corn, while on the opposite bank of Stones River, Donelson and his family worked to harvest cotton. When the boats were loaded, Indians attacked with only three settlers from Fort Nashborough surviving.

Subsequently, Robertson became more aggressive dealing with the Indian threat. Teams of scouts were dispatched to watch for activity and ultimately the settlers took action in their own hands. In 1794, Robertson sent an expedition lead by Gen. Orr to crush the Indian villages on the Tennessee River in northern Alabama. Eventually, settlers were able to move up Stones River and into what later became Rutherford and Cannon counties.

Cannon County was established in 1836 from portions of Rutherford and Wilson counties. Prior to that, Rutherford's boundary had extended nearly to Woodbury.

# Tolerate social harmony?

Here's a question for you: how much social harmony can democracy tolerate?

During the past few weeks and months we've seen more and more calls for the suppression of ideas this group or that group finds offensive, harmful or wrong. Indeed, not just calls for suppression, but actual violence by one group against another with conflicting political views.

At every political rally it seems someone is trying to prevent the other side from presenting their views, even getting to the point of pushing and shoving. It makes me wonder, if people are so sure of their position, why are they trying to forcefully prevent others from expressing contrary views?

And a few weeks ago a group of state attorneys general formed an organization to prosecute people who disagree with popular notions of climate change. In other words, a group of highly-placed government officials have decided to prosecute people who propose ideas that may be contrary to accepted orthodoxy.

Somehow I had the idea punishing people who don't believe in commonly accepted attitudes and prevailing views went out with the Spanish Inquisition.

Certainly democracy is a noisy

process. But it can still be noisy and civil at the same time. And it is the civility that seems to be sorely lacking. What is also apparently lacking is a willingness to calmly discuss opposing points of view.

It seems those who would stifle debate and discussions are afraid of what others have to say. Otherwise why would they try to prevent debate on public policy issues? Or perhaps they have no faith in the public, and think they must be protected from heretical or unpleasant ideas.

But if they are so afraid a little discussion will change someone's mind, well, just how strong and valid are those ideas in the first place? Apparently democracy is a difficult, noisy process, with disagreements, confusion, dissension and controversy. Attempts to stifle the noise don't lead to changed minds. It only leads to damage to democracy.

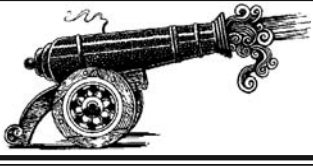

right to put another person's life at risk like that," said Tim Bell, Chief Operating Officer.

Texting and driving in Tennessee can result in a \$50 fine for a driver of any age. For young drivers who have Learner's Permits or Intermediate Restricted licenses, cell phone use of any kind while driving is illegal.

Preliminary data reveals that in 2015, Tennessee experienced its highest number of known distracted driving crashes at 22,964. These crashes resulted in the death of 51 people. Each day, twenty-five individuals on average are injured in a crash caused by a distracted driver. Nearly twelve percent of all crashes in Tennessee last year were caused by someone who was driving distracted.

"Crashes caused by distracted drivers have more than doubled in the last decade," said Tennessee Highway Safety Office Public Information Officer

# LANDFILL...

Commissioners voted unanimously Saturday, April 15 to block any effort to move Rutherford County's landfill operation to Cannon County.

"If you pass this resolution, no one can build a landfill here without the County Commission's permission," County Executive Mike Gannon told the commissioners.

Commissioner Mark Barker moved and Jim Bush seconded the motion to adopt Resolution 2016-9 to Adopt the Jackson Law.

The Jackson Law requires local approval by the county and the municipality, if any, in which a landfill is to be located that will accept municipal and county solid waste and household garbage. This law also establishes procedures for the granting of this approval.

Originally passed by Cannon County in 1992, the Jackson Law was recently amended, making it necessary for the Commission to readopt it.

Gannon said Cannon officials recently learned that Allied Waste and Rutherford County were considering a plan to move their Walter Hill operation here.

Rutherford County could buy land in Cannon County and move the operation here. The Locke Creek area was suggested by Rutherford County's CTAS representative, Gannon said.

"If push comes to shove, they will move it to Cannon and not back to the Walter Hill area," the county executive said.

Commissioner Glenn Steakley, who represents Cannon County on a four-county solid waste panel, said he recently asked Rutherford County's representative about the possible plan.

"He didn't deny it," Steakley said.

In addition to handling all the trash from Rutherford County and Murfreesboro, the Allied Waste landfill also buries all the trash from Metro Nashville and other communities as well.

The Commission quickly passed the measure by nine votes. Commissioner Todd Hollandsworth was absent. A two-thirds majority was required.

In other action, the County Commission appointed Robert D. Bush as Cannon County Historian. Bush's selection was endorsed by the Cannon County Historical Society.

Bush is the first county historian since the death of Robert L. Mason several years ago.

Commissioners voted 7 to 2 in favor of applying for a 80-20 matching grant to construct a walking trail around the county fairground.

"It would upgrade the facility completely," County Executive Gannon said. "It would be a pretty neat thing to do."

Commissioner Richie Hunter moved for passage. Adam Melton seconded. Voting yes were Mark Barker, Karen Ashford, James Holloway, Glenn Steakley, Brent Bush, Richie Hunter and Adam Melton. Voting no were Russell Reed and Jim Bush.

## MADD launches efforts

Mothers Against Drunk Driving (MADD) Tennessee announced that Governor Bill Haslam has proclaimed April 21, 2016, as PowerTalk 21 Day in Tennessee in conjunction with the national PowerTalk 21 Day - a day for parents to begin ongoing conversations with their kids about alcohol. The event is designed to empower parents to talk early and talk often with children about the dangers of underage drinking and to never ride with a drinking driver. Nationwide is the national presenting sponsor, and GM Foundation is the national supporting partner.

Around the state, MADD speakers will also be working with schools this month to talk to parents and kids about the dangers of underage drinking. On April 21, MADD State Program Manager and Victim of Drunk Driving, Phaedra Marriott-Olsen will speak at Briarcrest Christian School and Germantown High School in West Tennessee.

New research this year comes from a 2016 MADD and Nationwide survey which showed that parents talk with their children about the dangers of underage drinking and riding with a drinking driver, but could be inadvertently sending a different message through their actions. More than 80% of parents surveyed have talked with their children about the dangers of riding with a drinking driver. However, 43% of parents admitted to having a drink or two at dinner and then driving their children home in the past year.

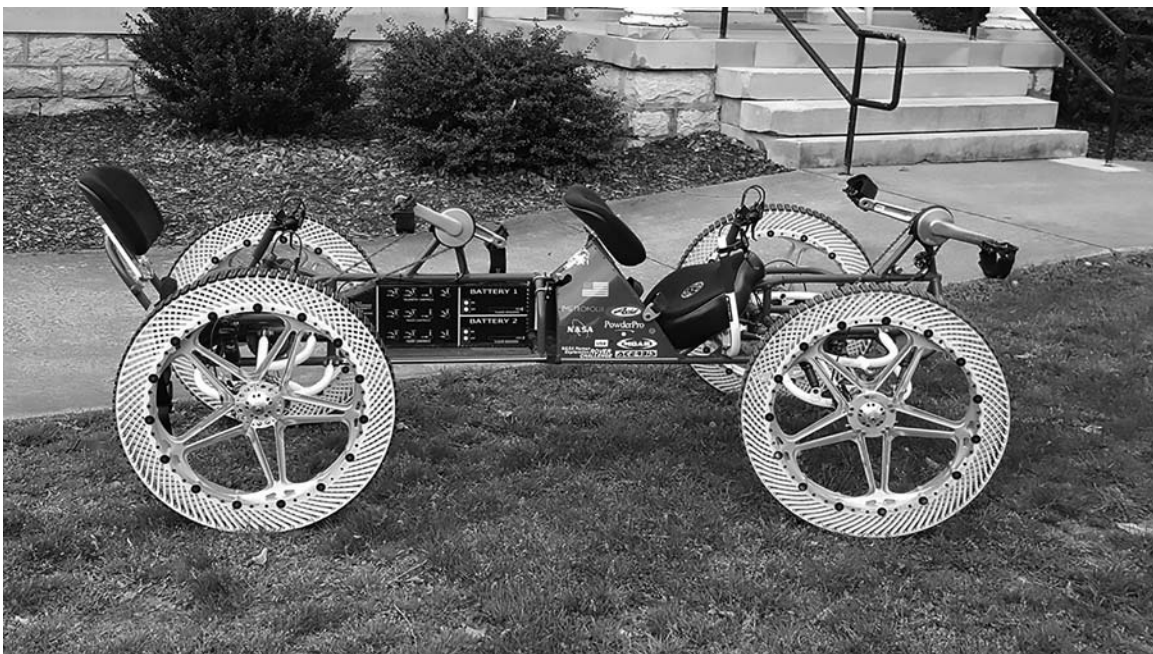

## MTSU places Seventh at NASA Lunar Rover Event

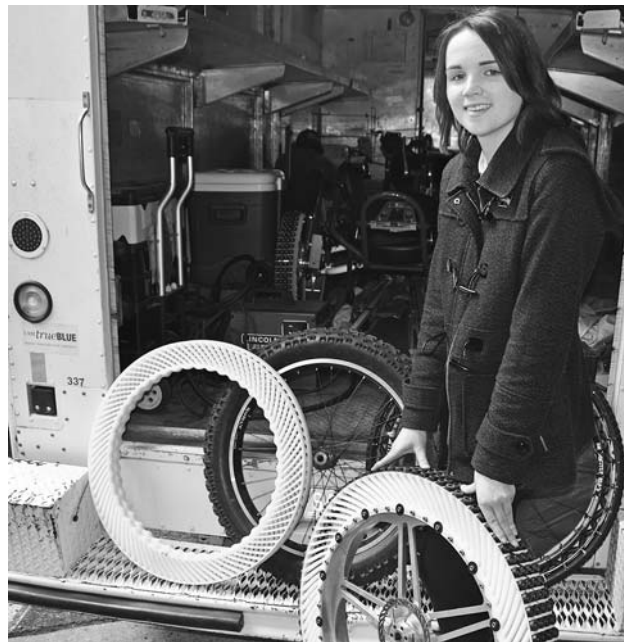
The MTSU Experimental Vehicles Program's lunar rover team members used a new airless tire design and parts assembly to land a top-10 finish at this year's NASA Human Exploration Rover Challenge.

Motivated by a competition rules change regarding tires, recent MTSU graduate Thomas Kenney's design and the machine shop work by junior mechatronics engineering major Kelly Maynard and others eventually kept the MTSU entry among the elite in the international field competing in Huntsville, Alabama, April 8-9 after a best-in-U.S. and third-place overall finish in 2015.

The event is held annually for university and high school teams to encourage research and development of new technology for future mission planning and crewed space missions to other worlds.

By competition's end,

## Young Historians Advance to National Competition

Nearly 70 students will be representing Tennessee at National History Day later this summer. Those students placed first or second in their categories at Tennessee History Day on Saturday.

Tennessee History Day participants entered projects in five categories: documentaries, exhibits, performances, websites and papers. While projects must relate to the annual theme, students are encouraged to be creative when choosing a topic. This year's theme was "Exploration, Encounter,

Exchange." 97 students received medals for their efforts, 27 students were awarded special prizes, two educators were recognized as teachers of the year and one teacher was named Behring Teacher Ambassador.

This year, National History Day will be held June 12 through June 16 on the University of Maryland campus in College Park, Maryland.

"I am proud of all our students," said Tennessee History Day coordinator Jennifer C. Core. "I'm impressed by

how enthusiastic they are about their selected topics and how effectively they present their findings to a sophisticated audience. I always learn something from our students and I know the judges do as well. This year our students researched topics ranging from World War II prisoners of war to Ada Lovelace to Suleiman the Magnificent."

The judges at Saturday's competition - including university professors, graduate students, high school teachers, librarians, archivists and other public

historians - picked the winners from the 152 submitted projects.

Since 1974, History Day has grown from a small local competition in Cleveland, Ohio with about 100 students into an event that attracts about a half million students nationwide each year.

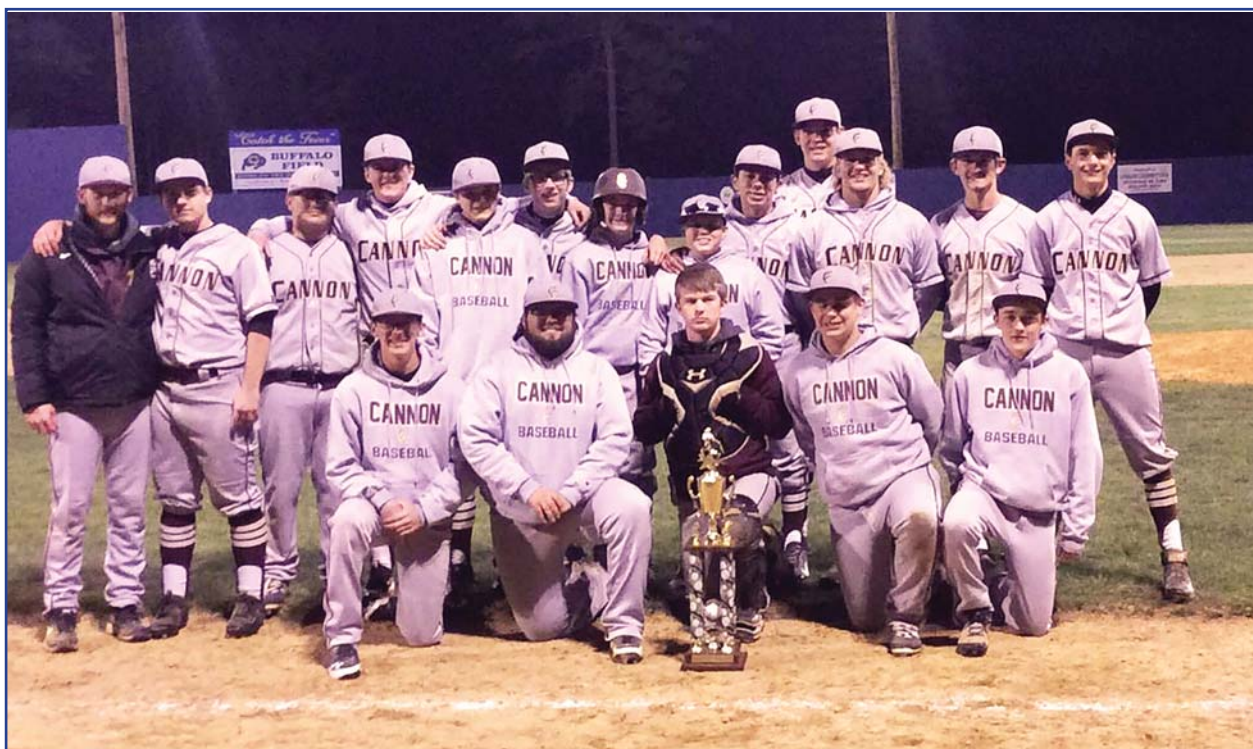

White County, a day later losing 11-3 and winning 10-0. Their game against MTCS was rained out on April 11.

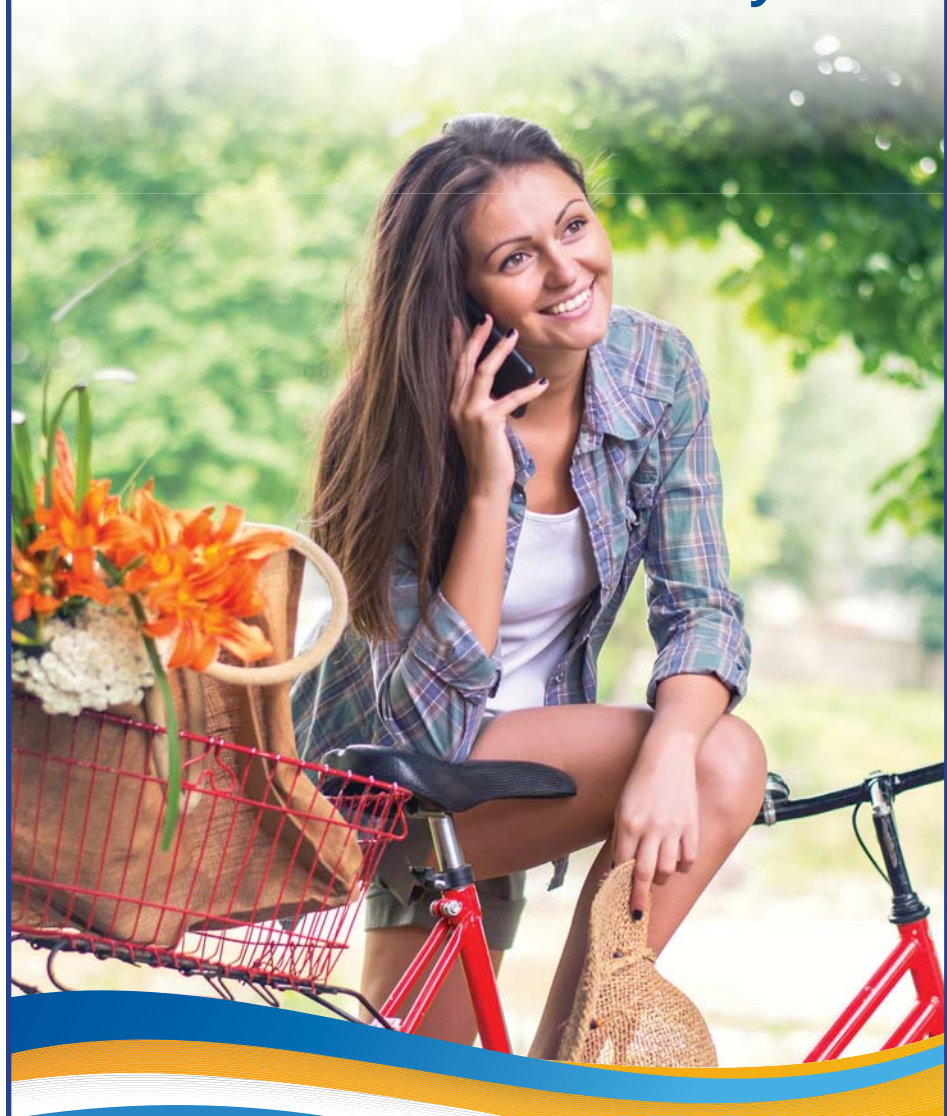

## Canberry Crumble

A New Crumbly Crisp

This cake does double duty as breakfast and as dessert. Have on hand for unexpected holiday guests.

**Filling:**  
1/2 cup dried apricots, chopped  
1/2 cup boiling water (12-ounce) bag fresh cranberries  
1 firm, ripe pear, cored and sliced  
1 Granny Smith apple, cored and sliced  
1/4 cup sugar

**Cake:**  
Cooking spray  
1 1/2 cups all-purpose flour  
1 cup sugar  
1/2 cup cold butter, cut into small pieces  
1/2 teaspoon salt  
1 egg  
1/2 teaspoon baking soda  
2/3 cup buttermilk  
1/2 teaspoon vanilla extract

**Streusel:**  
3/4 teaspoon cinnamon  
1/3 teaspoon ground nutmeg  
2 tablespoons brown sugar  
2 tablespoons old-fashioned oats  
1 tablespoon water  
1/2 cup chopped walnuts or pecans

Spray a 13 x 9-inch baking pan with cooking spray.  
2. To prepare filling, combine dried apricots and water in a small bowl; let stand 30 minutes. Combine remaining filling ingredients in a large bowl. Add apricots and soaking liquid; mix well. Spoon into prepared pan.  
3. To prepare cake, combine flour, sugar, butter and salt in a food processor. Pulse until crumbly. Set aside 1 cup for streusel topping.  
4. Add egg to flour mixture in food processor. Dissolve baking soda in buttermilk, stir well, and add to flour mixture. Add vanilla. Pulse to make a cake batter. Pour over cranberry mixture in pan.  
5. To prepare streusel, add streusel ingredients to reserved flour mixture. Toss well. Sprinkle over cake batter and bake 40 to 45 minutes or until a wooden pick inserted in center comes out clean. Cool on a wire rack. Serves 12.

## The Death of Stephen

In the early Christian church, a few years after the crucifixion and resurrection of Jesus Christ, the believers in Jerusalem put all their resources together. However, the Greek Christians complained that their widows were being ignored in the daily distribution of food. Seven deacons were appointed by the group to oversee sharing of food and other everyday matters. Stephen, a man "full of faith and of the Holy Spirit," was among them. Stephen performed great wonders and miracles among the people of Jerusalem. Jews of the outer provinces began to argue with him, but they could not win against his spirit-filled wisdom. So in secret, they convinced false witnesses to lie, accusing Stephen of blasphemy against Moses and God. In ancient Judaism, blasphemy was a crime punishable by death. The accusers brought Stephen before the Sanhedrin, the great council, where the false witnesses said they heard Stephen say Jesus would destroy the Temple. Stephen launched into a powerful defense, detailing the history of the Jews from Abraham through the prophets. He concluded that the Sanhedrin had murdered the prophesied Messiah, Jesus of Nazareth. The crowd became furious at him, but Stephen looked up to heaven: "Look," he said, "I see heaven open and the Son of Man standing at the right hand of God." (Acts 7:56, NIV) At that, the mob dragged Stephen out of the city and began to stone him. They laid their coats in front of a young man named Saul of Tarsus. As he was dying, Stephen prayed to God to receive his spirit, and further asked God not to hold the sin against his killers. Stephen "fell asleep," or died. Other believers buried Stephen and mourned his death.

Points of Interest from the Story:  
All seven appointed deacons, including Stephen, had Greek names, showing that the members of the early church considered it a universal institution, not just another sect of Judaism. Under Roman law, Stephen's death was illegal. The Sanhedrin was not authorized to impose the death penalty, but the stoning appeared to be the result of mob action.

## USDA Expands Safety-Net for Dairy Operations Adding Next-Generation Family Members

Agriculture Secretary Tom Vilsack today announced that dairy farms participating in the Margin Protection Program (MPP) can now update their production history when an eligible family member joins the operation. The voluntary program, established by the 2014 Farm Bill, protects participating dairy producers when the margin - the difference between the price of milk and feed costs - falls below levels of protection selected by the applicant.

"This change not only helps to strengthen a family dairy operation, it also helps new dairy farmers get started in the family business, while ensuring that safety net coverage remains available for these growing farms," said Secretary Vilsack. "When children, grandchildren or their spouses become part of a dairy operation that is enrolled in MPP, the production from the dairy cows they bring with them into the business can now be protected."

By strengthening the farm safety net, expanding credit options and growing domestic and foreign markets, USDA is committed to helping American farming operations remain successful.

The U.S. Department of Agriculture's (USDA) Farm Service Agency (FSA) published a final rule which makes these changes effective on April 13, 2016. Any dairy operation already enrolled in the Margin Protection Program

that had an intergenerational transfer occur will have an opportunity to increase the dairy operations production history during the 2017 registration and annual coverage election period. The next election period begins on July 1, 2016, and ends on Sept. 30, 2016. For intergenerational transfers occurring on or after July 1, 2016, notification must be made to the FSA within 60 days of purchasing the additional cows. Each participating dairy operation is authorized one intergenerational transfer at any time of its choosing until 2018.

For \$100 a year, dairy producers can receive basic catastrophic protection that covers 90 percent of milk production at a \$4 margin coverage level. For additional premiums, operations can protect 25 to 90 percent of production history with margin coverage levels from \$4.50 to \$8, in 50 cent increments. Annual enrollment in the program is required in order to receive margin protection. The final rule also provides improved risk protection for dairy farmers that pay premiums to buy-up higher levels of coverage by clarifying that 90 percent of production is

covered below the \$4 level even if a lower percentage was selected above the \$4 margin.

Earlier this year, FSA gave producers the opportunity to pay their premium through additional options including via their milk cooperative or handler. This rule facilitates those options and also clarifies that the catastrophic level protection at \$4 will always cover 90 percent of the production history, even if a producer selected a less than a 90 percent percentage for the buy-up coverage.

Assuming current participation, had the Margin Protection Program existed from 2009 to 2014, premiums and fees would have totaled \$500 million while providing producers with \$2.5 billion in financial assistance, nearly \$1 billion more than provided by the old Milk Income Loss Contract program during the same period.

The Margin Protection Program was established by the 2014 Farm Bill, which builds on USDA's historic investments in rural America over the past seven years. Since 2009, USDA has worked to strengthen and support American agriculture, an industry that supports one in 11 American jobs, provides American

consumers with more than 80 percent of the food we consume, ensures that Americans spend less of their paychecks at the grocery store than most people in other countries, and supports markets for homegrown renewable energy and materials. USDA has provided \$5.6 billion of disaster relief to farmers and ranchers; expanded risk management tools with products like to Whole Farm Revenue Protection; helped farm businesses grow with \$36 billion in farm credit; provided \$4.32 billion in critical agricultural research; established innovative public-private conservation partnerships such as the Regional Conservation Partnership Program; developed new markets for rural-made products, including more than 2,500 biobased products through USDA's BioPreferred program; and invested \$64 billion in infrastructure, housing and community facilities to help improve quality of life in rural America. ### Supreme Court Records Now Available for Online Ordering

The Tennessee State Library & Archives recently launched a new online ordering system for Supreme Court cases. 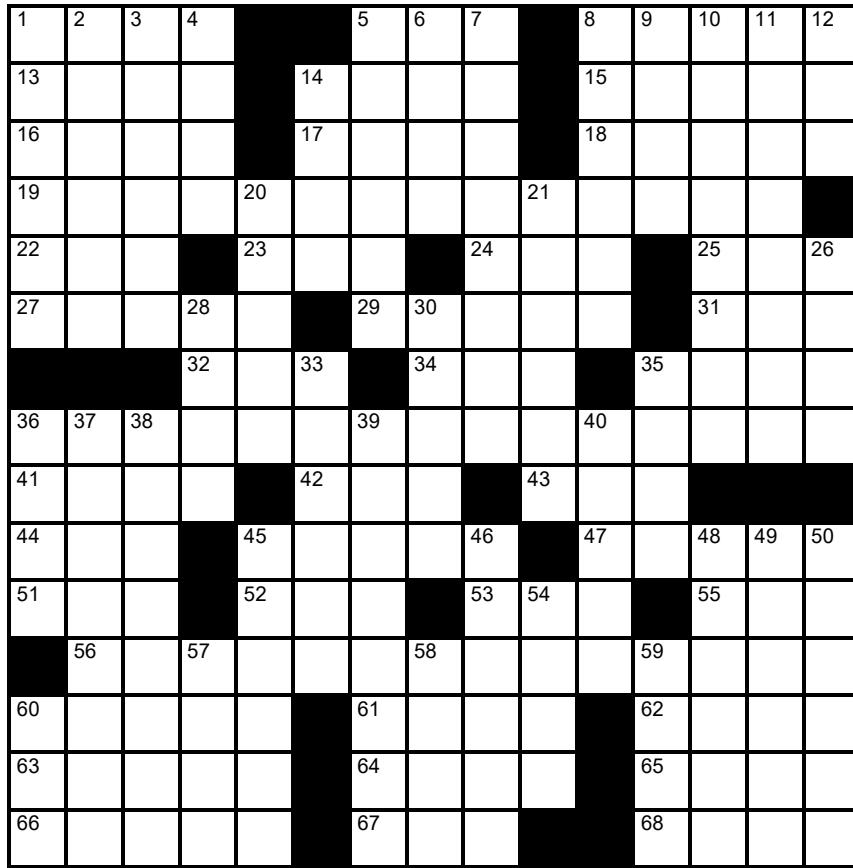

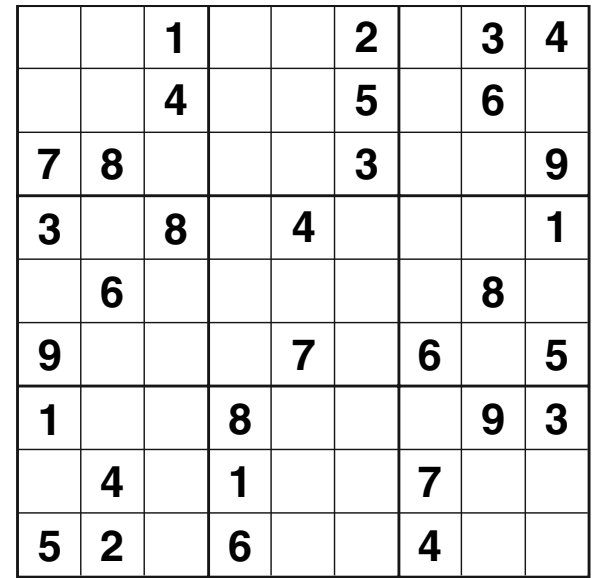

## Savvy Senior

### Auto Insurance Discounts for Older Drivers

Dear Savvy Senior,

I've read that many car insurance companies offer a variety of discounts to older drivers when they retire or reach a certain age. What can you tell me about this?

Discount Seeker

Dear Seeker,

Most auto insurance companies offer policyholders a wide variety of discounts, many of which can benefit retirees. Auto insurers love older drivers because they're experienced behind the wheel and they drive less than younger age groups, which makes them a lower risk for accidents and a safer bet for insurance companies.

While discounts will vary by insurer, many of these benefits can reduce your overall premium by 15 to 20 percent or more, and you are usually allowed to combine discounts to increase your savings, though total discounts are often capped at around 25 percent.

To find out what discounts may be available to you, contact your auto insurer and inquire about these benefits, and any others that may benefit you.

**Age discount:** Many auto insurance companies offer a general "senior" discount that will reduce your premium just because you've reached a specific age. The actual name and amount of the discount will vary by insurer.

**Allstate, for example,** provides a "senior adult discount" of up to 10 percent to drivers who are at least 55 years old and aren't actively looking for full-time work. And Liberty Mutual offers a "newly retired discount" to drivers who reach that employment milestone, regardless of age.

**Low mileage discount:** Most insurers offer discounts to customers who drive limited miles each year, which is often beneficial to retirees who drive less because they don't commute to work every day. The fewer miles you drive, the lower your odds of getting into an accident.

The parameters of low mileage differ by insurer, but generally about a 10 percent discount is available for driving less than 5,000 to 8,000 miles each year, although smaller discounts may also be available to seniors who drive more than this but less than 15,000.

**Drivers Ed discount:** Many states require insurance companies to offer "defensive-driving" discounts to drivers who take a refresher course to brush up on their safety skills. The discounts vary usually ranging between 5 and 15 percent.

**Driver safety courses** are inexpensive, usually costing around \$20 to \$30 and can often be taken in a classroom or online. To locate a class contact your local AAA (aaa.com), which operates a Driver Improvement Course for seniors, or AARP (aarp.org/driversafety, 888-227-7669), which offers the Smart Driver Course to members and non-members.

**Club member discount:** Insurers offer discounts to members of clubs and associations with which they have partnered. These could include professional associations, workers' unions, large employers or membership organizations such as AAA, the National Active and Retired Federal Employees Association, the Seniors Coalition, AARP, etc. You could even qualify for savings based on the college you attended or the fraternity or sorority you belonged to decades ago.

**Safe driving discount:** Many insurance providers now offer discounts based on how and when you use your car. To do this, they would place a diagnostic device in your car that transmits wireless data on how you drive (including how fast you're going and how hard you're braking), when you drive and how much you drive. Drivers are rewarded for safe driving, low mileage.

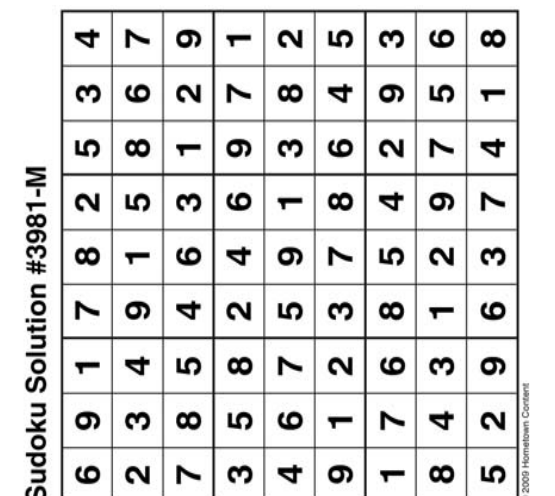
