# Key local offices up for election

## Polls open at 7 a.m. on Thursday, August 4

Some key Cannon County offices are up for grabs Thursday, August 4 in the county general election.

It will be a long day for election volunteers with the polls opening at 7 a.m. and closing at 7 p.m. A list of the polling places is included at the end of this article.

Only a few county offices are up for election in what is considered a federal and state primary.

The most contested race is for Assessor of Property. Four candidates are seeking this post, which is being vacated by Donald Preston. They include John U. Basinger, Anna Pittman,

Angie Schwartz and Michael R. Underhill.

Another contested office is School Board District one with newcomer Michael Keith Jones challenging incumbent Nathan Sanders.

Unchallenged for School Board seats are Bruce Daniel, District 3, Tim Powers, District 2, and Javin Fann,

District 4.

Three candidates are seeking Road Commissioner seats including James Hancock, Zone 3, Doyle Duke, Zone 2 and Terry Horn, Zone 1.

It is a primary race for two State and Federal posts.

In the Republican Primary, incumbent state Rep. Mark Pody is unopposed in the 40th District race. In the Democratic Primary, Amelia Morrison Hipps is

unopposed as well.

In the Republican Primary for the U.S. House of Representatives, incumbent Diane Black faces opposition from Joe Carr, Tommy Hay and Donald Strong. In the Democratic Primary, there are two candidates David Kent and Flo Matheson.

Remember, all voters must have a state or federally issued photo ID in order to vote.

Acceptable IDs include:

Tennessee Drivers License with a photo  
US Passport  
Dept of Safety Photo ID  
US Military ID  
Gun Permit  
Any State or Federally Issued Photo ID

Petitions for Mayor or Alderman of Woodbury and Auburntown are now available. The qualifying deadline will be noon on August 18. The election for these offices is November 8th.

## A town called Danville & Levi Woodbury

These first commissioners appointed by the state legislature also proposed a different name/or this new county seat -- now to be called Woodbury -- replacing the name Danville. The old town site would be increased in size to cover some 62 acres. Some refused to sell portions of their land to create a larger town. A town square was marked and identified, believed to have been about three acres.

Many local residents did indeed participate in this great event by selling, swapping and donating partials of land to increase the size of the town site. Some names as recorded by past historians were H. Y. Henderson, Nathan Neeley, Adam Elrod, Joseph Pinkerton, Henry Trott Jr., Abel McBroom, H.D. McBroom, William Young, Patsy Gannon, Mary Gan-

non and James Taylor. Commissioners also named additional streets for the town, two would be called Main and High streets. Numerous cross streets were designated also. Some of these cross streets were renamed in later years.

Again, according to the Woodbury historian Sterling Brown these first lots were only about four rods (poles) wide. It is interesting to note when the town of Bradyville was laid out along the upper Brawley Fork, its lots were also four poles wide.

Levi Woodbury, as far as anybody's knows, never visited this community that was named after him. In the whirlwinds of Tennessee's politics, the Jacksonian Democrats had recently lost the governor's race to the Whig party. As mentioned, this new county was even named after this Whig Governor, Newton See DANVILLE, Page 9

## Woman for all seasons

After a mostly sunny career with more than her share of stormy nights, WKRN-Channel 2 weather forecaster Lisa Patton is calling it a day.

Last week, the Mt. Juliet native took her final bow in front of the weather map after 25 years with the Nashville station. Her quarter-of-a-century tenure makes her the dean of Music City weatherwomen.

"I guess I've been forecasting weather on TV longer than any female in the Nashville market. It's not easy being a full-time working mom in an industry as visible as television news. It takes a toll. I have tried to give 110 percent to my family and 95 percent at work, but that means stretching myself pretty thin. Every working mom knows all about that," said Patton, the mother of three children: Madeline, 23, Brenna, 20, and Eli, 16.

It seems her decision to walk away from her position as one of Nashville's most beloved on-air

personalities came comfortably but with much thought.

"Live television and the news industry are demanding," she stated. "Certainly there are slow days when the weather is quiet, but we have more and more active weather days here in Middle Tennessee when you are always anticipating the

next storm or flood or winter event. And then there is the 'always on' feature of social media. Being a working mom is rewarding beyond measure, but while it has been my job to make it look easy, I admit to being a wee bit exhausted. I just decided I needed to make some time for me before I am too old to enjoy it.

"I want to clean up a lot of stacks at home. Maybe sleep through a thunderstorm and wear my pajamas when it snows, and I do hope it snows a lot this winter, and I do mean a lot," she said with a laugh. "I want to make some hot chocolate, watch the kids sled and just have fun." Patton, 54, began her See PATTON, Page 9

## TDCI: 'Unclaimed Funds' Letters Mailed From State Are Legitimate Division Offers Tips on How To Avoid Accumulating Unclaimed Property

NASHVILLE – The Tennessee Department of Commerce & Insurance's Division of Consumer Affairs wants consumers to be on the lookout for letters from the State of Tennessee indicating that they might have unclaimed funds. The State of Tennessee's Treasury Department, Division of Unclaimed Property, has recently sent a mass mailing of letters to consumers for which they have a record of unclaimed property.

What are unclaimed funds? Unclaimed funds are intangible assets held by financial institutions or companies that have had no activity or account holder contact for a year or more. This may include savings or checking accounts, refunds, customer overpayments, contents of safe deposit boxes, stock certificates, unclaimed wages, gift certificates, etc.

To determine if you have unclaimed property on file with the State of Tennessee, you can visit the Unclaimed Property Division's website at www.Treasury.TN.Gov/unclaim or call 615-741-6499. There is no fee to claim your property from the State of Tennessee.

To prevent accumulating unclaimed property:

- Deposit or cash all checks for dividends, wages, insurance settlements, etc. without delay.
- Respond to legitimate requests for confirmation of account balances and stock holder proxies.
- If you have a safe deposit box, record its number, bank name and address, and give the extra key to a trusted person.
- Prepare and file a will detailing the disposition of your assets.

# Fibbing always best part of going fishing

There's a new fishing pole on the market that can be connected to a mobile app and tell you when you get a bite.

It can also be programmed to land the fish, clean it, and take it back to the cabin, where it will fry it a skillet.

While the fish is cooking, the app will fetch you a beverage, scratch your skeeter bites and turn on the Sports Channel.

If you take it with you to lunch, it'll flirt with the waitress.

For a few bucks more it will fib to your buddies about how big the fish was.

I like that last part best. Fibbing has always been part of fishing.

The way I see it, we're doing our listeners a favor when we exaggerate a tad. Who wants to hear a boring story about how you reeled in a stunted 6-inch perch while standing on the dock in your Speedos?

But you'll have them on the edge of their seats when you relate your wilderness encounter with a fearsome razor-toothed Northern pike that would have easily weighed 20 pounds. If you had landed it, that is.

Unfortunately the fish -- which was probably closer to 30 pounds -- snagged the line on a submerged stump. When you swam out to free it, you found yourself trapped in the middle of a writhing throng of venomous water moccasins.

Gripping your fishing pole in your teeth while fending off the attacking reptiles, you managed to untangle the line. But just as you started to crank in the thrashing fish -- a solid 40-pounder -- bikini model Kate Upton roared past on a Ski Doo and accidentally snipped the line.

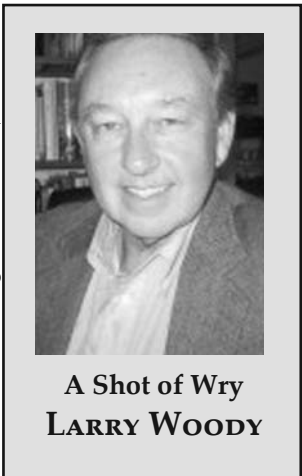
Kate was so distressed at having lost your 50-pound pike she insisted on treating you to dinner and inviting you over to her cabana for a

nightcap.

Now THAT'S how you tell a fish story.

In terms of fish size, it's important to understand the concept of "Anglers Math."

Eight inches equals a foot. Two

pounds equals four pounds. Add at least one pound per fish to allow for evaporation.

When using Anglers Math to count the number of fish caught, simply take the sum total and multiply by two. If, for example, a fisherman caught 15, that amounts to a total of 30.

To compensate for Global Warming and an erratic Dow Jones Average, a couple more fish should be added for good measure.

It's sort of like the Metric System, only easier to understand.

According to the

Angler's Code you

never question the size of another man's fish. If he holds up a guppy and claims it's a sailfish, you slap him on the back and say, "Way to go!"

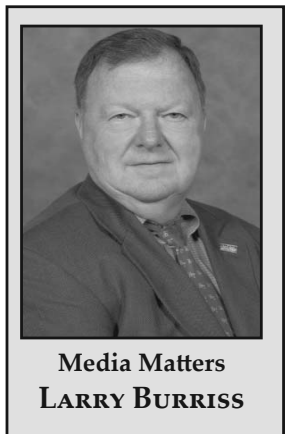
Each campaign playlist has to reflect both the candidate and the electorate. After all, music can bring back memories,

# Hot summer sun poses dangers to humans, pets

How are you enjoying all this hot weather?

I enjoy warm weather, but when it starts getting up near 100 its time for me to stay inside.

Why? A few years ago, I suffered a heat stroke and since then extremely hot temperatures really get to me. Before then, I could spend the day (after day) "piloting" a bush-hog equipped tractor all over the family farm. Hot weather just didn't bother me.

Was it really heat stroke? Maybe it was just what they call heat "exhaustion" these days. After all, I didn't pass out nor did I have to go to the hospital. But here are some of the symptoms:

- Extreme sweating.
- Rapid heartbeat
- Confusion
- Pale skin
- Dizziness
- Muscle cramps
- Bad headache

I didn't faint, but I almost did and it took a few days to get over my "exhaustion." And like I said, I am more easily impacted by heat now like when I am manning the grill outside on a hot summer day.

Eventually, I did learn how to avoid heat-related problems. (Air conditioning ... or head for the shade.)

A big, powerful fan on my patio helps too.

Drinking plenty of water is the best thing and is superior to soft drinks or tea. Unfortunately, drinks containing alcohol (that means ice-cold beer) doesn't help as much. That sort of beverage can actually make heat stroke or exhaustion worse.

The main strategy is to keep as cool as you can to begin with so you don't overheat. There's nothing wrong with ducking inside for a few minutes to cool off in the air conditioning.

And hot weather is the time to wear loose, light-colored baggy clothing. I prefer a baggy, all-cotton

T-shirt with my long (baggy) shorts. Yep, you will catch me dressed that way complete with sandals and a ball cap. No, its not pretty.

If that doesn't work, crank up the fan (if you've got one) and apply an icy wet towel. Get out of the sun!

If you are still overheating and can get inside, take a cool shower. The idea is to cool down as quickly as possible without having to call 911.

Another BIG worry this time of year are folks who leave children or pets inside a locked car or truck.

As for pets, leave them at home. That's more difficult to do with youngsters. Don't leave them in your car even for a second. If you have to dash inside (let's say) a convenience market for a second, DON'T leave them in the car. I know that's a hassle, but, like they say, it is better to be safe than sorry.

Thus far, this year, 23 youngsters have died this year because they were left in a car. In most cases, (54%), the child was "forgotten" by their caregiver. In other cases, the child was playing in an unattended vehicle. In 17 percent of the cases, the young victims were intentionally left in the car by an adult.

It's difficult to understand how a parent or other caretaker could forget to get a child out of the car, but it happens. The most recent case was in Dallas where parents left their child inside of their car parked outside of a church.

This horrible mistake shows why no one should take hot weather for granted.

## The Arts Center's White Oak Craft & Gift Shop features book by local author, Billy Plant

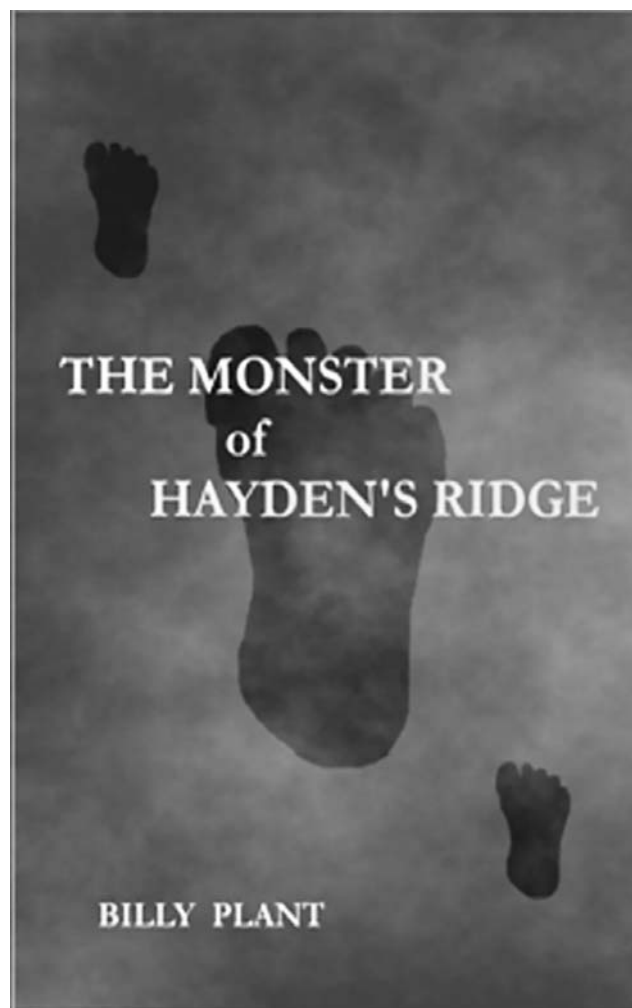

# Unclaimed funds letters are legit from state of TN

## Check website, submit a claim

NASHVILLE – The Tennessee Department of Commerce & Insurance's Division of Consumer Affairs wants consumers to be on the lookout for letters from the State of Tennessee indicating that they might have unclaimed funds.

The State of Tennessee's Treasury Department, Division of Unclaimed Property, has recently sent a mass mailing of letters to consumers for which they have a record of unclaimed property.

What are unclaimed funds? Unclaimed funds are intangible assets held by financial institutions or companies that have had no activity or account holder contact for a year or more. This may include savings or checking accounts, refunds, customer overpayments, contents of safe deposit boxes, stock certificates, unclaimed wages, gift certificates, etc.

To determine if you have unclaimed property on file with the

State of Tennessee, you can visit the Unclaimed Property Division's website at [www.TN.Gov/unclaim](http://www.TN.Gov/unclaim) or call 615-741-6499.

You can search for your name, and if property is found, you can quickly submit a claim for it. There is no fee to claim your property from the State of Tennessee.

To prevent accumulating unclaimed property:

- Deposit or cash all checks for dividends, wages, insurance settlements, etc. without delay.
- Respond to legitimate requests for confirmation of account balances and stock holder proxies.
- If you have a safe deposit box, record its number, bank name and address, and give the extra key to a trusted person.
- Prepare and file a will detailing the disposition of your assets.

# After-hours 'sting:' Deputy vs. Hillbilly

It comes as no divine revelation that operating a motor vehicle after consuming alcohol—commonly known as Driving under the Influence/DUI—is a serious offense, one that can result in a litany of charges: heavy fines & court costs, loss of driver's license, loss of vehicle, loss of job, jail/prison time served, etc. Worse yet, DUI-related vehicular accidents are responsible for irreparably crippling bodily injuries and deaths each year—not just in America but the world over.

In no way advocating "drinking & driving," the following story was handed down to me to be the truth. Though I can't verify this second-hand story to be the actual truth, I felt compelled to share the gist of it with my readers, simply because it is too good not to share.

*(NOTE: Regarding this story, the names of people, places, and locations are fictitious.)*

### SOMEWHERE IN RURAL TENNESSEE

The county deputy was a tall, burly, no-nonsense fellow named Jake Stuart: 35-years-old, 6 feet 2 inches tall, 240 pounds, and an ex-marine who sported a high-and-tight flattop haircut. It was 2:45 a.m. and the deputy had orders from the sheriff to stake out at closing time a local beer-bootleg joint called Honky-Tonk Babylon. As the name implied, Honky-Tonk Babylon was patronized by what were considered societal heathens: ex-cons, dope dealers, low-end hookers, and rough, uneducated hillbillies with quick tempers and even quicker hands with which to draw razor-sharp knives.

About 3:40 a.m. Roscoe opened the door, got into his truck, and started the engine. Though it was a dry summer night, Roscoe turned on the windshield wipers, hit the blinkers, honked the horn, and turned on the headlights. He moved the vehicle forward about ten feet, then put it in reverse and backed up to his original parking spot, patrons leaving the whole time. Finally, when his was the only vehicle left in the parking lot, he pulled out and drove slowly down the road, at about 25 mph.

Having waited patiently all this time, and having observed the obvious, Deputy Stuart's eyes lit up and he thought to himself: "I've got his drunk, hillbilly ass this time!" Deputy Stuart started up his patrol car, hit his beacon lights, tuned on his siren, and pulled over Roscoe a quarter-of-a-mile down the highway. At Deputy Stuart's request Roscoe obligingly exited the Dodge Ram.

Though Deputy Stuart could smell no alcohol on Roscoe, he administered a breathalyzer test. However, the breathalyzer results indicated Roscoe had not consumed any alcohol, whatsoever. 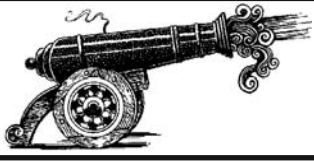

# Resolution of Constipation in Children Following Chiropractic Care

Published in the September 26, 2015, issue of the Journal of Pediatric, Maternal & Family Health is a case series study documenting the resolution of severe constipation in two small children. In both of these cases, the children's conditions were serious enough to have a negative effect on their daily lives.

The study begins by noting that functional constipation accounts for approximately 3% of visits to medical pediatric clinics. In about 40% of these cases, the parents of the children seek some form of alternative care due to the lack of results their child received under medical care.

In the first case, a 3-year-old girl was brought to the chiropractor by her mother. She had been suffering with constipation and had only had one or two bowel movements per week for the last two weeks. Her mother reported that the girl would say she needed to go to the bathroom, but was unable to and was in significant pain. The girl's diet contained lots of vegetables, raw fruit, and plenty of water.

In the second case, a 3-year-old boy was brought to the chiropractor by his mother with chronic constipation since birth. The mother noticed that her son

was "miserable" since the age of 6 weeks. His constipation was so severe that his mother would have to use a rectal thermometer to stimulate bowel movements. The boy's pediatrician provided no real explanation for the child's constipation and no treatment options were offered.

Both the children received chiropractic examinations consisting of various physical and functional analyses. Both children were determined to have subluxations that were affecting nerve system function. Based upon the findings and histories, the children began chiropractic adjustments for corrections of their subluxations.

In the case of the young girl, she experienced regular bowel movements by the fifth chiropractic visit, and did not have a repeat of the constipation problem thereafter. Her mother elected to have her daughter continue chiropractic care on a wellness care basis.

The young boy showed some improvement in the first few visits, though progress was slower but steady. By the 11th chiropractic visit, the boy's rate of bowel movements had dramatically improved. After 6 weeks of chiropractic care and 13 visits, the mother reported that her son was having normal daily bowel movements. The child was placed on wellness care thereafter.

In their conclusion the authors wrote, "This case series provides supporting evidence on the effectiveness of chiropractic care in children with constipation."

spell at WKRN as the week-end weather forecaster and three-day-a-week news reporter in July 1991 after receiving a phone call from then-news director Bill Lord, who told her, "I've got a place for you." She responded, "OK, I'm ready."

Looking back, she says she most will miss the camaraderie with her colleagues and longtime friends "like Davis [Nolan] and Anne [Holt] and Bob [Mueller] and so many behind the scenes: Jody [Shoulders], Noel [Edwards], Ken [Wilson], Michael [Dennis], Joe [Gregory], Clare [Gibson]. I will miss seeing them on a daily basis. And I'll really miss the interaction with the viewers, but I'm sure I'll still catch up with them at church and the grocery and the Wilson County Fair."

Although she was born in Coos Bay, Ore., where her father was stationed in the Air Force, her roots go deep in the southeastern section of Wilson County. Her dad's side of the family comes from Watertown and her mother's side hails from Statesville.

"I spent lot of time there, not just visiting but working. I grew up part of a farming family. I did a lot of working, cutting, raking and baling hay. My father grew tobacco, and I would pull slips out of the beds and plant them. I was one of the fastest planters of tobacco and tomato slips. I kind of grew up with my feet in the dirt," said Patton, who at 12 could drive a tractor like a pro.

After graduating from Mt. Juliet High School, she enrolled at the University of Tennessee.

"I really thought when I was in college that I was interested in being a sportscaster," she recalled. "The television industry is very competitive to get into. The weather door opened, so I went in. I just had a niche for it. It's kind of like working a puzzle every day, a challenge. It's

fun. Weather was the right fit . . . and I seem to have the gift of gab, and since weathercasting is unscripted, that helps."

It was just as she was completing her communications degree in 1984 that Knoxville TV station WTVK called and offered her a job.

"They told me, 'We have this weekend weather spot and would like for you to come audition for it.' . . . I told them, 'I don't know anything about weather.' They said, 'OK, we'll teach you.' I began learning weather forecasting on the job. Back then there were not as many meteorologists for news directors to choose from, so to rip and read was fairly common," she said, referring to the practice of reading the local forecast as it came off the wires from the National Weather Service.

"Fortunately, mets like my dear friend, Davis Nolan, have taught me so much. I have been building my own forecasts now for 20-plus years. And, gosh, sometimes I still don't get it right."

With four years at Knoxville radio and TV behind her belt, Patton landed another four-year gig at WTVD in Raleigh-Durham, N.C., as a weekend weather

anchor and news reporter. There she met husband-to-be, Eric, a director at the TV station, and after a three-year courtship, they married and moved to Middle Tennessee where they started their family on Wilson County's west side, and Patton began winning the loyalty of her viewers.

During her tenure at WKRN, Patton won Emmy Awards for tornado coverage in 2006 and 2008 and was named best TV weather anchor in 2013 by the Tennessee Associated Press.

Along the sunny, stormy, rainy, icy, sweltering, freezing and sometimes partly cloudy way, she reminisces on a few of her most unforgettable weather events.

"Most memorable was the tornado of April 16, 1998. Stormtracker was fairly new then. We could see the debris flying around on our City Cam. I realized then what an awesome responsibility it was to try and keep folks safe during threatening times. I would say the floods of 2010 were the most emotional event for me," said Patton. "It was overwhelming to see so many neighbors devastated by the rising water.

"And one of the most challenging days was when we hit our all-time record high of 109 degrees on June 29, 2012. At about 10 minutes 'til four, I had the weather graphics done when suddenly every computer system in the station shut down except the weather computers. So we went on-air with our newscasts with nothing but weather. I talked about that 109 degrees for about an hour and a half. There was no video for news stories. We finally got some reporters to do live shots about the heat, but that was a real song and dance."

As for her career highlight, she thinks back to a 1992 tour of the Navy aircraft carrier USS John F. Kennedy.

"It was amazing to see how dangerous the work is

on an aircraft carrier," she said. "I felt a little guilty because most of those sailors never got to experience what I did. We flew in and did a tailhook landing and then experienced a catapult launch. That was pretty exciting stuff. As a matter of fact, I thought I was in heaven for a few seconds. I guess we experienced zero gravity for just a moment after take-off, and I just couldn't feel anything. Video journalist Rich Stone assured me we were still very much alive."

So what is next for the budding lady of leisure?

"I want to organize my life. It got a little disheveled over the years. I want to relax a little, have a bit more laidback lifestyle for a while. I want to maybe grow roses again or herbs. Just get my hands back in the dirt again. I'm actually quite domestic—I like to cook, sew, craft, garden, even clean.

"While I do plan to rest and relax around enjoying some of my favorite hobbies, I'm a doer, so I imagine I will get my finger into some pot or two or three or 10."

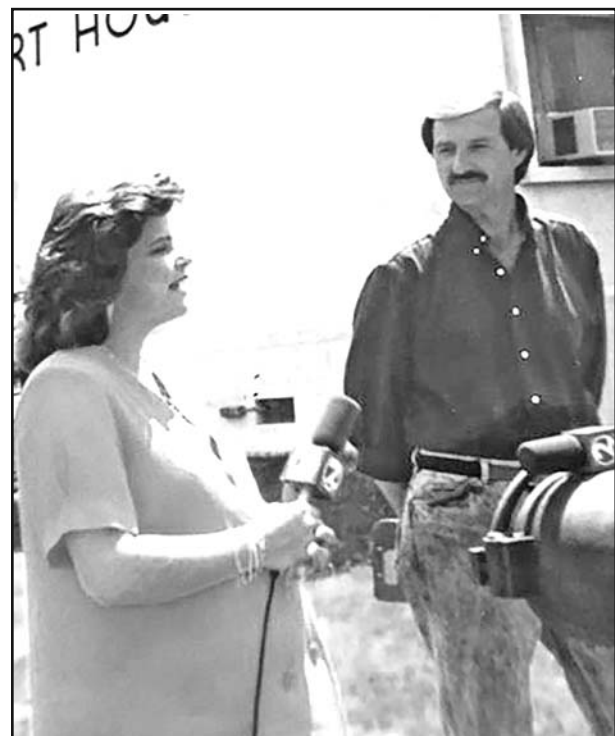
While she has given up on a few things that were on her bucket list, like watching a space shuttle launch, she clings to one. "I'd really like to see the Northern Lights," she confessed.

Asked what she enjoyed most about talking about the weather, she shared, "Just helping people out with their daily lives. Many people consider me family because I'm in their living room every day. A lot of people have sent emails, cards and Facebook posts saying they were gonna miss me. I'm gonna miss them, too."

So might she consider coming back to weather forecasting somewhere down the road?

These first commissioners were quick to move on a motion to select the town of Danville as the new county seat and also to rename the town. It may have been an effort to gain something of a foothold against the Whigs in this somewhat unusual 1836 election?

Levi was a close friend and ally of Tennessee's famous president, Andrew Jackson more popularly known as 'Old Hickory.' Levi Woodbury, served in Jackson's so-called cabinet as secretary of the Treasury. He was actually from the state of New Hampshire. Jackson recognized early-on Levi's unique abilities as an effective administrator and organizer. He certainly had an eye for the detail. Levi Woodbury was considered twice as a possible presidential candidate - in 1836 and again in 1852. In an effort to give him some name recognition for a possible presidential run the Jacksonian Democrats may very well have been behind

the move to name towns after him. However, Levi Woodbury's politics were not strong enough to beat out the Van Buren faction of the Democratic party. Martin Van Buren became the Democratic candidate for president and won the national election of 1836.

By 1852 Levi Woodbury's name came up again as the best choice to beat the Whigs. Unfortunately Levi's presidential ambitions came to an end when he took sick and died. The Democratic party's search for a candidate led them to what some would call in those days a 'dark horse' candidate at the time of their convention - someone totally unknown - Franklin Pierce. Pierce was also born in New Hampshire. Pierce was nominated after the delegates attending an unruly convention cast ballots 35 times in order to secure a nomination. Franklin D. Pierce won the 1852 national election over the more popularly known Whig candidate, General Winfield Scott. (The end.)

**Camp Read to be Ready made books come to life for students**

Camp Read to be Ready provides students with a total reading experience where books take life in relation to our community. Students are given the opportunity to read, think, talk, and write about various texts in relation to our focus of learning. The second session of Camp Read to be Ready allows students to experience Camp Reading River. Twenty five students have spent their fourth and final week of camp as freshwater explorers. Students are learning about and discussing animals, insects, and plants in freshwater habitats. We have dug deep into the following books: One Small Square: Pond written by Donald Silver, Float written by Daniel Miyares, Gruffalo written by Julia Donaldson, A Freshwater Pond written by Adam Hibbert, and Memoirs of a Goldfish written by Devin Scillian.

The ultimate goal for Camp Read to be Ready is to make books come to life for our students. Co-directors Melisha Simmons and MaryBeth Young as well as Troop Leaders Kathy Gannon, Emily Hughes, Beth Mathis and Joy Pope are working toward this goal by creating movements, songs, and art that relate to our books. Troop leaders have created experiences where campers experimented with other objects that sink and float. Campers have created their own boats and examined the properties required for an object to float. Campers also compared water from a mud puddle, a bird bath, a freshwater pond, and the Stones River. Campers examined these waters using magnifying glasses and microscopes comparing clarity, plant life, insects, and organisms.

During our final week of Camp Read to be Ready, Bonnie Irvin from Project Wet led our campers on a trip to The Stones River. Campers entered the river behind the Arts Center of Cannon County. Ms. Bonnie supplied our campers with magnifying glasses, nets, and collection trays. Campers were able to see three different species of crayfish along with numerous fish and plants. Campers were able to see how The Stones River supports the water supply for Cannon County. This was an excellent firsthand experience with resources in Cannon County for campers to see the importance of taking care of our water for plants, animals, and even our own water supply.

To culminate the Camp Reading River experience, campers traveled to Huff & Puff Trucking in Bradyville, TN. Campers began their visit by finally meeting Mike and Dianna Watson, the Huff & Puff drivers who opened their truck up to Flat Stanley so that he could travel their delivery routes. Campers were so excited to finally meet these local celebrities along with Flat Stanley! Every day campers were able to video conference with Flat Stanley and his drivers using Skype. We have tracked Flat Stanley's adventures across North America. Campers were given the opportunity to explore the actual Huff & Puff truck that transported Flat Stanley and tour the Dispatch area. 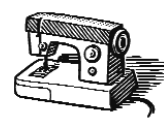

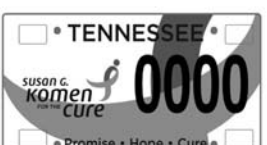

## Crossing the Jordan River

After wandering in the desert 40 years, the Israelites finally approached the boundary of the Promised Land near Shittim. Their great leader Moses had died, and God had transferred power to Moses' successor, Joshua.

Before invading the hostile land of Canaan, Joshua had sent in two spies to scout the enemy. Their story is told in the account of Rahab, the prostitute.

Joshua ordered the people to consecrate themselves by washing themselves, their clothes, and refraining from sex. The next day, he assembled them a half mile behind the ark of the covenant. He told the Levite priests to carry the ark to the Jordan River, which was swollen and treacherous, overflowing its banks with snowmelt from Mount Hermon.

As soon as the priests waded in with the ark, the water stopped flowing and piled in a heap, 20 miles north near the village of Adam. It was also cut off to the south.

While the priests waited with the ark in the middle of the river, the entire nation crossed over on dry ground.

The Lord commanded Joshua to have 12 men, one from each of the 12 tribes, pick up a stone from the center of the riverbed. About 40,000 men from the tribes of Reuben, Gad, and the half-tribe of Manasseh had crossed over first, armed and ready for battle.

Once everyone had crossed, the priests with the ark came out of the riverbed. As soon as they were safe on dry land, the waters of the Jordan rushed in.

The people camped that night at Gilgal, about two miles away from Jericho. Joshua took the 12 stones they had brought and stacked them into a memorial. He told the nation it was a sign to all the nations of the earth that the Lord God had parted the waters of the Jordan, just as he had parted the Red Sea in Egypt.

Then the Lord commanded Joshua to circumcise all the men, which he did, since they had not been circumcised during the desert wanderings. After that, the Israelites celebrated Passover, and the manna that had fed them for 40 years stopped. They ate the produce of the land of Canaan.

The conquest of the land was about to begin. The angel who commanded God's army appeared to Joshua and told him how to win the battle of Jericho.

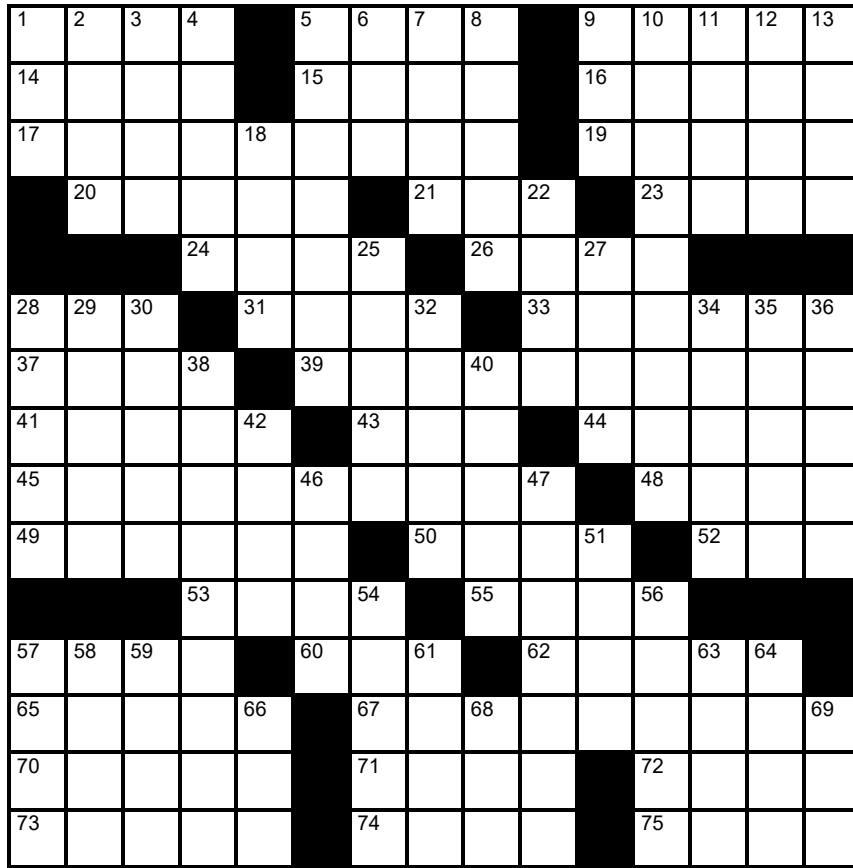

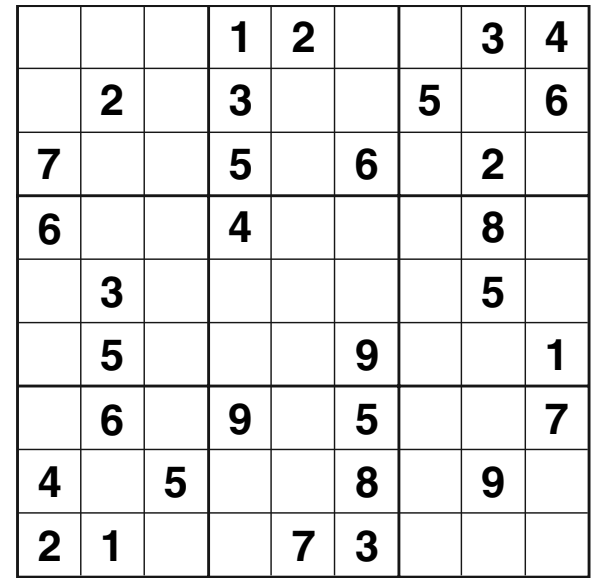

## Savvy Senior

### 10 Ways Seniors Can Avoid Identity Theft

Dear Savvy Senior,

What can seniors do to protect themselves from identity theft? My brother-in-law, who's 77, recently had his identity stolen and I want to make sure it doesn't happen to me.

Worried Relative

Dear Worried,

Great question! Each year around 17 million people fall victim to identity theft, which happens when someone gets access to your Social Security number, bank or credit card account number, or other identifying information and uses it to steal from you. Here are some free steps you can take to reduce your risks.

**Guard your personal information:** Never give your Social Security number, credit card number, checking or savings account numbers to anyone unless you initiate the contact. Also, do not carry your Social Security card around in your wallet or purse, and don't carry around your Medicare card either unless you're going to the doctor.

**Get off mailing lists:** Put a stop to preapproved credit-card offers, which is a gold mine for ID thieves. To do this visit [optoutprescreen.com](http://optoutprescreen.com) or call 888-567-8688 - they will ask for your Social Security number and date of birth. You can stop other junk mail at [dmachoice.org](http://dmachoice.org), and reduce telemarketing calls at [donotcall.gov](http://donotcall.gov).

**Use strong passwords:** To safeguard your personal data on your smartphone or tablet don't use a password that's easy to hack, like 1234 or 0000. Also, make your computer passwords more than 8 characters long, with uppercase and lowercase letters, numbers, and symbols like # and %, and use different passwords on different accounts. If it's hard to remember them, try a password manager service like [dashlane.com](http://dashlane.com), [truekey.com](http://truekey.com) or [lastpass.com](http://lastpass.com).

**Be wary of unknown emails:** Never click on links in emails from strangers, or those that claim to be from the Social Security Administration, IRS or other government agencies, or from your bank, phone or credit card company warning of a "problem." This can result in identity-stealing malware being installed on your computer. To protect your computer from malware, install antivirus software (see [avg.com](http://avg.com) and [avast.com](http://avast.com) for free options) and set up automatic security updates and full weekly scans.

**Secure your mail:** Empty your home mailbox quickly or buy a locked mailbox to deter thieves. And mail outgoing payments from a U.S. Postal Service mailbox or the post office, not from your more vulnerable home mailbox.

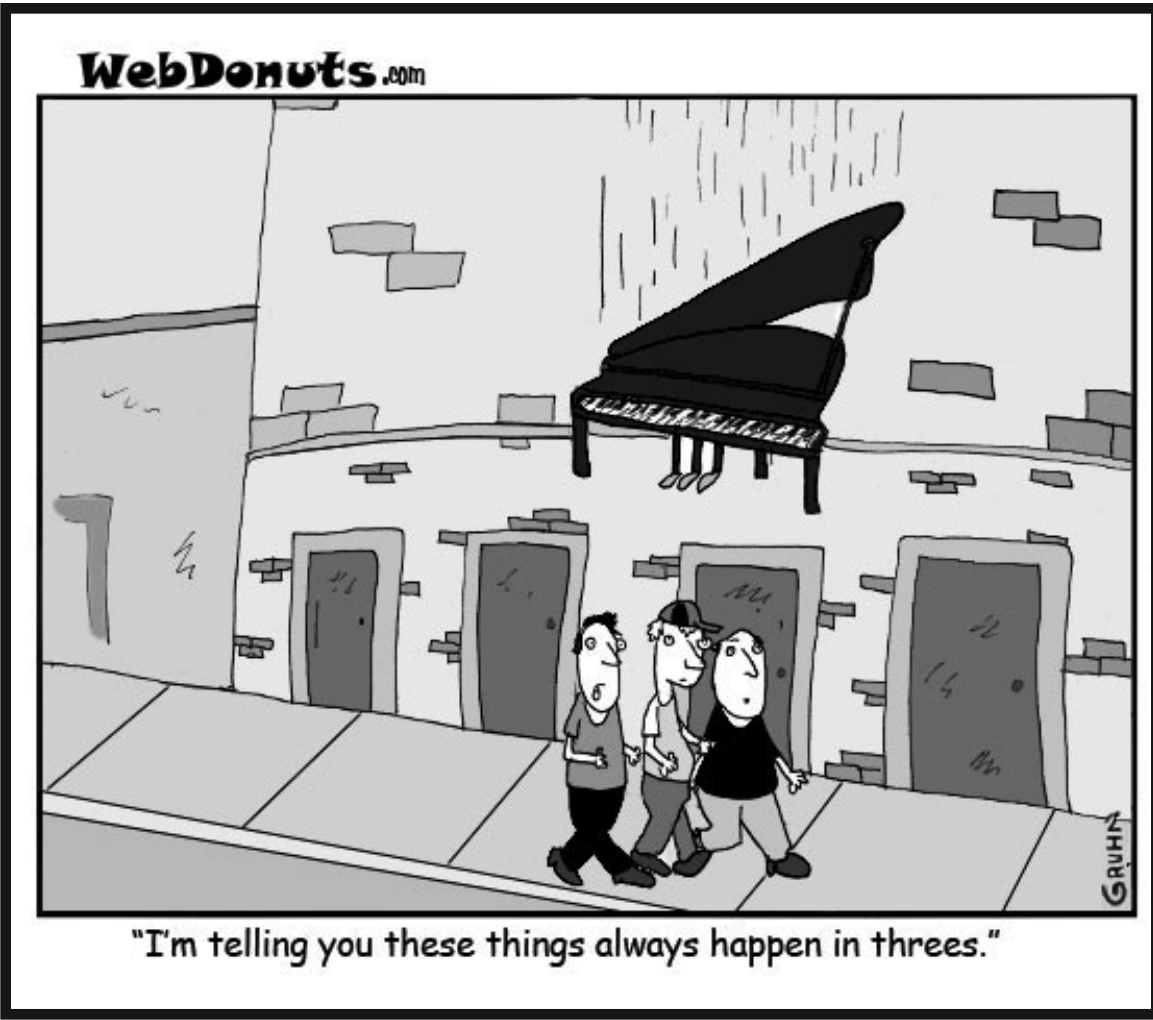
**Get safer credit cards:** If you don't already have one, get an EMV chip credit card from your credit card provider. They're much more difficult for fraudsters to hack than magnetic strip cards.

**Shred unneeded documents:** Buy a crosscut paper shredder so you can shred all unneeded records, receipts, statements, preapproved credit offers or other papers you throw out that has your financial or personal information.

**Monitor your accounts:** Review your monthly bank and credit card statements carefully, and see if your bank or credit card issuer offers free alerts that will warn you of suspicious activity as soon as it's detected. If they do, sign up for them or use [eversafe.com](http://eversafe.com), which will do it for you for a small fee.

**Watch your credit:** Check your credit report at [annualcreditreport.com](http://annualcreditreport.com) or call 877-322-8228. You can receive one free report a year from each of the three major credit bureaus (Equifax, Experian and TransUnion), so consider staggering your request so you can get one free copy every four months.

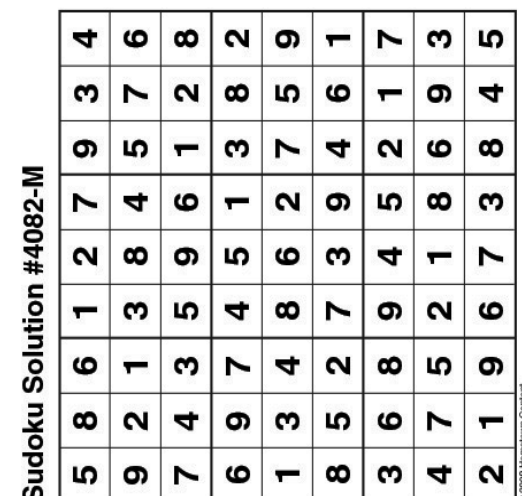
