Vote early to avoid long election lines

Early voting for the March 1 presidential preference primary, or "SEC Primary," is now underway.

Registered voters can cast their ballots early at the Cannon County Election Office at 301 West Main St., Suite #244 through February 23rd except Sundays. Hours are: 8 a.m. to 1 p.m. Monday, Wednesday and Fridays, 4 p.m. to 7 p.m. Tuesday and Thursday and from 10 a.m. to 1 p.m. on Saturdays.

Besides the presidential race, Cannon County voters also have two tax issues before them. First is a sales tax referendum which, if passed, will increase the Cannon County sales tax from 1.75 cents to 2.75 cents. The second referendum would increase the county's wheel tax from \$50 to \$70 with the increased proceeds going to the county's general fund.

Voting early during this election cycle could be an important option because of unpredictable winter weather. The number of presidential candidates as well as the number of delegates also adds to the length of the ballot.

Six Southern states will join Tennessee to help decide who could be the next president of the United States. The Volunteer State's clout could mean more primary See VOTE, Page 9

Whistle Blower Ben Taylor holds the rich and powerful accountable . . . on the basketball court

When you look at it one way, Ben Taylor ('09) may have a dream job. After all, he gets to be on television 80 or more times each year, and world-famous millionaires are obliged to follow his decisions. He might even be on posters hanging in your child's bedroom.

On the other hand, should Taylor make a decision that appears errant, 20,000 people might very well let him hear about it instantly, not to mention half of the millionaires in the room.

None of this is surprising given that Taylor, 30, is in his third full season as a referee in the National Basketball Association (NBA)-one of only 63 people in the world with the skill and credentials required to hold that job.

A Basketball Bloodline

Taylor played varsity basketball at Cannon County High School, located 20 miles due east of Murfreesboro and the campus of MTSU. He wasn't too bad, either. The letterman, who comes from a long familial line of ballplayers who distinguished themselves on a basketball court, started his junior and senior years. "We've always loved basketball in my family," Taylor said. He's not kidding-his maternal grandmother, Helen Davenport, held the all-time scoring record at Cannon County High School and was inducted into the nascent Cannon County Sports Hall of Fame in 2013. His older cousin, Julie Powell, is a shoo-in for induction as well. Before she helped the Vanderbilt Commodores win the SEC Championship in 1993 and advance to the Final Four of the NCAA Women's Tournament, she broke Davenport's record to be-

come Cannon County High School's alltime leading scorer. His father, Teddy Taylor, is in there, too. Teddy's induction is born from his work as a youth coach and as a contributor to the **BEN TAYLOR** high school team.

particular that was blown nearly 11 years ago.

"I was a real hothead when I played high-school sports," Taylor admitted. "We were playing at Smith County, and I hit a threepoint shot to tie it and send it to overtime. A teammate set a screen and an opponent tripped me-and I was called for my fifth foul. I still remember the guy's name who called it."

It's good that he remembers the play, because he later found a valuable life lesson embedded in the frustration of being forced unfairly from the game.

"We as referees need to see the first action so that we penalize that instead of penalizing the second action," he said. "And that's something I remember when I'm on an NBA court."

Given his high school experience, perhaps it's no wonder he initially declined when then-Riverdale High School girls' basketball Coach Corv Barrett invited him to officiate children's games. Then he thought through the economics involved.

"When I found out (officiating youth games) paid \$20 per game, I was sold," Taylor said. "I thought to myself, 'That's way better than working for the local Piggly Wiggly for \$5.25 an hour.' Within the first two weeks, I fell in love with it."

But long before he would realize a career as an official in the NBA, he wanted a college degree. So, he enrolled at MTSU, where he ultimately earned a bachelor of arts in public relations. He also attended as many "ref camps" as he could during the summers between semesters.

This year marks the 20th anni-versary of "Toy Story," a film that brings a charming group of toys and dolls to life.

One might say Marilyn Bloodworth does the same.

"I start them from scratch ... I have my own templates, and I cut them out and stuff them and sew them," Bloodworth says from her home-based doll studio in Woodbury. "I make them come alive."

Though her dolls don't get up and move like in the movie (as far as we

know), they do come to life through their unique clothing and faces.

Bloodworth works with a man in Murfreesboro who makes the unique faces for the dolls, which are printed onto cloth heads and then sent to her.

"You can look at this one, and she speaks," says Bloodworth, pointing to one of her dolls. "She's speaking to the generations and saying 'I'm here, and I'm alive."

MTSU's Forrest Hall task force will host an off-campus open forum later this month to get more feedback about whether to change the name of the building that houses the university's ROTC program.

Task force chairman Derek Frisby, who heads the 17-member panel of students, faculty, alumni and community members, said the second public forum will be from 6:30 to 8:30 p.m. Wednesday, Feb. 24, at the Lane Agri-Park, 315 John R. Rice Blvd. in Murfreesboro. Frisby, a Civil

War historian and faculty member in the Global

Cultural Studies and department, Geography said it was important for the task force to host an off-campus forum to get feedback from the wider community. The first forum was held Dec. 1 at the university's Student Union Building.

university The announced in June 2015 that it would engage the community on the name of the campus building that houses MTSU's Army Reserve Officer Training Corps program and is named after Confederate Gen. Nathan Bedford Forrest.

MTSU President Sidney A. McPhee asked

the panel to recommend by April whether the building should be renamed; retain the name but with added historical perspective; or recommend that no action or change is warranted. The Tennessee Board of Regents would have to approve any recommended name change and the university is also researching whether other state authorities would have to give approval as well.

Voters urged to vote no on sales, wheel tax

To the Editor:

I am writing this in response to comments made concerning the Sales Tax increase and Wheel Tax increase that citizens of Cannon County will be voting on during the early voting period or on March 1st, 2016.

To be honest and blunt, I am adamantly opposed to both increases and I encourage the citizens to VOTE NO and here is why.

It was been reported that the Commissioners have stated they will rescind the 15 cent property tax increase levied on the citizens in August 2015. This letter's intent is to ask you the citizen if you sincerely believe that will really happen? I was at the meeting when this was discussed. I heard what was said and it was stated that it "could" be reduced. At no time did they state that it "would" be reduced. There was no vote or a resolution passed to that effect. There is no guarantee.

Cannon County has been forced by the State of Tennessee Comptroller's Office to create a separate account for the current Wheel Tax monies because it has been determined that the money intended for the school debt has been used as the "primary revenue source for the County General Fund." In other words, the Wheel denied Cannon County government from borrowing any further money until it can show an increase in revenue to the General Fund. In other words, we can't borrow money until we have more money coming in.

The idea that the County Commissioners will reduce our property taxes by 15 cents if we vote to increase the Sales Tax or increase the Wheel Tax is simply not logical. In order to borrow money we must first show an increase in our revenue. How can we show an increase in revenue if the Commissioners reduce the property taxes by 15 cents? Are we to believe that we are increasing on one end and decreasing on the other and still raising revenue? Do you really believe that? When is the last time you know of any government body removing a tax?

I encourage you to read the resolution concerning both tax increases. I hope you notice as I do that all money will be placed in the County General Fund and there will be no additional services provided. I hope you will notice that there is no end date to either resolution. Both taxes will be law forever with no recourse to remove them if they pass.

If ever you're in Philadelphia, Miss., be certain to find Peggy's Restaurant, not only famous for cast-iron skillet fried chicken, but where they also have a unique "money basket" in the middle of the dining area where chicken eaters pay and make change on the honor system.

That's where Frances Williams graciously stood on Peggy's front porch for a full 20-minute interview with this unknown newspaperman from Middle Tennessee. Tour guide Rachel then motored us to Williams Store that goes back in the Williams' family through the Great Depression.

It's a country store known throughout Mississippi, having merchandise ranging from mule collars to designer label women's apparel and shoes, from thick store-sliced bacon to big round hoops of cheese.

Why is the Williams Store so popular?

"It goes back to the Great Depression, when times were hard, and the Williams' family granted credit to help feed hungry Neshoba County families," confirmed Murfreesboro resident Rick Hodgins, who grew up in Philadelphia. "Mississippi folks don't forget stuff like that."

Tourists are advised to shop at Williams Store well before 10 a.m., in order to beat the daily long line of customers at the cash registers.

That's where Pat and I met store man Sid Williams, an uncle to Eli and Peyton Manning.

"The New York Giants' would have been well-advised to talk to me, before giving Eli all that money," Uncle Sid accounted to us with a smile. "Each summer, Peyton and Eli worked here at the family store for minimum wages."

Last year the County Commission voted to allow an increase in property, sales and wheel taxes to fund county services. At the same time, they cut spending 2.75 percent to address the budget shortfalls. This balanced approach is the best course of action.

The sales tax does not apply to rent, electricity, gasoline, prescription drugs, food stamps, WIC and other items. To suggest that making Cannon County sales tax rate equal to Rutherford, Coffee, DeKalb and Warren counties would place an undue burden on the poor is false. The wheel tax applies to citizens who do not own property, but drive. It is an insult to the seven members of the budget committee, who met 16 times over a period of months, to suggest that the budget was not scrutinized carefully. The citizens who attended those meetings know that the budget was examined line by line.

Usually the GOP is in favor of broadening the tax base so that everyone has a share in funding our local government services. Concerning an actual sticker to prove payment of the wheel tax, I plan to bring this idea before the commission to consider again. I urge voters to search out the facts and vote for the wheel tax and sales tax.

Was it Hitler or FDR who really snubbed Jesse Owens?

Black History Month Jesse Owens: A real story about 'Race'

How many high school-level and college-level track & field athletes and coaches are familiar with the name Jesse Owens?

The youngest of ten children, Jesse Owens was born September 12, 1913, in Oakville, Alabama, to parents Henry and Emma Owens. Realizing poor blacks had a better chance at a better life in northern states than in the segregated South, the Owens family moved to Cleveland, Ohio, in the early 1920s, a period of time some historians refer to as the "Great Migration": more than one million blacks leaving the South and moving to the North. In Cleveland, Jesse Owens attended Fairmount Junior High School, where his coach, Charles Riley, white, saw tremendous potential in the black teenager and encouraged him to pursue his dreams of becoming a track & field star. Since Jesse had to work a job after school hours to help support his large, impoverished family, Coach Riley worked with young Jesse in the early mornings before the first school bell rang. And the effort paid off! Having already set world records at the junior high and high school levels, Jesse entered Ohio State University on a track & field scholarship in 1933, where he quickly earned the nickname "Buckeye Bullet." In the span of a mere 45 minutes, on May 25, 1935, during the Big Ten Meet at Ferry Field in Ann Arbor, Michigan, Jesse Owens, running and jumping for the Ohio State University Buckeyes, accomplished what many track & field historians call the "most impressive athletic achievement" in track & field history: tying one world record while setting three world records. None other than "Sports Illustrated" magazine termed Owens' accomplishments that May 25, 1935 day as the "Greatest 45 minutes ever in sports." Here's a timeline as reported by "Sports Illustrated." *3:15 pm. Owens won the 100-yard dash in a time of 9.4 seconds, tying the world record. (NOTE: Owens had previously tied the world record in the 100-yard dash with a 9.4 run in 1933!) *3:25 p.m. Owens won the long jump (also called the "broad jump") with a leap of 26 feet 8 1/4 inches, improving the world record by more than a half-foot, a world record that stood for 25 years. *3:34 p.m. Owens won the 220yard dash, running it in a blistering 20.3 seconds, breaking the old world record of 20.6 seconds.

hurdler, Owens won the 220-yard low hurdles in a time of 22.6 seconds, the first hurdler, ever, to break the 23-second mark in the event.

Across the Atlantic Ocean in Europe's Germany, Adolph Hitler was head of state, head of government, head of the armed forces-Fuhrer supreme-his Third Reich regime firmly in place, fueled by the Nazi doctrine that the Aryan/ Caucasian race was the supreme race, and other races, such as Jews and blacks, should be exterminated. Further, Hitler had the monstrous notion of conquering and ruling the world! However, Berlin, Germany was host to the 1936 Olympic Games, which took place the first two weeks of August. At those 1936 Olympics, Jesse Owens gave Fuhrer Adolph Hitler an attitude adjustment in racial superiority by winning gold medals in four events: (1) 100-meter sprint. (2) 200-meter sprint. (3) 400-meter relay. (4) Long jump. (NOTE: Though all track & field events are "metric" these daysand have been for some time-the traditional measuring system of "feet and inches" was still in use decades ago.) Regarding the 1936 Olympic Games, controversy continues to swirl. Some argue Hitler "snubbed" Jesse Owens by leaving the stadium in a fit of anger, refusing to shake the hand of a black man who had dominated his Aryan-German athletes. Others claim, though, Hitler did shake hands with Owens before departing the stadium, and the media chose not to disclose such to the public, in an effort to keep Hitler as the "monster." Ironically, Jesse Owens has been quoted as saying it was then-U.S. President Franklin Delano Roosevelt-not Hitler-who "snubbed" Owens by not inviting Owens to the White House to congratulate him on his Olympic victories. Reportedly, only white athletes were invited. A film titled "Race," a biopic drama about Jesse Owens, is set for release in American theaters on February 19, 2016. I find the title creatively appropriate because as Jesse Owens did race down numerous tracks to victory, he, in the process, helped his own "race" clear a high hurdle in terms of social acceptance. As testimony to his legacy, the "Jesse Owens Award," presented annually, is the highest honor that can be given in American track & field.

NIH Report Says Spinal Manipulation Unlikely to Cause Stroke

The National Institutes Health (NIH) of has issued a report stating that chiropractic care is unlikely to cause stroke as some opponents of chiropractic care have asserted. The NIH report further noted, "This is the first population-based study in the United States to examine the risk of stroke after spinal manipulation and the first such study on older adults." Researchers reviewed 1.1 million Medicare claims from 2006 through 2008. Cases included in the data were all Medicare patients ages 66 to 99 who had a diagnosis of neck pain and who had visited either a chiropractor or a medical doctor for that condition. had tried to suggest was associated with chiropractic adjustments, is extremely rare. one of the driving forces that allowed me to do this job, because she never questioned what I wanted to do. That's not to say that Taylor has never let emotion affect his officiating.

"I called a foul on Dwyane Wade my rookie season, and LeBron came over and wanted to talk about it," Taylor explained. "Dwyane wanted to talk about it, too, and the coach wanted to talk about it-all at the same time.

Generally, if you're not involved in the play, we're not going to talk to you about it. And if you were involved in the play, it's going to be a one-on-one conversation. And if you try to gang up on the ref, the conversation is not going to happen. In this case, I got mad. I apologized later in the game, and LeBron had the greatest response: 'Don't worry about itemotion is part of the game.' "

It could be argued that good referees really don't get noticed much, as they make all the right calls and don't play a primary role in determining the outcomes of games. Bloodworth's relationship with dolls began nearly 25 years ago when she worked at Children's Palace, a toy store in Virginia Beach, Virginia. She worked her way up to department manager before an epiphany led her in a different direction.

"I think I was inventorying the dolls, and I noticed that there weren't that many dolls for bi-racial kids or Indian kids or black kids," says Bloodworth. "I mentioned it to my manager at the time, and he said, 'Well, you might wanna think about filling in the gap."

She did just that. Bloodworth signed up for a doll-making class that would change her life forever.

"When I took this doll class, I made my first porcelain doll," says Bloodworth. "I said, 'This is beautiful,' and I was hooked."

Though her materials have varied from porcelain to liquid paper mache to the cloth she currently uses, Bloodworth's mission has always remained the same.

"I always try to inspire," she says. "Most of my dolls have inspirational messages that are going to encourage and inspire and

uplift."

The same cards that list the dolls' personalities also have an inspirational message for whomever buys them.

Bloodworth's desire to inspire her customers and those around her undoubtedly stems from her rough childhood.

"I saw my mom get killed at the age of 6," says Bloodworth. "It devastated my life at a very young age."

She and her brother grew up in Harlem, New York, an area that was riddled with violence and drugs. She didn't have dolls as a kid because her main focus was simply surviving. Luckily, she would find

inspiration in her stepmother

"She took a look at me, and she kinda let me know that 'Hey, you gonna be OK. You're in a safe place," says Bloodworth. "She helped me realize I had dreams and goals and passions and things that I could do, and that I could be creative."

If one word could describe Marilyn Bloodworth, it's creative.

Her dolls aren't run-ofthe-mill children's toys; each is a work of art and represents different parts of society.

"I try to make my dolls so unique and so different that it accommodates those that want that type

of doll," says Bloodworth. "You've got to be able to meet the needs of all people."

She does just that. Her inventory, which sits on a table in her small workshop, currently includes a bi-racial doll, a pregnant doll, a Jewish doll and roughly 40 more dolls.

Even though she has endured some hard times, Bloodworth says there's not much she would change.

"My life helped me," she says. "I took something from nothing and made something of value, and people appreciate what I have."

A letter to Cannon County parents concerning TNReady tests

Wednesday, Feb. 10, 2016 Parents and families,

Let me start by saying thank you. You have been tremendous partners with your child's teachers and principals over the past several years as we have raised standards and transitioned to a new, aligned assessment in math and English language arts: TNReady. All of us are truly grateful for your support. I also want to tell you directly that I am sorry for the frustrations the recent test changes have caused for you, your child, and his or her teacher and school leaders. Like many of you, I am disappointed we are unable to provide your student with an online version of TNReady this year, especially after a year of planning and hard work. Let me be clear: this is in no way your school district, school, or teacher's fault. We take full responsibility at the state department of education for the inability to test online this year, and we are working on a number of short-term and long-term solutions.

The investments your school and district have made in technology are absolutely critical if we want our schools to be 21st century learning environments. We don't believe students should learn how to use technology just to take a test, but we believe technology integration is part of the modern day teaching and learning cycle. Technology investments have helped personalize learning well beyond assessments and have given students opportunities to interact with content in more individualized and engaging environments.

students for the modern-day demands of our colleges and employers and equipping our education system to provide more real-time feedback to students, parents, and educators about where they are on that journey. This year will be the next step in an ongoing transition to ultimately make sure

Given all the effort and anticipation of this new online test, it was a difficult decision to delay the transition to statewide online testing, but the needs of students and teachers came first. We know they deserve a reliable, consistent experience every time they log in.

It's important to remember that TNReady on paper is still TNReady. Your child will still have an opportunity to show what they know this year in greater depth than they have in the past - and you will still get better information about where they are in their growth toward postsecondary and workforce readiness.

Over the past few months, the department and districts worked together to strengthen our technology infrastructure and prep systems and devices across the state, and we were prepared for everything we could control. But on Monday, a new issue we had not experienced before caused a network outage at the test vendor's site that interrupted testing for some students. This was unexpected and disappointing. Ultimately, this operational and network failure combined with the additional issues we had been mending almost daily over the past months caused us to lose confidence in our test vendor's ability to provide your child with an online platform that could perform reliably and consistently during testing.

We decided we could not risk having students and educators spend additional time on a platform that showed inconsistent performance, so we paused testing on Monday morning and asked districts to go back to regular classroom activities. Later that day, in order to protect our students' instructional time and better ensure they have a positive test experience, we decided to move all students to a paper-and-pencil version of TNReady for the rest of this school year. This change applies to both Part I and Part II of TNReady, as well as social studies.

Your district leaders, principal, and classroom teachers have worked tremendously hard over the last several months to prepare both your student and the technology to be ready, and that is work we know will still pay off. The questions your student practiced on a computer are the same types of questions they will see on the paper version of TNReady, and those questions will ask your child to use critical thinking and problemsolving abilities. In addition, developing keyboarding and typing skills are both part of our state's digital literacy expectations (which apply to grades K-12) and match the real-world demands we are preparing our children to meet.

So, all of this hard work to improve technology infrastructure and device access will still benefit students' learning.

I also want to reiterate that I believe a test is just one measure of a student's learning and growth. Student understanding of the content should be measured in multiple ways, and one of those pieces of feedback is a state-level perspective to see how students are learning compared to their peers in other districts. We are concerned about test anxiety and overtesting, so we have taken initial steps to address this, including eliminating some tests and considering future changes to the structure of TNReady. In response to recommendations from our assessment task force, we are working with our schools and districts to ensure that testing is streamlined and meaningful and that adults are conscious of ways in which they can help alleviate test anxiety.

In addition, as we move through a transition to a different test, last spring Gov. Haslam and the General Assembly worked together to lower the effect of TNReady on teacher evaluation scores and provide districts with complete flexibility about how or if they consider evaluation in any personnel decisions. Finally, we have proposed a test transparency bill to the state legislature this spring that will allow us to release the majority of assessment questions and answers to parents, students and teachers to help for future preparation. We are continuing this conversation with many of our parents, educators, and students - we know it is important.

For now, we are working with our test provider to produce and ship paper copies of TNReady to each district, at no additional cost to taxpayers or the department. The paper version of the test includes questions that were developed and approved by Tennessee educators, just like the online version. We will provide more information to your school districts later this week on a new Part I testing window, which will begin no earlier than Feb. 22, and your school district will tell you more specific testing dates as those are scheduled. While this is not what we had anticipated, we hope your student's transition to a more familiar testing environment this year is as smooth as possible. We will be providing more information to your school district in the coming days, particularly on accommodations for students with disabilities and English learners.

The transition to TNReady is here - even though it will be taken on paper. The new test this year will assess readiness on the standards we have in the state with new types of test items aligned to full depth and breadth of our standards.

In the long term, we are committed to using computers for online testing - and we are committed to regaining your trust. This transition has been challenging, but we still believe that by working together, we can strengthen what is happening in each of our classrooms.

The work that has gone into this transition supports goals that we believe are the right ones: preparing our we do this right. Thank you again for your partnership and support of our schools.

Jesus Christ and his disciples stopped at the house of Martha in Bethany, about two miles from Jerusalem. Her sister Mary lived there, along with their brother Lazarus, whom Jesus had raised from the dead.

Mary sat at Jesus' feet and listened to his words. Martha, meanwhile, was distracted with preparing and serving the meal for the group.

Frustrated, Martha scolded Jesus, asking him whether he cared that her sister had left her to fix the meal alone. She told Jesus to order Mary to help her with the preparations.

"Martha, Martha," the Lord answered, "you are worried and upset about many things, but few things are needed-or indeed only one.

Mary has chosen what is better, and it will not be taken away from her." (Luke 10:41-42, NIV)

Points of Interest from the Story:

For centuries people in the church have puzzled over the Martha and Mary story, knowing that someone has to do the work. The point of this passage, however, is making Jesus and his word our first priority. Today we come to know Jesus through prayer, church attendance, and Bible study. If all 12 apostles and some of the women who supported Jesus' ministry were with him, fixing the meal would have been a major job. Martha, like many hostesses, became anxious over impressing her guests.

Martha has been compared to the Apostle Peter: practical, impulsive, and short-tempered to the point of rebuking the Lord himself. Mary is more like the Apostle John: reflective, loving, and calm.

M'boro man charged with odometer fraud

NASHVILLE-Tennessee Highway Patrol (THP) has arrested Michael Marks of Murfreesboro on charges of odometer fraud and criminal simulation.

On December 10, 2015, the THP's Criminal Investigation Division received two complaints from victims regarding possible odometer fraud and approved an investigation. It was noted at that time the same person had sold the vehicles to the different victims. The victims stated they had purchased the vehicles from an ad on Craigslist.

The investigation revealed the odometers in the two vehicles had been

The rolled back. Investigators were able to identify a suspect, and the identity was confirmed by a victim. The THP's Criminal investigation Division sought and obtained two felony warrants for criminal simulation as well as two misdemeanor warrants for odometer fraud against Marks.

On January 28, 2016, members of the Tennessee Highway Patrol Criminal Investigation Division with support from troopers from the Nashville District executed the arrest warrants for Marks. Prior to the execution of arrest warrants, Marks was observed driving a

blue, Toyota Camry. The blue Toyota pulled into the driveway of 5530 North West Broad Street in Murfreesboro that was identified as his place of residence and business. Criminal simulation is a class E felony, and odometer fraud is a class A misdemeanor.

The THP CID is asking anyone who has conducted business with Michael Marks or anyone who may be associated with him who believes he/she is a victim of odometer fraud to contact the Tennessee Highway Patrol Criminal Investigation Division at 615-251-5185.

How to Calculate Your Retirement Number Dear Savvy Senior,

Can you help me calculate about how much my wife and I need to save for retirement? We are both in out late-fifties and want to see where we stand.

Looking Ahead

Dear Looking,

Calculating an approximate number of how much you'll need to save for a comfortable retirement is actually pretty easy, and doesn't take long to do. It's a simple, three-step process that includes estimating your future living expenses, tallying up your retirement income and calculating the difference. There are even a host of online calculators that can help you with this too.

Living Expenses

The first step is the most difficult - estimating your living expenses when you retire. If you want a quick ballpark estimate, figure around 75 to 85 percent of your current gross income. That's what most people find they need to maintain their current lifestyle in retirement.

If you want a more precise estimate, track your current living expenses on a worksheet and deduct any costs you expect to go away or decline when you retire, and add whatever new ones you anticipate.

Costs you can scratch off your list include work-related expenses like commuting or lunches out, as well as the amount you're socking away for retirement. You may also be able to deduct your mortgage if you expect to have it paid off by retirement, and your kid's college expenses. Your income taxes should also be less.

On the other hand, some costs will probably go up when you retire, like health care, and depending on your interests you may spend a lot more on travel, golf or other hobbies. And, if you're going to be retired for 20 or 30 years you also need to factor in the occasional big budget items like a new roof, furnace or car. Tally Income

Step two is to calculate your retirement income. If you and/or your wife contribute to Social Security, go to ssa.gov/myaccount to get your personalized statement that estimates what your retirement benefits will be at age 62, full retirement age and when you turn 70.

In addition to Social Security, if you or your wife has a traditional pension plan from an employer, find out from the plan administrator how much you are likely to get when you retire. And, figure in any other income from other sources you expect to have, such as rental properties, part-time work, etc.

Calculate the Difference The final step is to do the calculations. Subtract your annual

living expenses from your annual retirement income. If your income alone can cover your bills, you're all set. If not, you'll need to tap your savings, including your 401(k) plans, IRAs, or other investments to make up the difference.

So, let's say for example you need around \$55,000 a year to meet your living expenses and pay taxes, and you and your wife expect to receive \$30,000 a year from Social Security and other income. That leaves a \$25,000 shortfall that you'll need to pull from your nest egg each year (\$55,000 – \$30,000 = \$25,000).

Then, depending on what age you want to retire, you need to multiply your shortfall by at least 25 if you want to retire at 60, 20 to retire at 65, and 17 to retire at 70 – or in this case that would equate to \$625,000, \$500,000 and \$425,000, respectively.

Why 25, 20 and 17? Because that would allow you to pull 4 percent a year from your savings, which is a safe withdrawal strategy that in most cases will let your money last as long as you do.
