## Have you voted yet?

Early voting ends as campaign winds up

When you cast your ballot on Nov. 6 there are a few things to keep in mind besides remembering to bring a photo ID.

Polls are open from 7 a.m. to 7 p.m. Tuesday. Early voting ends Thursday, Nov. 1.

"Based on past elections, we are expecting a big turnout," said Dorinda Mankin, administrator of elections.

In addition to the Tennessee General Election, voters in Woodbury and Auburntown can cast ballots in municipal elections in addition to a Cannon County Sales Tax Referendum.

Grabbing the headlines is the race for President featuring Republican nominees Mitt Romney and Paul Ryan vs. Democrats Barack Obama and Joe Biden.

But Obama and Romney aren't the only presidential candidates. The Constitution Party and the Green Party are represented along with three independent candidates. Of, if you choose, voters can write-in a candidate for president.

In the U.S. Senate race incumbent Sen. Bob Corker faces opposition from

Democrat Mark E. Clayton as well as a number of lesser known office seekers.

For U.S. Congress Diane Black, a Republican doesn't face a Democratic challenger, but she is opposed by a Green Party and one independent candidate.

Rep. Mark A. Pody, a Republican, is unopposed in the Tennessee House of Representatives 46th District.

All Cannon County registered voters can vote "yes" or "no" in the sales tax referendum which proposes increasing the local sales tax from 1.75 percent to 2.75 percent.

In Woodbury, a liquor referendum is on the ballot. This measure, if approved, would allow package stores to sell alcoholic beverages in town. Voters can vote for or against liquor stores.

Mayor Harold Patrick is unopposed for mayor of Woodbury. Voters can also vote for six out of seven candidates for alderman. These candidates include incumbents JoAnn Davis, Dotty Duggin, Charlie Harrell, Faye N. Knox, Lois W. Larimer and Adam Melton. Chuck Holt is the newcomer seeking a seat on the board.

Is God a hit in country music popularity ratings?

Thanks to the international Gospel to Go's Nashville-based ministry, the answer is yes, according to a unique Christian evangelist with an unusual name who does a lot of his witnessing out of the glow of Music City USA's bright lights.

Tennessee native Bill Wolfenbarger's online Gospel to Go CD/tape ministry is not only impacting performers and back stage industry people throughout Nashville's music realm, it has exploded globally.

How special is Gospel to Go?

This ministry does not seek, nor will it accept donations, making it more than merely unique.

"Our messages are free to listen to online, download, and we encourage people to make copies and give them away," Wolfenbarger said. "Since we started the

website four short years ago, we've had more than 90,000 hits from 80 different nations, including Russia and China. We've never accepted a donation."

Few media evangelists have ever stipulated no donations.

Admittedly, Wolfenbarger is among the more unusual behind-the-scenes' people who comprise Nashville's country music family leading into the new century.

"Bill is one of those special people always asking what he can do for

others," verified Hilda Stuart, mother to performing legend Marty Stuart. "That's not always the case in the music business, or any other profession. His Gospel to Go ministry is very fruitful, and extremely well done."

"I love that Wolfenbarger, and admire him so much," pictured legendary Music City scene photographer (Les Leverett. "After I'd listened to several of his Gospel to Go CDs, I told him that he was one of the best preachers I've ever heard. He immediately denied being one, but I countered by saying: 'Anybody who proclaims the Gospel of Jesus Christ the way you do, is a preacher.' And I still believe that. There's no telling this side of heaven how much good he has done with those CDs. I pray that his ministry will go on for years to come."

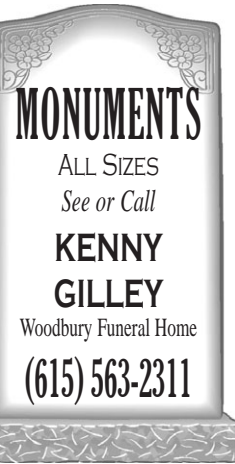

## In My Opinion

### Cannon's school needs not now being met

Some Cannon County citizens already have taken advantage of early voting and made their decisions regarding a referendum for a 1 percent increase in the local sales tax on the ballot for the Nov. 6 general election.

For those who haven't and either will vote early in the next few days or go to the polls Nov. 6, I urge you to vote yes for the 1 percent increase. Ours is an anti-tax society. No one wants to see their taxes raised and most will not voluntarily vote to raise them; however, this decision transcends our personal desires.

This referendum has a tremendous impact on schools as 50 percent of the 1 percent increase will go to fund education and necessary resources and programs within Cannon County's School System, which includes Cannon County High School, six grammar schools and an alternative school program serving students in seventh through 12th grades.

The budget for the Cannon County Schools System was cut this year, which is unacceptable. There is more pressure on students, teachers and administrators than ever before to meet the rising academic challenges placed on them.

Demand for production is great and the need to support new measures to improve student outcomes is even greater; however, funding for schools in Cannon County - and across the state for that matter - is not being met.

One of the most logical ways to address this overwhelming concern is to vote yes for the 1 percent increase. A yes vote is a vote for our children. No one likes to think about raising taxes but this is one increase that will produce great benefits for children and adults in Cannon County.

We must support proactive measures that will ensure that children in our community are prepared for a lifetime of achievement, and start school ready and eager to learn.

While 50 percent of this 1 percent increase will be earmarked for schools, the remaining half will go toward city and county government. No one likes increased taxes but this is a fairer tax than a property tax increase. Not everyone owns property, but everyone purchases goods, necessities and other items, thus everyone pays sales tax.

No one is thrilled about the idea of paying more taxes, but if the money is earmarked for children - our future - then everyone should be in favor. If the only way we can get what we need for the schools is to vote for a 1 percent increase, then I am in favor because I support education and our youth. The goal should be for every child in our county to have the best shot at the best education they can achieve. We must show our children that as a community we value them and we value their education.

Since children cannot vote it is our responsibility to advocate on their behalf. Public schools must be improved and we must understand that students must have the learning tools and community resources needed to be successful. Local academic achievement rates are demanding our immediate attention.

Despite limited funding and a depleted budget, Cannon County Director of Schools Barbara Parker and the seven principals within the System are to be commended for the level of academic

excellence achieved; however, it is not enough. More funding would mean improved programs.

More funding would mean additional programs that can be offered to enhance the quality of education.

Getting by simply is not good enough for Cannon County's youth, who are our leaders of tomorrow. They deserve more. Cannon County's principals, teachers and students are to be applauded for the high level of success they achieve on state, regional and national levels. East Side School recently was recognized as one of Tennessee's "Award Schools" for academic achievement in 2011-12. Various clubs and organizations compete at the top level, but this is not because Cannon County has the resources necessary. It is because of the additional time, effort and funding provided by students, teachers and families responsible for the respective clubs or organizations.

The 1 percent tax sales tax increase would lift Cannon County's tax rate to 2.75 percent, which is equal to that of Bedford, Coffee, DeKalb, Rutherford and Warren Counties - all of which surround Cannon County. The current sales tax rate in Cannon County is a woeful 1.75 percent. Of the 95 counties in Tennessee only Johnson County is lower at 1.5 percent.

Opponents of the referendum to raise the sale tax argue it hurts the poorest citizens of our county because it affects every day goods. Less than 17 percent of the citizens in Cannon County are 65 or older.

An additional 21.6 percent of Cannon County's population is young people ages 18-under. That leaves more than 60 percent of Cannon Countians who are between the ages of 19-and-64 and likely travel outside of the county to work. They are also likely to travel outside the county to eat and shop.

Point is each time a person leaves Cannon County to eat or shop, he is paying the same tax rate being asked with this current referendum. Chances are they are also buying gas or other "goods." Those additional dollars are funding other counties and assisting to improve their schools, neighborhoods and communities.

Meanwhile, back in Woodbury and surrounding areas, the sales tax is amongst the lowest in the state. People passing through or are here for sporting events, car shows, Good 'Ole Days or any other function, only pay 1.75 percent sales tax. They are getting a break while our kids are getting the shaft. It is amazing that people would be willing to pay more elsewhere and not at home.

Cannon County citizens probably have done more to help fund schools in Rutherford County than they have the seven existing ones here.

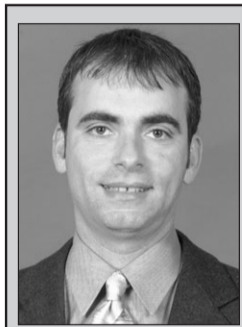
If you care about our future then say yes to education.

### Let's pay ourselves what we pay others

Have you ever stopped to think that every time you make a purchase in a county adjacent to ours that you leave behind 3 cents on every dollar to their education system?

Cannon County is adjacent to Murfreesboro, Manchester, McMinnville, and Smithville. All have a 2.75% sales tax rate, and a Wal-Mart. Practically all of us do a lot of our shopping in these areas and leave that tax money behind to fund their educational system to benefit their children.

Our tax rate is 1.75%. Do you believe it is appropriate to support other counties more than we are willing to fund ourselves? The reality is that most citizens of those counties don't travel back into our county to shop, so we pay them, but they don't pay us. It's not rocket science to believe that we should contribute to our education system and programs equal to what

we contribute to our neighbors.

Landowners should also consider what a vote for or against a sales tax means for them. A sales tax will help alleviate the need to ask for more property tax which has been the means of increased revenue in the last few years. Voting against the sales tax or not voting at all is essentially a vote for additional property tax increases.

Teachers should consider the fact that this year, the school's budget had to be cut to help fund the county's budget. Part of the sales tax is earmarked specifically for schools.

The myth that sales tax unjustly affects lower income people has been argued for years. My first thought is that rent is not affected; neither is electricity, natural gas, vehicle gas, purchases made with food stamps or WIC, medical services and many of the things that low income people

purchase. Most tax professors don't support the argument that citizens with low income are adversely affected by a sales tax increase.

Other things that won't be affected include: diesel, doctor's visits, hospital stays, medications, medical equipment, farm equipment/expenses and supplies, land, and the sales tax on automobiles will only increase by \$16.00.

In closing, it just makes sense to pay ourselves what we pay our neighbors. Our commission has given us the opportunity to do this on the November 6 ballot. Let's vote to support ourselves as much as we support our surrounding counties. If you have further questions regarding sales tax, I am usually at home.

# Blue Light shines on diabetes dangers

Pretty Blue World... This month, local monuments, buildings and homes will be bathed in blue light to highlight diabetes and raise awareness of its dangers. November is Diabetes Awareness Month, and our pretty, blue world will be just a little brighter blue because of it. Monuments all around the world will glow sky blue to emphasize the global impact that diabetes has; driving home the message that we all live beneath the same blue sky, and diabetes touches all of us in some way. November 14 is World Diabetes Day raises, instituted to raise global awareness of diabetes - its escalating rates around the world and how to prevent the illness in most cases. Started by the International Diabetes Federation (IDF) and World Health Organization (WHO), the Day is celebrated on 14 November to mark the birthday of Frederick Banting who, along with Charles Best, was

instrumental in the discovery of insulin in 1922, a life-saving treatment for diabetes patients. WHO estimates that more than 346 million people worldwide have diabetes. This number is likely to more than double by 2030 without intervention. Almost 80% of diabetes deaths occur in low- and middle-income countries. In the United States, 25.8 million children and adults in the United States-8.3% of the population-have diabetes. Of that number it is estimated that more than 7 million of them are currently undiagnosed. It is also estimated that in the U.S. there are 79 million people who are pre-diabetic. Diabetes is a chronic disease that arises when the pancreas does not produce enough insulin, or when the body cannot effectively use the insulin it produces. Insulin is a hormone made by the pancreas that enables cells to take in glucose from the blood and use it for energy. Failure to produce insulin, or of insulin to act properly, or both, leads to raised glucose (sugar) levels in the blood (hyperglycaemia). This is associated with long-term damage to the body and failure of various organs

and tissues. Among a myriad of dangers, diabetes is the leading cause of new cases of blindness among adults aged 20-74 years in the U.S. That makes it one of the chief targets for the Lions Clubs world-wide, who answered Helen Keller's plea and have been "...Knights of the Blind, in this crusade against darkness" since she asked them to do so at the 1925 International Convention in Cedar Point, Ohio. So please look around you this November, see if you can spot all of the buildings drawing attention to this disease and the impact it is having. Keep looking in this media all month, as it has joined the fight and will run many informative articles about diabetes. Watch and listen for other sources of information. Change out your own floodlights or front porch bulbs this month, and add your building to the cause with blue light bulbs that can be found in most stores these days, even compact fluorescent. Please wear sky blue to show your support and help us in the fight against diabetes. I have a daughter that is depending on us; and if you check, odds are good that someone very close to you is depending on us, too.

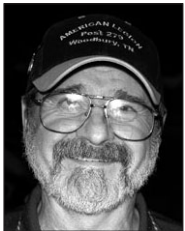

# HONORING OUR VETERANS

### Martin Tocholke U.S. Navy



This Veterans Day we are honoring Martin Tocholke (toe hoe kay) as the Marshall representing the U.S. Navy.

Martin was born in Germany on January 11, 1943. He and his family immigrated to the United States in 1952. They arrived at Ellis Island on March 24, 1952 and then they were moved to Hinkley, Minnesota, where they farmed.

After leaving Hinkley High School, like so many young men of that era, he joined the military service. "I joined the Navy and was sent to the US Naval Training Center in San Diego, California in April 1961," says Martin. After basic he was sent to the USS Yellowstone Ad-27 a Destroyer Tender. This was temporary duty until they assigned him to the USS Bigelow DD-942. The Bigelow was the Flagship of Destroyer Squadron Sixteen of the 6th Fleet. Martin was assigned to the forward boiler-room. This is where Martin learned his trade for his job that he holds at the Alvin C. York VA Hospital.

Martin was proud to be where history was being made. His first assignment was on standby to recover the space capsule with Gus Grissom on the Mercury Project. The next time was January 1962 when they were on standby for the Gemini Project. After they finished those assignments they got underway for a tour in the Mediterranean Sea. "We visited 17 ports in 10 countries on 3 continents traveling in the Black Sea, Red Sea, Indian Ocean, the Mediterranean Sea and the Persian Gulf. We traversed the straights of Messina, Bonifacia, Dardanelles, Bosphorus and the Suez Canal" remembered Martin.

Another part of history came about when Martin's was deployed to Cuba in October 1962 to chase Russian Submarines and blocked Russian Freighters from going to Cuba. "After two months we came back to our home port of Mayport, Florida. "In early 1963 while on a refresher training they were deployed to Haiti during the Haitian uprising. On August 6, 1963 we were once again deployed to the Mediterranean." Martin said that they had

visited 11 ports in 11 countries including Beirut, Kuwait, Bahrain, and Gibraltar. They came to Mayport in December in time for Christmas.

Martin certainly saw a lot of the world; he even got to see his home country of Germany, Sweden and then the Netherlands. In August of 1964 they were sent to Mayport, then Jacksonville Shipyards for repairs. After being repaired they went to the Caribbean Sea for a Shakedown Cruise and gunnery practice. On April 2nd he was released from active service.

Martin returned to Minnesota where he went to school for Low and High Pressure Steam Engineering. "I passed my test for the Minnesota Chief "A" Boiler License. I worked at various steam plants and hospitals until I moved to Tennessee in 1988."

Martin built his house in the Readyville area and was hired on by the Alvin C. York Veterans in Murfreesboro. "I married my lovely wife Ronji in the Philippines and we are presently working at the VA. Ronji is in H&R and I am in the Steam Plant," beams Martin.

Martin urges everyone to share in the Veterans Day Celebration, and to remember our sons and daughters who are serving our nation in all parts of the world.

### William M. Spradley U.S. Air Force (ret)



William M. Spradley age 76 graduated from Central High School in Murfreesboro. He married Lillian T. Harrell and has been married to her for 55 years. Together they have three children, Robin, William Kelly and Theresa. They have nine grandchildren and 11 great grandchildren. His parents are the late Monroe and Lucimae Spradley.

William served in the Army National Guard for 2 years from 1953 to 1955; he then transferred over to the US Air Force for 20 years from 1955 to 1975. He served overseas in Japan, Germany, Vietnam and Greenland (where it is never green). He

served in different states Wyoming, Texas, Massachusetts, New Hampshire, Michigan and Florida.

William retired a Tech Sergeant and was awarded lots of medals including; Bronze Star Medal with 4 Oak Leaf Cluster, Republic of Vietnam Campaign Medal Bar in 1969, and the Air Force Presidential Unit Citation with 3 Oak Leaf Cluster. He also won the Army Good Conduct with three bar knotted, Air Force Commendation medal, the Outstanding Unit award, the Air Force Good Conduct Medal with 2 Oak Leaf Cluster. 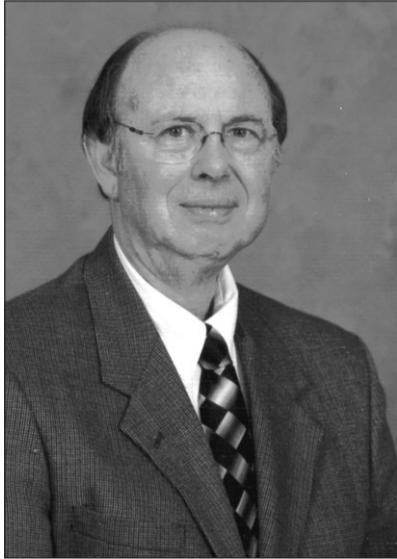

there ... a man, a woman and a cluster of little kids. The light down in that deep hollow was dim and it was almost like the early evening. Twilight it seemed, but my watch told me it was only 3 p.m. The children, the oldest couldn't have been more than 8 years old, seemed to be playing. They grabbed each other's hand and began to dance in a circle almost like the old "ring around rosy" game. They appeared to be singing as

they merrily danced, but we could hear no words. Maybe we weren't close enough? Quietly, we inched closer and it almost seemed that we could hear words "they all fall down" whispering in our ears as the children seemed to laugh and tumble on the ground. Suddenly, the "father" of the little group ran forward swinging his arms. He seemed to cover his ears with his hands and his face was contorted with a grimace. We couldn't hear

him, but those pale kids could. They stood up and started running away. My eyes were straining, but it seemed the father had a big butcher knife in his hand. His wife ran toward him, her arms raised in surrender, but he slashed at her, again and again. She fell to the ground as the children ran in obvious fear. But it was still unearthly quiet. It seemed that time was almost standing still as I watched the horrific scene unfold

before my very eyes as the man chased the children with that bloody knife. One, after another, they fell and almost seemed to disappear. Then suddenly, the last child ran toward us. Were we to be next? I stood there, frozen in fear. The child...I could see the horror in his eyes...ran right toward me and then suddenly through me. He was a specter...a ghost...and so was his father who dissipated yards away. I could feel myself screaming as my

wife shook me ... awake. It was all a horrible dream. A smile wreathed her face as her laughter broke the doom. "You having a nightmare?" she asked. "I, uh, ah...it must have been. You're not going to believe this one," I told her. "Spare me the details. Let's find out where this trail ends," she grinned. Eventually we did. All I know is that we ended up in Smithville as the sun was setting. I slept like a baby that night, forgetting about my

horrible dream. Time passed and I found myself at work, looking up something in an old volume of the Cannon Courier for a customer. There on page one of the old, dusty bound volume was the story "Man murders wife and children in berserk attack." And yes, the story recounted what I had witnessed in that deserted hollow. The only thing left to say is "trick or treat."

industry down-and-out songs show-cased getting drunk and falling off the bar stools, such as at Tootsie's Lounge of the 1930s, 1940s and 1950s when the female owner used a hairpin to keep house control of those often-rowdy country crooners. "It Wasn't God Who Made Honky Tonk Angels," is a typical song of that era that launched Kitty Wells' Country Music career in the early 1950s.

However, research shows most performers in the Country Music Family have roots in church music of their youth, and Wolfenbarger agrees.

"It is a family, but admittedly, there are stars who uplift themselves as self-made super stars not interested in reaching out in the name of Christ, and helping others within the industry," the Music City minister with an unusual name and uplifting soul-searching mission confirmed. "But then, there are super stars and legends such as Connie Smith who regularly showcase Christ and the importance of our Savior not only in the here-and-now, but in the heavenly for-ever-more. They know from where their gifts of heavenly-sounding music originate."

"Most of the truly great artists know their music-making talent is God-given," Wolfenbarger accounts. "And most performers (including Elvis Presley, Ricky Skaggs, the Whites, Marty Stuart, and John and June Carter Cash) have childhood roots in country churches."

Wolfenbarger is among the legions of impactful players comprising the behind-the-scenes' Country Music Family, but you won't often read the his name in bright stardom lights of musical Tennessee Tinseltown USA. Like many country music players, past and present, Wolfenbarger's childhood was not easy. Although born on the perimeter of the bright lights of Music City, the 56-year-old Wolfenbarger was homeless as a 7-year-old

boy, along with three younger brothers. "However, I can't remember not having faith in God," notes Wolfenbarger. "Through that faith, even as a child with difficult times in life, I knew there was a victorious light at the end of the ordeal." "God has always provided 'a way' when there seemed 'no way,'" Wolfenbarger testifies. "One day as I was driving down the road, I wondered why my childhood was rough, when I always tried to have faith and do what I should, and the Holy Spirit revealed to me in the voice of my mind and heart: I was forging the metal."

"I was so humbled by that answer about my difficult childhood, it has enabled me to help other people who face similar adversities in life. Thanks to God, I was doing it before I realized I was doing it. I can relate to hurting people and also show them with faith and Jesus in their lives, they too can become victorious and overcome the obstacles of life."

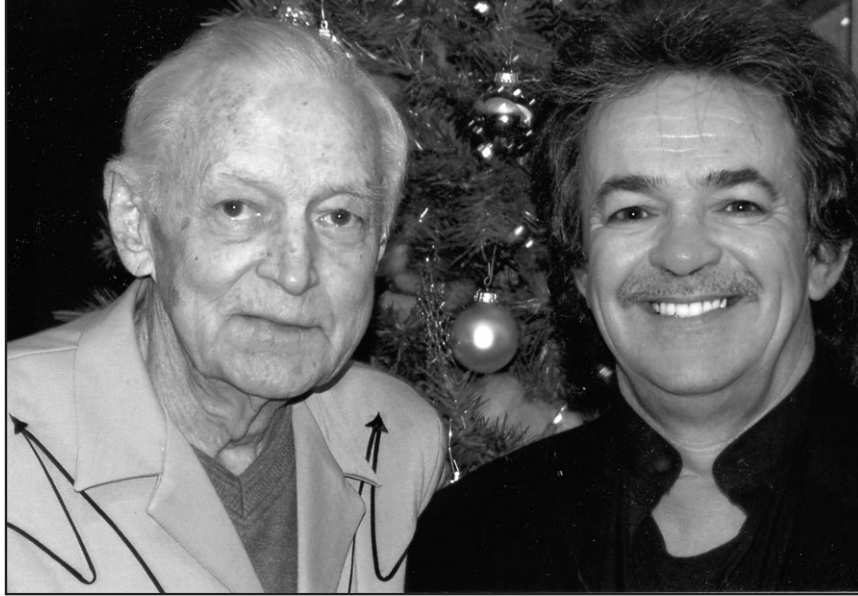
"It's the Gospel of Christ that changes lives," Wolfenbarger proclaims. "I know, because God took the broken life of a little boy and made him a Man of God...thus, was born the Gospel To Go ministry."

A 2011 interview set the table of his troubled early life.

"My earthly father had split, after becoming addicted to alcohol," he accounted. "Mother had emotional problems of her own. My younger brothers and I ended up living in a trailer with an aunt and her three children. That made 7 living in a trailer, with many meals of white gravy and a single slice of bacon on our table, on the good days, but, we still had something to eat." But then when our aunt decided for the good of she and her children, we became homeless when she moved to another state," Wolfenbarger confirmed

God took over from there, he credits.

"We had been attending an Assembly of God church in Mt. Juliet (suburb of Nashville) when a faithful Christian man came up to

me during a fateful service, and instructed: 'You're moving in with me, and your brothers are going to live with the preacher's family.'" Wolfenbarger accounts. "I recall all my earthly belongings were packed into a single cardboard box. That struck me.

"And when I got to my new home that first night, I was the only one there at the time, and recall sitting down in the middle of the floor, and recall I broke down in thankful tears, realizing that for the first time in my life, I was inside, safe and snug, in a real home," Wolfenbarger recalls.

The minister within the Country Music Family cannot recall not believing in God.

"As far back as I can remember, I have always had a strong faith in God," Wolfenbarger declares.

He uses a parable to set the stage of his adult ministry life.

"When I was 5 years old, we were visiting grandparents and all of us were down at the creek swimming," Wolfenbarger traces back to a wilderness in Kentucky. "My (blood) father was in the creek and beckoned me to jump in, assuring me that he would catch me. I was scared to do so because I didn't know how to swim. But the one thing I did know was that my father was in the creek and if he told me to jump and that he would catch

me, I knew he would. "So, I became the obedient child, and took the step of faith and jumped," Wolfenbarger noted. "I knew he would catch me." The early childhood turmoil seemed endless to a little boy. He describes a child's faith.

"My family went to church until I was about 4 years old," Wolfenbarger traces back in time.

"The music touched my very soul in ways that continue today. Grandmother always had that faith those songs and sermons were describing.

"We stopped going (to church) when my father became addicted to alcohol," Wolfenbarger notes. "My family went through very tumultuous times that resulted in my parents divorcing when I was 8 years old, then re-marrying and divorcing again when I was 10. It was during those difficult years between 4 and 10 years old, I learned to lean and rely on God to keep myself and younger brothers safe during the turmoil going on between my parents. In turn, my faith grew even stronger."

Wolfenbarger cites other ways God has favored him in life.

"In high school, sure there were boys and girls who made fun of me being without parents, without a new car when I was 16 years old," he recalled. "But I look around today at

some of those who seemed to have everything handed to them in life, and sadly, they remain without an anchor today to base their lives on...serving Christ is the anchor of life."

Gospel To Go's own birth?

"Gospel To Go' is a ministry born a few years ago when a lady in our Bible study requested I make some CDs, so she could take the Gospel message every where she goes," Wolfenbarger credits. "From that request, Gospel To Go blossomed when we put up on the website...it's impacted people throughout the world, including some former Communist bloc countries."

Wolfenbarger, a song writer, has seen God work in his own music endeavors.

"I spent years chasing that dream, writing country music songs that came close to being big hits," he noted. "But when I started writing gospel songs, and nothing happened, well, I didn't understand, and finally proclaimed, after years' of frustration. I proclaimed to myself: 'I'm finished with music.'"

But, God wasn't done with Wolfenbarger's music.

"Five days later, when I gave up on writing songs, my song agent called, informing an independent Gospel recording artist had contacted him, asking permission to record one of my songs," Wolfenbarger

noted. "See, it wasn't in my time, it was in God's time." There was more Divine intervention to come involving his music aspirations, Gospel word-smith Wolfenbarger added.

"My co-writer on many songs was Charles Lilly, whose father was Hall of Famer Everett Lilly, of the legendary Lilly Brothers going back to the late 1940s, and in the early 1950s, Mr. Lilly performed with Lester Flatt and Earl Scruggs," Wolfenbarger described. "We'd had the idea of producing an album of Mr. Everett's song stylings from the past, paying tribute to the Lilly Brothers' unique Bluegrass sound."

A tragedy was followed by a miracle.

"You can imagine my earthly sadness when we lost Charles Lilly, one of my best friends, on the night of May 21, 2006, when Charlie, along with Grand Ole Opry legend Billy Walker, and his wife Bettie, plus guitar man Danny Patton perished in a grinding car crash," recalled Wolfenbarger. "The resulting album was entitled: 'Everett Lilly & Everybody and Their Brother,'" Wolfenbarger traced back to 2007.

"We had received some positive reviews within the industry, but in 2008 we got a huge surprise," Wolfenbarger credited. "I got a phone call, out of the blue, advising our CD of Everett Lilly's music had been nominated for the International Bluegrass Music Association's coveted 'Recorded Event of the Year.' The call advised the CD had been judged one of the finalists. You can only imagine the excitement and satisfaction, not to mention the tears of thankfulness that swelled up within, when we won the award the night of IBMA Music Awards' Show," Wolfenbarger confirmed.

"Although I was thankful, and yes, proud, I knew it was God who had opened the doors for the music project, not only by having some of the top names in music volunteering to be on the album, but for the blessing of winning the award as well."

### Boys cross-country qualifies in second season

**CHATTANOOGA** - Cross-country was not an option for student-athletes at Cannon County two years ago.

One year after starting the program in 2011, Cannon County's boys team has qualified for the TSSAA Boys Class A/AA State Tournament at Percy Warner Steeplechase Cross-Country Course in Nashville.

The Lions finished second at the Region 4-A/AA meet at the Chickamauga Dam in Chattanooga. By finishing as region runners-up, the Lions entire team qualified. Central Magnet won the championship with 19 points. Cannon County was second with 61 points and Signal Mountain was a distant third with 103 points.

The top three teams and top 10 individuals advance to the state meet.

"This is a very tough region for cross-country," Cannon County Head Cross-Country Coach Marc Larson said. "The second-place regional plaque the boys won represents a lot of miles, sweat and pain that the entire Cannon County team has experienced throughout the year. I am very proud of the boys, girls varsity and junior varsity."

Freshman Elva Magana also will represent Cannon County at the state championship. Magana finished eighth overall and qualified for the TSSAA Girls Class A/AA State Tournament as an individual.

The Lionettes finished fourth with 106 points, one spot from reaching the state tournament. Central (45), Signal Mountain (58) and Notre Dame (64) were the top three teams.



Jordan Turney and Marshall McReynolds led the Lions with Top 5 finishes. Both earned individual medals. Turney turned in a time of 18:24 on the 5,000-meter course. McReynolds was fifth with an 18:47. Sophomore Jake Burdick narrowly missed a Top 10 finish. Burdick was 11th with a 19:42.

Devin Burgess earned a Top 20 finish. He was 14th overall with a time of 20:09. Clay Luker finished 30th with a 21:18 and earned points for the Lions. The top five finishers on each team count toward the team score. T.J. Paul (31, 21:26) and Will Bailey (35, 21:47) also competed at the regional meet and factored into the team success.

Magana continued her smashing freshman season. She finished eighth

with a time of 23:36 to reach the state tournament.

The Lionettes narrowly missed an opportunity to advance. Macy Clements finished 13th with a 23:50 to provide the squad with two Top 20 finishes. Hannah Faulkner was 25th with a 25:03, followed by Madison Walkup (28, 26:14), Sara Hickman (32, 26:28), Katie Hickman (36, 27:17) and Jessica Elmy (41, 28:39).

Cannon County was hampered by not having Faulkner until the last two weeks. Faulkner, who advanced to the state tournament as a freshman last season, was injured most of the season and was not able to begin competition until the last two weeks.

## Blue Raiders turn back Mean Green

**MURFREESBORO** - An explosive offensive performance coupled with stout defensive play helped Middle Tennessee to a 38-21 rout of North Texas on Saturday afternoon at Floyd Stadium.

The Blue Raiders (5-3, 3-1 Sun Belt) played sharp offensively in their black helmets and uniforms, totaling 448 yards on the day. MT forced four Mean Green (3-5, 2-2 SBC) turnovers to secure their third conference win.

For the third time under head coach Rick Stockstill, the Raiders reached five wins in eight contests. The other two times occurred when MT reached bowl games in 2006 and 2009. Another MT win would put MT with six wins for the fourth time in the last seven years.

Offensively, the Blue Raiders relied on the arm of Logan Kilgore and the hands of his play making receivers. Kilgore reached 300-plus yards for the third time in his career when he completed 20 out of 30 passes for 349 yards and three touchdowns. Kilgore threw four passes of 34 yards or more in the contest. He also ran a career-high 45 yards for a touchdown.

The Raiders had two wide receivers catch 100-plus yards for the first time since playing WKU on Oct. 24, 2009. Anthony Amos and Kyle Griswold caught 11 passes for a combined 261 yards and three

touchdowns. Amos moved into 10th all-time in a single season with 794 yards, while Griswold set a personal best in yardage and touchdowns.

Middle Tennessee's defense collected three interceptions, two sacks and a fumble on Saturday. The bruisers were led by JuJuan Harley with a season-high 14 tackles and an interception. MT had three tackles-for-loss as O'Shae Bridges and Leighton Gasque each had a sack.

Harley's interception helped jumpstart the Raider offense in the first quarter. Eight plays later, Kilgore threw an 18-yard touchdown strike to Amos to give MT the seven point edge with 9:18 on the clock.

The MT offense found more open pockets in the secondary and Kilgore connected with Griswold with a 72 yard touchdown pass to put the Raiders up 14-0. Carlos Lopez tacked on his 10th field goal of the season, extending the Blue Raider lead to 17-0.

Middle Tennessee used its long-yard passing game to its advantage. Kilgore threw a 49-yard pass to Griswold to give the Raiders a 23 point lead with less than three minutes remaining in the first half.

For the half, MT amassed a season-high 304 yards of offense at the intermission, including 248 yards from the air. North Texas was limited to 97 yards. Kilgore completed 11-of-15 for 248 yards.

## “Hornet’s Nest” at Pittsburg Landing

The story didn't take place on the bloody fields at Stones River, but instead at the horror that was called the "Hornet's Nest" at Pittsburg Landing on the Tennessee River.

Martha Ann Wallace was extremely anxious about the welfare of her husband Brig. Gen. W.H.L. Wallace. Will Wallace, a lawyer from Ottawa, Ill., had been one of the heroes of the Union victory at Fort Donelson.

He was a hero because his unit weathered the worst of the battle.

At the start of the Civil War, Wallace volunteered as a private with the 11th Illinois, which was assembled in Springfield. He was then elected the unit's colonel. He quickly climbed the ranks and commanded a brigade of Brig. Gen. John A. McClernand's division of Brig. Gen. U.S. Grant's Army of West Tennessee at the Battle of Fort Donelson in 1862.

At Fort Donelson, McClelland's division had been driven back with heavy losses but Grant and others especially noted Wallace's coolness under fire.

Brig. Gen. Lew Wallace described him as looking like a "farmer coming from a hard day's plowing."

Lew Wallace, who hailed from Indiana, was the more descriptive of the two. Besides being a Union general, he was also governor of Indiana after the war. But he's best known as the author of one of the best-selling books of all time, "Ben-Hur: A Tale of the Christ."

Modern readers tend to get the two Wallaces confused.

Will Wallace was born in Urbana, Ohio, and educated at Rock Springs Seminary in Mount Morris, Ill. He was invited to study law with Abraham Lincoln in Springfield, but was convinced to join the practice of T. Lyle Dickey in Ottawa, Ill., and married Dickey's daughter, Martha Anne, in 1851.

He had joined the 1st

Illinois Infantry in 1846 as a private. He rose to the rank second lieutenant and adjutant and participated in the Battle of Buena Vista along with a few other minor engagements. After this brief experience in the Mexican-American War, he became district attorney in 1853.

At Fort Donelson, Wallace's troops had saved the day, although the 11th Illinois had lost nearly two-thirds of its men.

Wallace and his wife were close and constantly corresponded when they were apart. Perhaps something he wrote alarmed her, but legend claims it was a premonition of death that caused her hastily to seek permission to take a steam boat to where Grant's army was assembling at Pittsburg Landing in Hardin County, Tenn. near Savannah.

It was Grant's plan to combine the Army of West Tennessee with Gen. Don Carlos Buell's Army of Ohio, but Confederate Gen. Albert Sidney Johnson planned on hitting Grant and trapping him on the banks of the Tennessee before Buell could arrive.

Johnson, who was mortally wounded during the battle, almost succeeded. Grant was recovering from nearly being crushed by his horse in a fall days earlier, and his army was disorganized when Confederates attacked at daylight near Shiloh Church. Shiloh is a Hebrew word meaning a place of piece. That peace was to be broken early Sunday, April 6, 1862.

At 7:15 a.m., Grant, nine miles downriver at Savannah, had his breakfast interrupted by the sound of cannon fire. William T. Sherman was surprised as well. Sherman, who was to redeem himself at Shiloh, was fired on and slightly wounded at 7 a.m. by Confederates from Cleburne's Brigade.

On the main Union defensive line, starting at about 9 a.m., men of W.H.L. Wallace's division, joined by survivors of

Benjamin Prentiss' division, established and held a position nicknamed the Hornet's Nest, in a field along a country lane now called the "Sunken Road."

The pivotal position withstood 11 Confederate attacks until Brig. Gen. Daniel Ruggles was given permission to round up a massive battery of 53 to 62 cannons to blast the Union defensive line.

Lt. Abner Dunhan, of the 12th Iowa said the artillery fire "seemed like a mighty hurricane sweeping everything before it.... The great storm of cannon balls made the forest in places fall before its sweep, ... men and horses were dying, and a blaze of unearthly fire lit up the scene. At this moment of horror, when our regiment was lying close to the ground to avoid the storm of balls, the little birds were singing in the green trees over our heads."

The Union troops held to the scant cover, but to move was to die. But Wallace's men were forced to move when McClelland's Division began to collapse on their flank.

At the same time, Wallace's wife was on a Union steamer that was ferrying soldiers in and out of Pittsburg Landing. She recalled that terrible day in a letter to her aunt.

"The lower deck of our boat and that of others was used to ferry reinforcements over. Over and back, over and back we moved. I was earnestly watching these scenes more hopeful than most around me," Ann Wallace wrote.

But "Elder Button," who had been tending to the wounded, gave her a hint of the bad news to come.

"You have a great many relations on this field, you cannot hope to see them all come in safe.' I answered, 'They all came safely through Donelson, and today my husband is in

command of a division and is comparatively safe.' He repeated from behind my shoulder, 'It is an awful battle.'" she wrote.

The truth then hit her like a steely, cold thunderbolt.

Some while later, her brother Cyrus Dickey came, crestfallen, with the official news.

"My husband was dead, and the enemy had possession of the ground where he lay. 'Twas all they could tell me, and it was enough," Ann wrote.

But Wallace still lived. He had been found on the battlefield, partly covered from the overnight rain by a blanket.

At about 10 a.m. Monday morning, Ann Wallace received the news that her gravely wounded husband was aboard the adjacent steam boat. She rushed to his side to find him with a horrible wound in his temple, but breathing naturally.

"The greatest joy was yet to come - Will recognized my voice at once and clasped my hand. I was thrilled and exclaimed, 'He knows me; he knows me!' Others said that could not be, but Will's lips moved and with difficulty uttered, 'Yes.'"

The steamer transported Wallace to Union headquarters in the Cherry Mansion in Savannah. The river front house was where Grant was enjoying his breakfast the previous morning.

Wallace was to linger three days in the loving embrace of his wife and surrounded by brothers Martin and Hitt Wallace and Ann's brother, Cyrus. Gen. Sherman had refused Ann's father, Colonel Dickey's request to join them.

"No surroundings of my life were ever more painful, Ann had been in the neighborhood for three days and was hanging over the bedside of her dying husband and I could not come to her support," Dickey wrote.

Wallace seemed to rally, then faded.

"My darling knew he was going and pressed my hand long and fondly to his heart. Then he waved me away and said, 'We meet in Heaven.' They were the last words upon those loved lips," Ann wrote.

Today, the Cherry house is a privately-owned residence marked by a historical marker. Passersby have reported seeing the face of a man wearing a Civil War uniform peeking out an upstairs window.

Some say it's the apparition of Grant, but a much more likely occupant is the spirit of long-suffering Gen. Wallace.

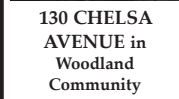

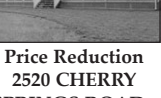

**Jehoshaphat Appoints Judges**  
II Chronicles 19

He reminded them to consider carefully what they did because they were not judging for man but for the LORD, who was with them whenever they gave a verdict. He instructed them to let the fear of the LORD be upon them and to judge carefully, for with the LORD our God there is no injustice or partiality or bribery.  
In Jerusalem Jehoshaphat appointed Levites, priests and heads of Israelite families to administer the law of the LORD and to settle disputes and ordered them to serve faithfully and wholeheartedly in the fear of the LORD.  
Late in his reign Jehoshaphat made an alliance with Ahaziah, king of Israel and son of Ahab, who was guilty of wickedness. He agreed to construct a fleet of trading ships at Ezion Geber. Eliezer prophesied against Jehoshaphat telling him that because he had made an alliance with Ahaziah, the LORD would destroy what he had made. The ships were wrecked and were never able to set sail.

# Tips for a healthier Halloween



BONY FINGERS

Make your Halloween season healthier this year by getting plenty of physical activity to balance food intake and help children choose wisely and eat their treats in moderation. Help kids and yourself enjoy Halloween without overindulging.

Use party games and trick-or-treat time as a way to fit in 60 minutes of physical activity for kids. You can encourage and pump up the enthusiasm for being more active by providing small and inexpensive toys that promote activity.

A tip for a healthier Halloween is to hand out treats rather than just candy (granola bars; snack packs such as trail mix, raisins, crackers, or pretzels; 100% juice boxes; non-candy Halloween treats such as stickers, bookmarks, tattoos, erasers, and pencils). A new toothbrush is even a neat treat for kids to receive!

For classroom snacks, you could get creative and provide healthy treats by

making something with popcorn. Popcorn is a healthy snack. The following are ways to make it "extra creepy!"

### BONY FINGERS

Put a piece of candy corn in the fingertip of each finger with the small pointy end sticking out like a fingernail. Fill clear plastic gloves (the type designed for wearing in the kitchen when preparing food) with popcorn. Tie the end with orange and black ribbon.

### HALLOWEEN MIX

By mixing Halloween candy with popcorn, you cut back on the total

amount of candy offered. Fill a sandwich bag with popcorn for each child. Combine popcorn with your choice of the following ingredients.

In early autumn, adult and large nymph boxelder bugs congregate in large numbers, primarily on the bark of boxelder trees, and then begin migrating to a place for overwintering. Only adults overwinter, moving to hibernation sites either by crawling or flying. These insects hide in cracks and crevices in walls, in door and window casings, around foundations, in stone piles, in tree holes and in other protected places.



On warm days during winter and early spring, they sometimes appear on light painted surfaces outdoors on the south and west sides of the house, resting in the sun. Overwintering adults leave their hibernating quarters with the coming of warm weather, and females begin laying eggs in crevices of tree bark and on other objects near host plants. Eggs begin to hatch after 14 days. Nymphs appear about the same time buds break and new leaves emerge.

In July, new adults lay eggs that result in a second generation by early autumn. Boxelder bugs feed primarily on the seed-bearing boxelder trees by sucking sap from the leaves, tender twigs and developing seeds.

Occasionally, they have been observed feeding on silver maple, other maples, ash, plum, cherry, apple, peach and grape. Feeding injury results in some scarring or dimpling of fruits. However, boxelder bugs seldom develop in large enough numbers to become a nuisance unless able to feed on pod-bearing boxelder trees. Apparently, they do little feeding damage to boxelder trees. They may also suck juices from fruits of thorn-less common honey locust, plum, cherry, apple and grape.

### Control Measures

**Outdoors – Host removal**  
Because boxelder bugs breed on female boxelder trees, removal of these trees may reduce nuisance populations. Correct identification of the nuisance bug is important to prevent removal of the incorrect host. While removal of a volunteer boxelder tree may be considered when boxelder bugs are the pest, it would be a shame to remove a valued landscape plant such as a golden-rain tree unnecessarily. If boxelder trees are desirable for shade, ornamental beauty or other purposes, nursery producers should propagate them by taking

cuttings only from male trees.

### Outdoors – Exclusion and Sanitation

Be sure to repair and close openings where boxelder bugs can enter the house before bugs start moving off their host in the fall. Exclude pests with tightfitting doors, windows and sealed walls. This may involve adding door sweeps, adding weather stripping to sliding glass doors and windows, caulking openings in window frames, repairing holes in screens, adding screens, etc. If you are unsure whether a door fits tightly, observe the door from the outside when it is dark and an interior light is on. If light is seen around the edges of the door, then it doesn't have a good seal. Seal cracks, crevices and holes in the foundation. Screen vent openings in foundation walls and attic. Caulk or seal holes in outside walls, eaves and other external surfaces. Many pests use wires, pipes, tree limbs and other guidelines to help them move from one area to another. Voids around pipes can be sealed with steel wool or copper gauze (which won't rust) and expandable foam. Eliminate potential hiding places, such as piles of boards, rocks, leaves, grass and other debris close to the house. Rake leaves, mulch and grass away from the foundation, especially on the south and west sides of the structure.

**Outdoors – Removing Bugs by Vacuuming**  
A wet/dry vacuum cleaner can be used to remove large numbers of these insects. Vacuum the bugs into a soapy water mixture (one teaspoon of a liquid household detergent per gallon of water). The bugs will drown quickly in the soapy water.

### Outdoors – Insecticides on Trees

Inspect boxelder and other host plants during spring and early summer for young, exposed boxelder bugs and treat to prevent potentially large populations and indoor migrations in the autumn. This is best done by a professional. Consideration should also be given to whether infested trees are on a neighbor's property, since the adults often fly to nearby buildings to overwinter.

### Outdoors – Insecticides on Structures and Indoors

When the "swarm" of box elder bugs emerge, homeowners want immediate and complete relief, unfortunately this simply is not possible. Because bugs are emerging from hidden areas that are mostly inaccessible to insecticides, setting off household foggers or "bug bombs" will not provide effective control of these

pests Indoor control is often difficult because the bugs are scattered throughout the house. Boxelder bugs emit substances that can stain surfaces, making a broom less desirable. Use a vacuum cleaner to remove bugs indoors. Although we are not aware of allergies caused by exposure to boxelder bugs, it is best to use a vacuum with a HEPA filter to prevent insect parts from being circulated in the air. Upon completing the vacuuming, vacuum cleaner bags should be placed in a plastic bag and the bag sealed. The bugs can then be destroyed or the sealed plastic bag can be placed in a tightly-sealed outdoor garbage can.

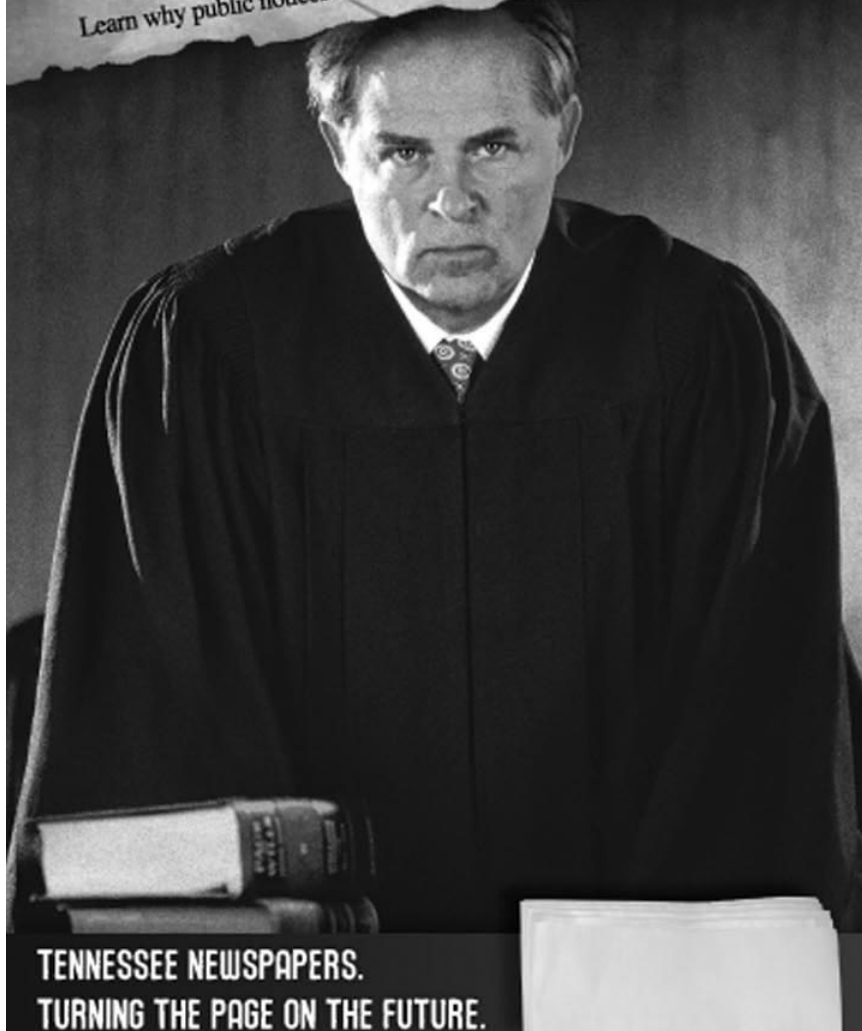

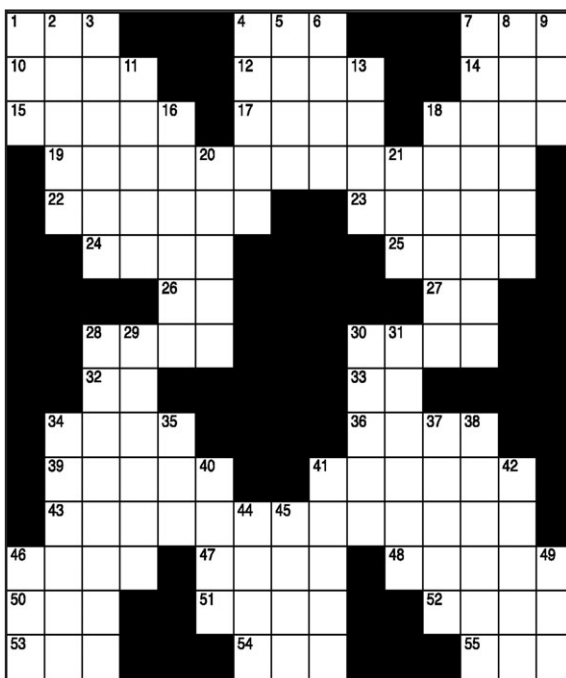
Dear Ken: How many times was Frank Sinatra married and how many children does he have?
