# Charges filed in homicide

Metro Nashville detectives charged Nicholas T. Griffin in connection with the death of Cannon County native Henry Moore.

Griffin faces criminal homicide charges for the death of Moore, who had worked in Nashville for nearly 40 years as a Yellow Cab driver.

Metro Police said additional arrests are anticipated in the case.

Griffin, 20, of Derrick Court Nashville, was developed as a possible suspect early in the investigation. Detectives located him Wednesday, Oct. 31 afternoon. During an interview, Griffin admitted to his involvement in the murder, which he said occurred during a robbery.

Moore, 69, was shot in the 1500

block of 10th Avenue North before 3 a.m. Friday, Oct. 27 after being dispatched to pick up a fare at 10th Avenue North and Garfield Street. After being shot, Moore accelerated the cab and crashed at the intersection of 10th and Garfield.

"It was his belief that a lady and her

child needed to go to Vanderbilt hospital," said Yellow Cab President and General Manager Doug Trimble. It was far out of his way, but there were no other available drivers, so he agreed to go across town to pick up the female caller who said it was an

emergency. About a block from the intersection, someone pulled out a gun. The shot shattered his driver's side window. The cab crashed a block in front of a

church, across from a school.

The investigation into this murder case remains active. Griffin is being held in lieu of \$750,000 bond. Griffin was previously arrested in

April for waving a gun at a group of See CHARGES page 9

# Father shoots son in self-defense case

The Cannon County Sheriff's Department is investigating the shooting death of Thomas Laxton in Bradyville.

"On 28 October 2012, we responded to 350 Lola Lane in Bradyville TN for a victim of a gunshot wound," said Sheriff Darrell Young.

"During the course of this investigation it was determined that a 65-year-old male, Pless Laxton had shot his son, Thomas Laxton, in an altercation. Thomas Laxton had a history of drug abuse," the sheriff said.

The investigation is still ongoing and was conducted by members of the Cannon County See FATHER page 9

# Franz Walkup battles to recover from wounds

# Family, community show their support

Franz Walkup wanted to follow in the footsteps of his father and older brother when he joined the military.

Much like those family members before him, Walkup gave of himself to serve and defend his country. The Army fire support specialist has been transferred to Walter Reed Hospital in Washington, D.C., after suffering from injuries sustained during an attack in Afghanistan.

Walkup was injured during a gun battle in Afghanistan in late September. Walkup suffered gunshot wounds to the abdomen when U.S. soldiers fired upon Afghan allies who returned fire. U.S. soldiers believed they were under attack by insurgents when a mortar round hit a checkpoint set up by American soldiers. The Afghan allies returned fire and Walkup was shot five times.

Doctors originally treated Walkup, a Cannon County High School graduate, in Landstuhl, Germany. He underwent five surgeries to repair various serious injuries. He was recently transferred to Walter Reed Hospital in Washington, D.C., where he continues to battle on the road to recovery. The Walkup family has endured military conflict previously. Frank Walkup III was a Marine, as was another of his sons, Frank Walkup IV. Walkup IV was killed by an explosion in Iraq in 2007. He was a commissioned officer and was a member of the ROTC program at the University of Tennessee.



fairly," said Davenport, who appointed Siskin to his current seat as Rutherford County's Juvenile Court magistrate in 2004. "He knows the law. He's the whole package."

The Vanderbilt graduate and University of Georgia School of Law alumnus said this appointment fulfills a life-long dream.

"This is why I went to law school," Siskin said. "You can say it's a calling." Siskin explained he interned for a judge in high school, which inspired his love for law.

"I've wanted to be a judge ever since," he said. Siskin's first step to

recovery process will not be an easy one; however, she says there is progress and all the love shown Franz helps drive him.

"It's tough, especially when you have been through this before," Agee said. "We are so very lucky and fortunate. We are so relieved that (Franz) is doing better. Knowing people care and are sending prayers and support has been helpful."

Franz' twin brothers, Jake and Joshua, are eighth-graders at Woodbury Grammar School. They said just knowing their brother is

The larger workers serve as guard-rats and the smaller ones are assigned to gather food, maintain the nest, take out the garbage, repair the cable and so on.

Life is hardly a bowl of peaches for any African mole rat, but if you're a sterile little runt worker-rat you're REALLY at the bottom of the totem pole.

# Local families' music tradition goes global through Mickey Harris

At age 3, he had a toy guitar.

At age 9, a real bass electric model had Mickey faithfully playing music each Thursday night for aging and ailing veterans at York VA Medical Center and the little "Leanna Opry"in the old building.

At age 10, Middle Tennessee native Mickey Harris touched musical history, to wit, by playing backup to legendary Uncle Dave Macon with deep Cannon and Rutherford county musical roots.

At age 36, the locallygrown minstrel strums and strolls all over the world with internationally acclaimed Rhonda Vincent and her Rage band.

More about that first electric bass guitar: "Grandfather Jack (the late) Tomberlain bought it for my birthday. His band needed a bass player, so that's what got me started."

More about playing for the veterans: "Because my father, Eddie (Harris), worked in healthcare at hospital, they permitted me, at under-age 9, to come into Dad's ward and make music for the veterans with my family, headed up at that time by Grandfather Tomberlain. We did that several years for the veterans.

More about making history with the late great Uncle Dave Macon: "I was age 10, when our family's band was asked to back Uncle Dave in a local performance. I sheepishly warned the legendary Uncle Dave, I didn't know any of his songs. I'll never forget his words: 'My songs are simple, you'll be OK.' With Uncle Dave's confidence, I must have done fine.

And into the new 21st Century the music plays on, as evidenced last month when he and a group of family and friend musicians picked, harmonized and honored Rutherford resident Grandmother Louise (music maker) Tomberlain at Murfreesboro's Farmer's Restaurant on

landmark birthday. Rutherford/Cannon county music royalty was there, including 84-yearold legend Billy Yearwood who dates back to the 1940s picking with Mickey's extensive musicmaking family, that includes the Tomberlains, the Tiptons and the

Leonards. On the wall at 's WGNS Radio, hangs a historic picture of Mr. Yearwood, who can be heard each Saturday morning making music at historic Readyville Mill Restaurant.

That 1947-era picture shows Mickey's (late) Uncle Carl Tipton, with (then little and young) Floyd Leonard, a presentday Murfreesboro resident, stroking the strings of a big bass fiddle, and Mr. Yearwood making his steel guitar cry out, blanketing radio land in parts of five Middle Tennessee counties.

While on tour recently in North Carolina and Arkansas with Rhonda Vincent, whom Mickey has performed with the last 11 years, Mickey described some of his music family roots,

"It's born in us...this music stuff. No reunion goes without music. It runs in the family from generation to generation," Mickey shared over a pile of hash browns and scrambled eggs at an eatery. "That was evidenced the recent night we honored Grandmother Louise with a surprise dinner and picking session."

Those invited guests grew emotional when Louise and her sister, 77year-old Sophie Tipton, after encouragement from picking session leader Mickey, jarred down on soulful notes of an old Baptist hymnal song.

"My four-year-old son, Jackson, named for Grandfather Jack Tomberlain, walked up that night we honored Grandmother Louise, and asked fiddle player Tom Brantley (of Wartrace) if he'd teach him how to play the fiddle," Mickey



shared. " Jackson is already interested in music.

The family's generational music tradition looks safe going into the future.

"Daughter Mikayla (age 6) already loves to sing and loves music, so yes, the generational thing looks promising," Poppa Mickey noted proudly.

Mickey recalls his boyhood days of music, dating back to the regionally-famous "Carl Tipton Show" that aired multiple decades on area radio and TV stations.

"Even when I had a toy guitar, sometimes they'd have us younguns come out on stage, to maybe help introduce a special guest, or to pretend we were making music along with the adult musicians,' Mickey continued.

"Grandmother Louise and Aunt Sophie were lead singers with Uncle Carl in that era and we played a lot at the old Leanna Opry on Saturday nights.'

Today, Mickey is recognized in the industry as accomplished on multiple instruments, including the Dobro, mandolin, banjo, guitar and bass

He describes area music heritage.

"Rutherford and Cannon counties are rich in talent, have greatly impacted the and world music scene, starting of course, with first super star, Uncle Dave Macon," Mickey strummed back in time. "Uncle Dave put Murfreesboro and Cannon County on the map.

"I recall Billy Yearwood going back to the 1940s, with him appearing with legends such as (the late) Kitty Wells and her husband in 1946," Mickey added. "Mr. Yearwood later played with us, when I was a boy, at York VA Medical Center. And today, at age 84, Mr. Yearwood and his music plays on. We have a great

sort of cute-o-meter. The cuter the critter, the more angst from the activists.

## Murfreesboro is still behind the times

I consider myself as one who enjoys talking about the old days, but really appreciates my modern conveniences.

I've lived without running water, indoor plumbing, air conditioning, heat in every room and other things we take for granted these days. I've done it and would not enjoy going back. I would miss my Facebook, 125plus channel TV, central heat and air, computers, microwave and other things that I enjoy on a regular basis. But, even with all of these wonderful modern day inventions, I'm still one of those who lives in an area of this great state that is behind the times.

I really didn't know it until the other day when I opened my mailbox and had a letter from the countv's area cable company telling me about how my cable subscription was outdated and I needed to upgrade to their new super system. It had all kinds of movies, public service channels, viewing on demand and internet service so fast that it would go to a website almost as fast as you could think of it. Plus, they would lower my monthly charges for the first six months so that it would only cost me pennies a day to upgrade.

It sounded like a great offer and I looked at the envelope one more time to see if it was really mailed to me, and sure enough, it was. There was one problem though. I don't have cable and cable has never been made available to anyone who lives on our county road.

I would like to have fast Internet, but unless the cable company knows something I don't know, I think all I'm going to receive is the envelope currently lying on my kitchen table.

You see, our farm is located only fifteen miles from Murfreesboro, which just happens to be one of the fastest growing areas in this state, and for awhile, this nation. I moved back to the family farm in 1998, and as soon as we made the move, asked for cable to be placed on the farm. Knowing that the service was only one half mile from our house, I assumed that it easily would be made available. However, that was not the case. After my first call and two weeks of waiting for a survey to be made checking out the possibilities of getting the service, I received a call telling me they had good news. The cable company told me that they could hook me up for



only a mere \$8,000. In fact, it would cost some bit more than that, but after that quote, it was not going to happen anyway. I, instead, put up an antenna, forgot about Internet and lived as I had before leaving the farm some 25 years earlier.

Waiting another 6 years, I tried again. Once again, the cable company, who had gotten the other company's contract from the county since the last time I tried to go global, gave me the same story. Trying not to be out-done, I put in satellite for the TV and contacted my phone company to get Internet. Yet again, I found out how communicationilliterate my farm was. There was no DSL line near my house, so I had to settle for dial-up. And by the way, they thanked me for upgrading my phone service and being a faithful customer.

What they didn't know, but should have, was that I was becoming а disgruntled rural customer like many folks in the rural parts of this state. Today, I still have satellite TV to watch my westerns on and my Internet is accomplished by a cell phone hot spot. Rural Tennessee has made large improvements in affordable broadband coverage, but it needs more! Why is it so important to rural Tennessee? The Tennessee Broadband Task Force several years ago answered that question. They said, "Broadband expansion is to the 21st century what rural electrification was to the 20th century. High-speed Internet access is critically important to Tennessee's future, especially in jobs, education and healthcare."

electrification Rural changed rural Tennessee from kerosene lamps to electric lights and generated billions of dollars to our state's economy. Iust like electricity affordable helped rural Tennessee, the current efforts to bring affordable broadband into the outer areas of our counties has placed at the fingertips of rural Tennesseans much а needed economic impact, along with jobs that have helped during difficult times over the last few years. But, more must be done.

Today, Connected Tennessee, which is an independent non-profit organization, is the only group that monitors rural areas of this state connected by broadband. They give out information about coverage areas, organizing communities and educating policymakers. We need more involvement by local citizens, civic groups and other Tennesseans to bring our rural areas up to speed like our urban locations

# WIC kiosks increase convenience

Good nutrition for pregnant women, infants and children ages five and under just got easier for of Cannon residents County. The Cannon County Health Department is now offering online education for clients of the Women, Infants and Children, or WIC, program. "Nutrition education for some WIC participants can now be done at home or wherever you can use a computer," said Barbara Prater, nursing supervisor for Cannon County Health Department. "If WIC clients do not have a computer, a WIC kiosk is available at the Cannon County Health Department." Eligible WIC clients can

use the health department computer on the kiosk and follow the easy instructions

on Saturday, October 27th in

Murfreesboro. The race is a

to complete a ten minute module on nutrition. When the module is complete, clients receive a certificate and the office assistant will print their WIC vouchers.

Online WIC education can also be done outside the health department. Eligible clients who are currently enrolled in the WIC program and are not considered high risk or receiving therapeutic formulas can go to http://health.state.tn.us/wic edu/ to access online education. If a printer is not available, the client can write down the name of the completed session, their certificate number, the date and the time the session was finished and bring that information to the health department on their next WIC visit.

"Our goal is to make it easy for pregnant women, infants and young children to receive nutritious food and reliable nutrition information," Prater said. "Good nutrition during pregnancy helps reduce infant mortality and good nutrition from infancy through the preschool years helps children get started on healthy habits for life."

Eight WIC educational modules are currently online available and additional modules will be developed.

To qualify for WIC, a family of four can make up to \$42,643 annually. For more information on WIC, including income guidelines and eligibility requirements, contact the Cannon County Health Department at 563-4243.

judgeship was in 2004 when Davenport appointed him as a Juvenile Court magistrate, where he presided over both civil criminal and cases including parentage, child support, child custody and dependency, visitation, neglect, abuse and delinquency matters.

Siskin was mostly assigned temporary cases and like motions preliminary hearings - in iuvenile court, because any of his decisions could be appealed to her as the supervising judge, Davenport said.

But may attorneys would request Siskin to get a faster hearing and not appeal to Davenport.

"A lot of attorneys would waive the appeal, because he knew the law," she said. Davenport appointed Siskin to the magistrate seat because she had seen him in action over the years in juvenile court, representing everything from children with delinquent acts to child neglect to child support cases, she said.

"That's how I knew his capabilities and intelligence - from practicing in font of me," she said.

Haslam must have seen his capabilities to appoint him to the 16th district bench, which has seen some high profile cases recently. The most recent and high profile was the of Shanterrica case Madden, who was sentenced in July to 29 years in prison for the murder of Lady Raider basketball player Tina Stewart.

Ash, who has served the 16th Judicial District Court since 1994, stepped down to be a senior judge for the State of Tennessee. These are appointed by the Tennessee Supreme Court and may be assigned on a

temporary basis to hear cases in any state court. With the addition of Ash, there will be four senior judges statewide.

"The opportunity to try all types of cases across Tennessee, as well as sitting on various appellate courts, will certainly be a challenge but I am truly excited about this new phase of my judicial career," Ash said upon announcing his promotion in July.

In addition to his regular docket, Ash was the presiding judge of the 16th Judicial District Drug Court and DUI Court.

In addition to his time on

the bench in Rutherford County, Ash also authored "A Bridge over Troubled Changing the Water: Custody Law in Tennessee," which became the basis for changes to domestic relations laws in Tennessee. He also coauthored "Children of Divorce: A Practical Guide for Parents, Therapists, Attorneys, and Judges' with William Bernet.

"I have all the respect and admiration for Judge Ash. I have real big shoes to fill. But I'll do my best to follow in his footsteps," Siskin said.

While Ash presided over

a variety of case, it's unclear whether Siskin will hear civil or criminal cases, because case assignments are at the discretion of Judge Mark Rogers. But regardless of the type, Siskin feels ready for whatever cases that come before him.

"Either way I can draw from my experience in juvenile court," he said, explaining that much of the state law and case law is similar, whether it be a divorce case or a criminal case.

"It's going to be a challenge, but I'm ready to get to work," Siskin said.

## Farm Service Agency announces crop year 2011 sure program signup

Farm Service Agency Administrator Juan Garcia announced today the signup period for the 2011 crop year Supplemental Revenue Assistance Payments (SURE) program opened October 22, 2012. The SURE program is part of the Food, Conservation, and Energy Act of 2008 (Farm Bill). Under the 2008 Farm Bill, SURE authorizes assistance to farmers and ranchers who suffered crop losses caused by natural occurring disasters through Sept. 30, 2011.

Donny Green, County Executive Director of the DeKalb/Cannon County Farm Service Agency says he wants producers to be aware of this signup so they are certain to visit

their FSA county office to file a crop year 2011 SURE program payment application no later than June 7, 2013.

Since DeKalb/Cannon Counties received a disaster designation in 2011, producers who obtained an insurance policy or plan of insurance for ALL 2011 crops (except grazing crops), or meet waiver provisions as disadvantaged, socially resource, or limited beginning farmers AND suffered at least a 10% production loss, due to a natural disaster, to at least one crop may be eligible if all other payment conditions are met. Producers considered socially disadvantaged, a

beginning farmer rancher, or a limited resource farmer may be eligible for SURE without a policy or plan of insurance or NAP coverage.

SURE payments are calculated based on 60% of the difference between the SURE Disaster Program Guarantee and the Total Farm Revenue. A limit of \$100,000 applies to the combination of payments from SURE and the livestock disaster programs.

Producers who do not file a 2011 SURE program payment application by June 7, 2013 will not be considered eligible for 2011 SURE program payments. # 911 Board oks new high school connection

Cannon County's 911 Board of Directors voted unanimously Oct. 25 to purchase equipment allowing the county's center to connect to a new, statewide network.

The proposal was presented to the board by 911 Director Roy Sullivan.

Cannon County, he said. "NG911 will enable the transfer of call information including the caller's location," Sullivan said.

Currently, a wireless location is caller's calculated by either X and Y coordinates or GPS. If the call hits a neighboring Tennessee county's cell tower, the 911 service does not receive the caller's information, making it necessary to verbally relay the location. That takes up precious time, he said.

It's difficult for Grace Christian Academy Coach Randy McKamey to remember a time when football was not a key part of his life. He grew up in the shadows of Tennessee's Neyland Stadium, playing for his hometown Clinton High School, then furthered his education and playing career while proudly wearing the Orange and White uniform of the Tennessee Vols. He was truly living a dream that literally thousands of young men share on Friday nights in the fall.

For nearly 20 years now, he's coached the sport that has meant so much to him. The last six years, he's been the head coach at Knoxville Grace, watching his son Will, a potential Mr. Football candidate, mature into one of the top players in the state. Just days earlier, the talented athlete received a scholarship offer to play for the Naval Academy. It was an incredibly proud moment for everyone in the McKamey family.

But a couple of Friday nights ago, the game that has meant so much to the McKameys nearly took Will's life. In the regular season finale at South Pittsburg, young McKamey suffered a serious brain injury and was airlifted to Erlanger Hospital in Chattanooga.

One moment, everything was fine. Young McKamey had just scored a touchdown and the ensuing two-point conversion. But after trotting off the field, he collapsed into the arms of Grace's athletic director on the sideline.

"I had no idea that Will was hurt," recanted the coach a few days after the incident. Seconds later, McKamey's wife Kara was tugging at her husband's arm, letting him know their son "was in trouble". Unconscious and flirting with death, young McKamey had suffered a serious brain bleed.

"As we raced down I-24 towards Chattanooga to meet our son at the hospital, I prayed like I'd never prayed before," said Coach McKamey. "It was then that the reality of it all finally set it, that I might not see my son alive again," he said.

Will's condition was touch and go for a while. Brain scans were initially made every four hours and literally thousands of prayers were lifted up on his behalf as word about the seriousness of his injury spread like wildfire across the state.

But almost miraculously, young McKamey's condition began to drastically improve. Doctors at Erlanger were baffled. What they were seeing on the brain scans did not match the condition and actions of their patient. By Monday afternoon, less than 72 hours after his body was flown from South Pittsburg to Erlanger, doctors announced he could go home on Tuesday.

Young McKamey, an honor student, will likely be back in the classroom on a limited basis this week. Whether or not he'll be back on the field in uniform is still up in the air. Doctors are projecting, however, that he should make a full recovery, enough to honor his scholarship offer at Navy.

I remember the alerts going off, by this time I thought I was in the Navy, because of all the ships I had been on and now we were being torpedoed. We looked out to sea and saw two destroyers coming to us, it was then we saw that they were Australian destroyers coming towards us dropping depth charges where they thought the submarine was.

The Australians hit the sub and Hillis and the others continued their crossing to Korea. When Louie and his battalion landed they went by foot to different bamboo villages, in all they traveled about 30 miles. He said they rested for the night all the while he said they could see flashes in the north. The next morning they left at 0830. Companies L and K were together heading into the pass.

Louie explained that the Pass was actually a horse shoe road, twisting and winding up and over a mountain. He said they came upon a dead North Korean officer. They continued forward towards the Pass when they came upon this long valley with rice patties on each side of them. Louie says that this is when the sound of rifle and machine gun fire began filling the air. Everyone scattered and tried to take cover. "I had a Lieutenant beside me and he had nothing but a pistol on him and he took my rifle and started up the hill.

The lieutenant told me there was a sniper around; he started up the hill when I saw him get shot dead on by the sniper, he had on the web type gallowses on his back and I saw them pooch out; he slid down the hill to me and started shaking his head and climbed back up the hill. I followed him, but I never got to see where he went because they grabbed me and started loading me down with 60 millimeter mortars because I didn't have a rifle on me. I climbed the hill to where they had the mortar launcher set up and we started sending those mortars, but I never could find where they hit." Louie recalls. After a fierce battle where the US took a beating a lot of the soldiers were separated from the others. It was at this time that Louis was captured.

The Koreans took Louie and the rest and marched them into Hadong village, he said it looked flattened and it was burning. "There was a place that looked like a church or a school to the left near the trees and when we got there it was packed full of GIs', so they took us across the yard and put us in a chicken hut (Louie and three more). Louie said when you are penned up like that and because of nothing to tell time he couldn't give us the specifics on some things that happened but he said it wasn't too much later that one of our aircraft came and dropped a napalm bomb onto that hut.

He said they had no radio communication with anyone. "Our boys didn't know we were behind the enemy lines, I found out later that 18 of the GIs' died in that building. I know because four of us could walk and we had to bury those GIs'. We did get their dog tags though and we gave them to Lieutenant Reid. The bomb went in the front and came out the back. I did hear that about 8 were taken from there up north on a death march and then to the Sunchon Tunnel.

"Around the end of September they rounded us all up and started us on our death march, we were headed towards a village called Namwan about 35 miles towards Seoul from our position. We knew what it was; we knew we all wouldn't make it. While walking if someone fell to the side of the path because they were not strong enough to go on, they would shoot them where they lay" Louie says. They traveled by night and slept during the day, if they could sleep. He said that the enemy would come around and throw lit cigarettes on them and wake them up and ask "why you come Korea?" Then they would tell them, when they got to Seoul they could have beef steak and bread, they knew to say bread and beef steak in English taunting us Louie said. One man was so dehydrated Louie said that he just gave up and fell to the side. "We wanted him to live and so Sgt. Winters and I put one arm over our shoulders and helped him make it to the bottom."

Louis and the other ones were repatriated at the end of September. Out of the 108 men in K Company (Louis's company) only 9 of them made it back. Louie and the other POWs were sent back home via different hospitals, he had lost 63 pounds from July 27th to the end of September.

They are listed as the very first POWs of the Korean War. He and the others were assigned to Fort Benning in the training division for new recruits until their time was up in the service. Louie left the Army with Purple Heart, The National Defense Medal, the POW Medal, Korean Service Award, the United Nations Combat Award, The Korean Presidential Medal and Commendation.

Louis and his wife Mary Nelle live in the Elkins community and are active in many military organizations. Louis asks that all come and support the veterans on this day that is set aside solely for them.

#### TOM NICHOLS Grand Marshal for the 2012 Veterans Day Parade By Colonel Jim Stone



Thomas (Tom) Nichols, known as Brother Tom, twenty years ago had a vision. He wanted to do something to preserve the history and proud heritage of Cannon County. He wanted to honor the Veterans of Cannon County. Tom called me when we were living in Murfreesboro, and asked if I would come and meet with several men in the community to discuss what we could do to honor our Veterans.

I remember I asked what they did at

the present time to honor our Veterans. He said several good citizens got together on Veterans Day at the Courthouse, at 1100 oclock, the eleventh hour, the 11th day, the 11th month to read the names on the monument in front of the Courthouse. There were 59 names on that monument at that time. We discovered that one name had been left off and we fixed that. When Iraq came about we added another name, Frank B. Walkup, IV. We met at the Dillon Street Missionary Baptist Church. There were eight men present, Tom Nichols, Marvin Jennings, Aubry Nichols, A.W. Potter, Albert Thomas, Luther Mooneyham, Flovd Bogle, and myself.

The first year was a blessing, it was snowing and sleeting, as we tried to have our program on the steps of the Courthouse. It was so bad we had to move to the Cannon County High School Cafeteria. This was a blessing in disguise. God knew that we needed to be at the High School making our presentation to our children, so that they never forget the sacrificies and horrors of war. We declared the first year a success and vowed to continue and make the program and parade bigger and better each year. Now 20 years later we have done that. We have a great all day program at the High School and a tremendous parade to honor our Veterans

Of the original 8 members that started this wonderful adventure, only two are left, Tom Nichols and myself.

I am proud to be a part of a good thing for our community. And what I like most of this adventure is that it was started by a Non-Veteran, Tom Nichols, who had a dream and a vision, and we lived that dream and vision. We now have an organization, "The Veterans and Concerned Citizens for the Veterans of Cannon County. We have a Veterans Service Officer, Penny Daniels, who works deligently to help the Veterans of Cannon County. And in my 35 years of military service Penny is by far the best Veterans Service Officer I have ever known. And, as Brother Tom said, "Just look at all of the fun we have had over these 20 years". We also have a newly chartered American Legion Post 279 in Woodbury, with the distinct honor on having Bobby E. Ferrell, the Commander of our Post 279, which is only two years old, to be selected as the "Legionnaire of the year for the State of Tennessee, which has 189 Posts, and 30,000 Legionnaires, in the State. Thomas Earl (Tom) Nichols born February 18, 1932, on Doolittle in a small two room house across from the Doolittle Cave. The Nation was just coming out of the Great Depression. His father was William Richmond Nichols and his mother was Lucille Davenport Nichols. He had one sister, Nancy Ann, who passed away at age 3. He has two brothers W.R and Roy Nichols. Tom loved working on the farm. He started plowing in the fields on the Dillon Farm, which is where the hospital and all of the others businesses are located now. Tom said he loved working with his Dad. He said each of them had a team of mules. It was a lot of hard work and he loved every minute of it. When he was eleven years old, the U.S. Army conducted manuvers on the Dillon Farm. It was a very exciting time for Tom. He said that his Mama would cook

and give the soldiers hot food. The soldiers had a guard post in their yard, around the clock, so Tom got real close to the soldiers. Most of them were from New York, New Jersey, and California. The soldiers were here several days during the winter. They were with the 100th Infantry Division.

Tom said that it was a sad day when the soldiers left for war. He said he remembered crying when saying good bye to them. They had become like his brothers.

Later on Tom was drafted for the Korean War, but was turned down due to health problems. He was so disappointed and sad. He found out that instead of going in the infantry he could sign up for another branch of service. He chose the Marines, but was again disappointed because he did not pass his physical examination, and a lot of his friends left for war. Tom said that he had a lot of friends who were in World War II and never returned home.

Tom married Ruth Harmon in 1952. They were married for 53 wonderful years. Ruth passed away on November 5, 2005. They had a blessed life together. They had one daughter, Ruth Ann (Dennis) Watts and two grandchildren, Lee Ann and Daniel (Amber) and one great grandson, Levi, son of Daniel and Amber, who is already in Heaven.

Tom had many jobs working first at the shirt factory, then he went to Nashville and trained in concrete work. When things got slow he came back and worked in the box factory. Later on he went back to the concrete work and stayied with it for 33 years. Tom and his crew built many of the interstate bridges, some on the four lane highway to Woodbury. During all of of these years he also preached at the Millersburg Baptist Church and the Dillon Street Baptist Church. He had a radio broadcast, "Forward in Faith", for many years. He retired in March 1994 and began bee keeping. He said he did not know which is harder, bridge building or bee keeping. He enjoyed them both. Tom said that with God's help he was able to accomplish all of these things and he always put God first.

It is a great honor to have Tom Nichols as the Grand Marshal for our 2012 Veterans Day Parade. Tom did not serve in the military, because of medical problems, but Brother Tom served this County and the Veterans of Cannon County for twenty years. The citizens and veterans of Cannon County owe a great deal of gratitude to Tom Nichols. Because of Brother Tom's dream and vision the Veterans of Cannon County and American Legion Post 279 have put Woodbury and Cannon County on the map. God bless Brother Tom and the original eight men for their service to Cannon County, God bless our Veterans, and God bless this great county.

#### MARY NELLE HILLIS Concerned Citizen for the year 2012

This years' Concerned Citizen is Mary Nelle Ruhl Hillis.

Mary Nelle is 83 years old and admitted that she has volunteered most of her life. She is a retired federal employee with 30 years having worked at the Pentagon and at the Birmingham Ordinance Center in Alabama.

Mary Nelle, as she is known around here, used to roll bandages during WWII, and did many things to help the war effort and her country and she has worked at the auxiliary at the Stones River Hospital as long as her health was good. Mary Nelle has endured much during her long life; her father and family worked in the coal mines of northern Alabama. She married in 1947 to Paul Elkins. She met him in Alabama but he was born and raised in Woodbury Tennessee. Mary Nelle had to promise to move back to Tennessee after he retired. She had to "agree to that before he would go through with the marriage," said Mary Nelle as she laughed remembering the conversation. Paul was the uncle of Jerry Elkins who owns E&E Wholesale.

## Make food safety first during and after the hunt this fall

In Tennessee, hunting is a viable sport shared among generations as a family activity. This fall, many Tennessee hunters will make the trek to their favorite spot in hopes of bagging the best wildlife of their choosing. Bragging rights isn't the only thing hunters are looking for though, supplying food for their family is one reason hunters engage in this pastime. Making jerky is another activity that some hunting enthusiasts enjoy. After the hunt, it is important to remember food safety techniques for you and your family.

According to the National Center for Home Food Preservation, jerky is a lightweight, dried meat product that is a handy food for backpackers, campers and outdoor sports enthusiasts. It requires no refrigeration. Jerky can be made from almost any lean meat, including beef, pork, venison or smoked turkey breast. (Raw poultry is generally not recommended for use in making jerky because of the texture and flavor of the finished product.)

Raw meats can be with contaminated microorganisms that cause disease. These harmful bacteria can easily multiply of moist, high protein foods like meat and poultry and can cause illness if the products are not handled correctly. If pork or wild game is used to make jerky, the meat should be treated to kill the Trichinella parasite before it is sliced marinated. This and parasite causes the disease, trichinosis. To treat the meat, freeze a portion that is 6 inches or less thick at 5°F or below for at least 20 days. Freezing will not eliminate bacteria from the meat.

#### General Tips For Safe Food Handling

The following general tips for safe handling are based on USDA Meat and Poultry Hotline recommendations.

\* Always wash hands thoroughly with soap and best to avoid making jerky from this meat and use it only in ways that it will be thoroughly cooked.

Deer carcasses should be rapidly chilled to avoid bacterial growth. The risk of foodborne illness from home-dried jerky can be decreased by allowing the internal temperature of the meat to reach 160°F, but in such a way as to prevent case hardening. Two methods can be used: heating meat strips in marinade before drying or heating the dried jerky strips in an oven after the drying process is completed. Directions for both methods will be presented here. When the strips are heated in a marinade before drying, drying times will be reduced. Color and texture will differ from traditional jerky.

#### Preparing the Meat

Partially freeze meat to make slicing easier. The thickness of the meat strips will make a difference in the safety of the methods recommended in this article. Slice meat no thicker than 1/4-inch. Trim and discard all fat from meat because it becomes rancid quickly. If a chewy jerky is desired, slice with the grain. Slice across the grain if a tenderer, brittle jerky is preferred. A tenderizer can be used according to package directions, if desired. The meat can be marinated for flavor and tenderness. Marinade recipes may include oil, salt, spices and acid ingredients such as vinegar, lemon juice, teriyaki, or soy sauce or wine.

#### Jerky Marinade\*

<sup>1</sup>/<sub>4</sub> cup soy sauce 1 tablespoon Worcestershire sauce <sup>1</sup>/<sub>4</sub> teaspoon each of pepper and garlic powder <sup>1</sup>/<sub>2</sub> teaspoon onion powder 1 teaspoon hickory smokeflavored salt

\* (for 1½ to 2 pounds of lean meat (beef, pork or venison)

Combine all ingredients. Place strips of meat in a shallow pan and cover with marinade. Cover and refrigerate 1 to 2 hours or Products overnight. marinated for several hours may be more salty than some people prefer. If you choose to heat the meat prior to drying to decrease the risk of foodborne illness, do so at the end of the marinating time. To heat, bring the strips and marinade to a boil and boil 5 minutes before draining and drying. If strips are more than 1/4 inch thick, the length of time may need to be increased. If possible, check the temperature of several strips with a metal stem-type thermometer to

Place the slices close together, but not touching or overlapping.

Place the racks in a dehydrator or oven preheated to 140°F Dry until a test piece cracks but does not break when it is bent (10 to 24 hours for samples not heated in marinade). Samples heated in marinade will dry faster. Begin checking samples

after 3 hours. Once drying is completed, pat off any beads of oil with clean, absorbent towels and cool. Remove strips from the racks. Cool. Package in glass jars or heavy plastic food storage bags.

If the strips were not heated in marinade prior to drying, they can be heated in an oven after drying as an added safety measure. Place strips on a baking sheet, close together, but not touching or overlapping. For strips originally cut 1/4 inch thick or less, heat 10 minutes in an oven preheated to 275°F. (Thicker strips may require longer heating to reach 160°F.)

#### Making Jerky From Ground Meat

Jerky can be made from ground meat using special presses to form or shape the product. Diseasecausing microorganisms are more difficult to eliminate in ground meat than in whole meat strips. If ground meat is used, follow the general tips for safe handling tips listed previously. Be sure to follow the dehydrator manufacturer's directions carefully when heating the product at the end of drying time. Again, an internal temperature of 160°F is necessary to eliminate disease-causing bacteria such as E. coli O157:H7, if present.

#### Storing the Jerky

Properly dried jerky will keep at room temperature 2 weeks in a sealed container. For best results, to increase shelf life and maintain best flavor and quality, refrigerate or freeze jerky.

\* Thaw frozen meat in the refrigerator, not on the kitchen counter.

\* Marinate meat in the refrigerator. Do not save and re-use marinade.

When preparing jerky from wild game, it is important to remember that the wound location and skill of the hunter can affect the safety or the meat. If the animal is wounded in such a way that the contents of its gut come in contact with the meat or the hunter's hands while dressing the meat, bacteria fecal can contaminate the meat. It is

#### Mrs. Lincoln (Sally Field) downsizes in L.A.

*Dear Ken: What has Sally Field done lately?* Double Oscar-winner ("Norma Rae," "Places in the Heart") Field, who turns 66 on Nov. 6, co-stars as Mary Todd Lincoln in Steven Spielberg's new film "Lincoln," which opens within two weeks. (Daniel Day-Lewis portrays Lincoln.) Field played Aunt May earlier this year in "The Amazing Spider-Man" and was the voice of Marina Del Rey in 2008's "The Little Mermaid: Ariel's Beginning." Dear Ken: Our family was sad to hear of the death of crooner Andy Williams? What years did his TV show run? Williams, who died Sept. 25 of bladder cancer at age 84 in Branson, Mo., sang and laughed his way into the homes of America from 1962 to1967 and from 1969 to 1971 on NBC with his "Andy Williams Show." And he kept coming back for decades with his trademark sweaters in those annual Christmas specials. His giant holiday hit, "It's the Most Wonderful Time of the Year," was written by Edward Pola and George Wyle for his TV show in 1963. "The show I always enjoyed doing above all others was the Christmas show, and it was the one that the audiences loved the most, too," Williams noted in his 2009 autobiography, "Moon River and Me." "It always had the highest ratings of the entire season. To this day people stop me on the street and tell me how much they cherished the Christmas shows and how much it meant to their whole family." The singer recorded five holiday albums: "The Andy Williams Christmas Album," "Merry Christmas," "I Still Believe in Santa Claus," "Christmas Present" and "We Need a Little Christmas.'

#### Dear Ken: What can you tell me about the girl who plays Destiny in the movie "Butter"?

That is Yara Shahidi, 12, who was born in Minneapolis, Minn., to an Iranian father and an African-American mother. After moving to California, she worked in a bunch of commercials and then made her film debut opposite Eddie Murphy in 2009's "Imagine That." Her other films include "Salt," "Unthinkable" and "Rip City," and she has appeared in the TV shows "In the Motherhood," "Cold Case," "Wizards of Waverly Place" and "Lie to Me.'

Jones, 81, a native of Decatur, Ala., starred in "That Darn Cat!"
