Wheel tax OK'd on 2nd vote Taxpayers get final say on March 1

Cannon County Commissioners passed on second reading a resolution calling for an one cent sales tax hike.

"You have voted on this already," County Executive Mike Gannon told the commissioners during the brief meeting. "One-half goes to the school system and one-half goes to the county general budget."

Cannon County voters have the final say on the sales tax hike during the March 1 presidential primary election.

Cannon County's sales tax currently stands at 1.75 cents. The increase would put the tax at 2.75. Surrounding counties of Rutherford, Warren and DeKalb already have the 2.75 rate. "It won't bring in a lot of money, but it does help

spread the cost across all of the public," Gannon said. Generally, Cannon

County government is financed by property taxes.

"For your information, the sales tax brought in 77,343 last year," said Budget Chairman Mark Barker. "I move that we adopt this."

Commissioner Jim Bush seconded the motion which passed 7-2 during a voice vote. Voting "no" were Commissioners Russell Reed and Brent Bush. Commissioner Todd Hollandsworth was absent.

Voting "yes" were Commissioners Barker, Karen See WHEEL Page 9

"This morning I received a phone call from the IRS stating that I owe them money. I know this was a fraud phone call cause I do not owe anything to the IRS," an Auburntown resident told the Courier.

"I have read articles on these types of phone calls and people being scammed out of a lot of money, I have been in the banking business for my whole working career and its amazing what you see," she said.

Conclusion: Forrest didn't 'found' Ku Klux Klan

Fact: America's original Ku Klux Klan started in Pulaski, Tenn., shortly after the conclusion of the War Between the States.

Fact: Six Confederate Army veterans founded the KKK, but Forrest was not among them.

Fact: It is important that present-day researchers know Pulaski Citizen newspaper editor Frank O. McCord, brother to Citizen Publisher Luther W. McCord, was one of the founders.

Research indicates the McCord brothers evolved into publicists for the KKK, and helped spread the word, mainly in the South, while claiming publicly and privately to have no knowledge of the Klan's existence. Other founders were Pulaski citizens Richard R. Reed, John B. Kennedy, John C. Lester, Calvin Jones and James. R. Crowe.

Fact: In 1869, approximately two years after the KKK was started, Forrest ordered the group disbanded. This came after Forrest was installed, in absentia, as the KKK's Grand Dragon. It has never been documented Forrest ever attended a raid, or wore regalia of the KKK.

Rutherford County Historian Gregory Tucker shared research about this: "There is no evidence that Forrest ever wore any Klan costume or ever 'rode' on any Klan activity. He did, however, on Oct. 20, 1869, order that all costumes and other regalia be destroyed and that Klan activity be ended.

"This was confirmed by the U.S. Congress in 1871. The natural tendency of all such organizations is to violence and crime, hence it was that General Forrest and other men of influence by the exercise of their moral power, induced them to disband." (See U.S. Congressional Committee Report of June 27, 1871).

The assignment came after recent public debate started at Middle Tennessee State University whether to remove Gen. Forrest's name from MT-SU's ROTC building.)







Don't you think - "Black-Smith Mule Museum" - has a nice "ping" to it?

Excuse me while I lay my mulishlooking lop ears back and shout from Short Mountain ... the time for a mule/ walking horse museum in Woodbury is at hand!

If indeed community leaders decide to establish a museum, what better name than "Black-Smith Mule Museum," named after Middle Tennessee Mule Skinners' Association founders Buddy Black and the late Bill Smith?

I can hear the "pings" in my soul as blacksmith Jimmy Simpson's heavy hammer slams against a big anvil in forming a hot new pair of mule shoes during an on-site demonstration. Simpson is also a certified bona fide and sanctioned in good standing card-carrying Mule Skinner. Lifelong mule

enthusiast Bill Smith's recent death, at age 97, can serve as a beacon of encouragement for a museum honoring those animals and the ancestors who labored to make our community what it is today, before the advent of mechanized power.

As a founding member of the Woodbury-based

Mule Skinners that has members throughout Middle Tennessee, Mr. Bill was one of the first vocal local advocates for a mule museum.

A possible location is the historic Old Cannon County Jail on Woodbury's pristine Courthouse Square. A museum there could make the old jail even more historically significant.

Mr. Bill's respect for mules dates back to his own childhood, when his father, George Stanton Smith, taught him how to drive a team of mules through a field.

"I was big for my age, but Dad waited to when I was up around 10 or 11, before he'd trust me with a team of big and strong mules," Mr. Bill plowed back in time.

Mr. Bill described how mules impacted society's development in the Cumberland Foothills' region.

"Those trees that were logged to clear land for our ancestors' homes and farms, mules provided the power," Mr. Bill bragged as he penned his own ears back on behalf of mules. "That first nice new modern paved road that linked Woodbury and Murfreesboro up to Nashville to the east, and points east up in the mountains, mules did the heavy work." How big did Mr. Bill become in his lifetime advocacy for mules. "Upon seeing Bill Smith handle and direct multi-teams of powerful mules through a field, he reminded me of 'Paul Bunyon," eulogized Col. Jim Stone recently in the Cannon Courier about the banking legend's stature.

Now, how about the "Black" part of the proposed "Black-Smith Mule Museum name?

Who better than former Cannon County Chief Deputy Sheriff Buddy Black to serve as the co-namesake of a mule museum?

Mr. Buddy is perhaps the current "best known" mule man from Cannon County, having served a record 34 consecutive years as the Grand Marshal at Columbia's famous Mule Days' Parade. "Buddy Black is among

some of the most famous Tennesseans recognized at Columbia Mule Days," confirmed Mule Skinner Fraley.

Fraley also contends mules are smarter than horses.

"And they're sensitive," Fraley brayed on a mule Leroy and Lucky's behalf.

Back in boyhood hometown Canalou, Mo., in the annals of local law enforcement, there is a case listed of a "mule suicide."

In 1945, the small farm town was served twice a day by mail trains.

High mule-related drama began building the day that a mule named "Jack" parked himself on the railroad tracks and would not budge.

"Jack belonged to my grandfather," confirmed former farm town neighbor Les Landers. "The incident happened after Jack's long-term plow-pulling mate named Murt died of old age.

"A few days after Murt fell dead, lonesome Jack, who was getting up in years too, walked out of the barn, and into town where he gathered an

Cannon County citizens who had been taken prisoner by Federal occupation troops in Murfreesboro. Those citizens were scheduled to be executed the following day. Forrest swept in, liberated them and returned them to their families.

We're not sure how many Cannon County citizens were saved by Forrest and his cavalry, but men like James Calvin Carnahan went home to their families. A photo of Carnahan and his descendants was included during the 2015 "Portraits of Cannon County" exhibit at the Arts Center of Cannon County.

This raid from Woodbury to Murfreesboro resulted in a promotion for Forrest.

Later Forrest became enmeshed in controversy first in the Battle of Fort Pillow and then in the rise of the Klu Klux Klan after the Civil War, but that does not diminish his actions in Woodbury or Murfreesboro.

Forrest was brought back into the news by the Charleston church shooting on June 17, 2015.

During a prayer service at **Emanuel African Methodist** Episcopal Church, 21-year Dylann Roof killed nine people. Roof told authorities he committed the shooting in hopes of starting a race war.

In the investigation that followed,

battle flags along with symbols associated

with white supremacy. That triggered a push to do away with anything associated with the Confederacy, which in turn, included just about anything to do with Nathan Bedford Forrest.

So, after 150 years, Forrest is again "news." That development prompted efforts by some (chiefly politicians) to eradicate anything about the losing side of the Civil War.

In Memphis, this eradication of history reached a fever pitch with city council members wanting to dig up the remains of Forrest and his wife and move them to anyplace other than Memphis.

And so on ..

All of this turmoil has conflicted with the 150th anniversary of the

Civil War. Important lessons from the past have been pushed aside in an attempt to avoid controversy.

And while we aren't immune from controversy, the Cannon Courier has continue to print articles about the Civil War in Middle Tennessee.

I'm glad to report there's been considerable interest in the "news" from 150 years ago.

All networking sites have at least some minimal standards of identity verification. But all too often these checks and balances have broken down, and ordinary folks, not to mention criminals, have assumed the identities of politicians, sports figures and entertainment



Buried historical facts: Grace Stephens the 'Sacrificial Lamb'

Yearly, America honors "Martin Luther King Jr. Day," an American federal holiday marking the birthday of Martin Luther King Jr., born January 15, 1929. (NOTE: The holiday is held the third Monday of each January, which correlates with King's birth date of January 15.)

With Martin Luther King Jr. Day just around the corner, January 18, 2016, there exist some "buried facts" that certain powers would rather remain hidden in the grave. However, preferring historical correctness over political correctness, I have opted to resurrect these facts.

First, here's a brief overview to ensure all readers are on board:

A black, Baptist minister from Atlanta, Georgia, Reverend Martin Luther King Jr. (MLK), arguably, was the most influential civil rights leader in history. A crowning moment came August 28, 1963, at the Lincoln Memorial in Washington, D.C., when MLK gave his timeless "I Have a Dream" speech in front of some 250,000


found out authorities were offering a \$100,000 reward for information leading to the capture of MLK's killer

Still, Charlie Stephens' flip-flop statement identifying Ray as the man coming out of the restroom was the primary reason British authorities were considering allowing Ray to be extradited from England back to Memphis.

However, the whole time, Grace Stephens was refuting her husband's statement, putting the state-prosecution in a bind regarding their "star witness." Stated Grace to Attorney Mark Lane, who represented James Earl Ray: "Charlie didn't see anything. He couldn't have. He was on the bed trying to sleep one off" (reference: book "Murder in Memphis," authors: Mark Lane and Dick Gregory).

Bolstering Grace Stephens' claim is former Memphis Police Captain Tommy Smith. Smith, canvassing the murder scene, attempted to interview Charlie Stephens only minutes after MLK was shot, and Smith testified: "He [Stephens] was too intoxicated to carry on an intelligent conversation." However, Memphis authorities placed Charles Stephens in protective custody, so valuable was Stephens' ID – and extradition – of Ray!

listeners. This would become known as the "Poor People's March."

Having elevated several tiers as a civil rights force, MLK was planning a second Poor People's March, to take place late April 1968. There were logical guesstimates that 750,000 - 1,000,000 would participate in this second march, which worried many governmental sources.

April 4, 1968, MLK was in Memphis, Tennessee, to lead a march for the city's striking sanitation workers, the majority black. At approximately 6 p.m., standing in front of room 306 of the Lorraine Hotel & Motel, MLK was fatally struck by a single sniper's bullet.

June 8, 1968, James Earl Ray, a white, 39-year-old career criminal, and fugitive from justice, was arrested at London's Heathrow Airport and charged with MLK's murder. March 10, 1969, Ray entered a guilty plea and received a 99-year sentence. Ray succumbed to liver disease, April 23, 1998, going to his grave claiming he didn't shoot MLK.

The prosecution's story: Ray rented room 5B of Bessie Brewer's flophouse and shot MLK from the commonly-shared restroom of Bessie Brewer's.

James Earl Ray's story: He did rent room 5B from Bessie Brewer but did not shoot MLK.

Enter one Grace Stephens:

Grace Stephens and her commonlaw husband Charlie Stephens occupied room 6B of Bessie Brewer's flophouse. Charlie Stephens was a well-known drunk. When Charlie was first shown a photo of Ray, Stephens said the man in the photo was not the man he saw running from the commonly-shared restroom after MLK was shot. Later, though, Charlie changed his story when he

FACT: Early July 1968, after James Earl Ray had been arrested, but not yet extradited, Grace Stephens went to a Memphis hospital for a routine check-up. She ended being forcibly placed in the hospital's psychiatric ward.


FACT: July 19, 1968, Ray was extradited from England to Memphis.

FACT: Late July 1968, a Memphis judge had Grace committed to Western State Mental Hospital in Bolivar, Tennessee. At this point, Ray was going to trial, and Charlie Stephens was a potential witness, with Grace adamantly rebutting Charlie's story. As an attorney explained to me, "Once you've been declared mentally ill, your testimony is worthless."

FACT: Grace Stephens remained a patient in Memphis-area mental facilities for approximately ten years, until Attorney Mark Lane took over as James Earl Ray's lead defense counsel. Though her last name had been changed, her records altered, Lane, with the help of Memphis clergymen, secured her release.

FACT: Jerry Ray, brother of James Earl Ray, spoke with Grace Stephens, and Grace told Jerry: "They [authorities] put me away for all those years just because I wouldn't lie for them."

Was Grace Stephens a "sacrificial lamb"?

W.B. Romine, who authored this version of history, attempted to describe the group's original intent: "The Ku Klux Klan which was organized following the War Between the States, was not organized for the purpose, as some have believed, of oppressing and punishing the negroes who had recently been freed, and were as yet unaccustomed to their new circumstances and conditions of life, and was 'children crying in the night, children crying for the light and with no language but to cry."


That historic booklet remains available today at the Pulaski Citizen newspaper.

The most publicized date for the KKK's founding, was Christmas Eve, 1865, which metered out to the present, would have made the original KKK 150 years old, this past Christmas Eve, 2015. However, that founding date has been questioned by more than one researcher.

A present-day historian noted by 1871, "thugs" from various Southern communities had started committing terrorist acts, primarily against newly-freed slaves and the appointed government regulators of Reconstruction.

How did the group spread, and did that trigger the change in course of the KKK into a brutal racist organization, partly justified because of the Republican Party's confirmed brutal Reconstruction tactics in the South?

Three years after being founded in Pulaski, why was controversial Forrest called in to ultimately disband the secret KKK?



SECTION 2: If a majority of those voting in the election required by Tennessee Code Annotated, Section 67-6-706, vote for the increase in the tax imposed by this resolution, collection of the increased tax levied by this resolution shall begin on the first day of the month occurring thirty (30) or more days after the county election commission makes its official canvass of the election returns.

SECTION 3: The Department of Revenue of the State of Tennessee shall collect the additional tax imposed by this Resolution concurrent with the collection of the state tax and the local tax now being collected for Cannon County, in accordance with rules and regulations promulgated by the Department. on my caller ID. So I called and a gentlemen answered with a very heavy foreign ancient I asked him his name and he stated John Edwards. I told him that I know that this is a fraud call and I told him I will call my local sheriffs office and I did," she said.

"The dispatcher said that she has had a few of these calls. I would like for you to let the public know that this is going on in our area." The IRS said this is part of an aggressive and sophisticated phone scam targeting taxpayers.

Callers claim to be employees of the IRS, but are not. These con artists can sound convincing when they call. They use fake names and bogus IRS identification badge numbers. They may know a lot about their targets, and they usually alter the caller ID to make it look like the IRS is calling.

Victims are told they owe money to the IRS and it must be paid promptly through a pre-loaded debit card or wire transfer. If the victim refuses to cooperate, they are then threatened with arrest, deportation or suspension of a business or driver's license. In many cases, the caller becomes hostile and insulting.

Or, victims may be told they have a refund due to try to trick them into sharing private information.

If the phone isn't answered, the scammers often leave an "urgent" callback request.

Note that the IRS will never: 1) call to demand

immediate payment, nor will the agency call about taxes owed without first having mailed you a bill; 2) demand that you pay taxes without giving you the opportunity to question or appeal the amount they say you owe; 3) require you to use a specific payment method for your taxes, such as a prepaid debit card; 4) ask for credit or debit card numbers over the phone; or 5) threaten to bring in local police or other law-enforcement groups to have you arrested for not paying.

The Better Business Bureau of Middle Tennessee also offers the following tips to avoid becoming a victim of the IRS phone scam:BBB offers the following tips to avoid becoming a victim of the IRS phone scam:

Beware of any caller claiming to be with the IRS and demanding money.

If you owe federal taxes, or think you might owe taxes, call the IRS directly at 800-829-1040. IRS representatives can help you with your payment questions.

If you don't owe taxes, call and report the incident to BBB and to the Treasury Inspector General for Tax Administration at 800-366-4484.

You can also file a complaint with the Federal Trade Commission at FTC. gov. Add "IRS Telephone Scam" to the comments in your complaint.

Never trust callers who use threats and hostility to bully their targets into doing what they want. This is a scare tactic many scammers use.



Music, special programs, and children's activities

will be ongoing throughout each day. The American Eagle Foundation will be present for its alwayspopular live raptor show each day with times at 2 p.m. on Saturday and 1 p.m. on Sunday. There will be a new presentation this year, "Birding Makes Cents (and Dollars): The Economic Impact of Birding and Bird Festivals which will be held Jan. 16 at 1 p.m.

An official welcome and live music will start the programs each day at 11 a.m. TWRA Information and Education Division Chief Don King, also a Nashville recording artist and friends will perform each day. Traditional heritage music led by Tom Morgan, Lynn Haas with friends will also perform in the morning and afternoon and will include a special children's music appreciation program each morning.

The group, South Wind, will perform from noon until 12:45 on Saturday.

The nearby Cherokee Removal Memorial will feature Native American folklore specialists. They will present performances,

artifacts and objects used in everyday life by Native American inhabitants in the Hiwassee River area.

Along with the wildlife viewing at the refuge, wildlife and birding experts will be on hand. They will provide visitors with a unique educational experience by sharing viewing scopes and information.

New Years always called for hogs jowl, black eye peas, turnip greens, hominy and corn bread for as long as I can remember. I always thought it was for, Health, Wealth, Happiness and Luck.

When I first got married these would always be part of my New Years meal and I normally would do the cooking. As best than I can remember I only missed this two times in my 67 years, 1970 when I was in Vietnam and the other time when my family attended the Rose Bowl Parade.

greens the cheapest vegetables to buy. Others say eating fat of the New Year will have you eating fat for the year. Pork in many countries is for wealth for the coming year. Countries using hogs jowl, Southern United States. Countries eating pork: Germany, France, Norway, Holland and the United States.

Cabbage with Pork: Green Leafy vegetable mostly used as paper money, for wealth, prosperity and also for health for the coming year. Germany, United States, Sweden.

Sauerkraut and Kielbasa: Pork sausage is a symbol of abundance because they are rich in fat and cabbage for wealth and prosperity. Germany and Northern United States.

Noodles: Long noodles that should be sucked up and eaten without breaking them to ensure long life. Most Asian countries will eat some form of noodles on their New Year. In Italy Lasagna is the custom and eating any other type noodle is concerned bad luck.

Meatballs: Pork and round shape is symbol for becoming a full-circle completing year's cycle from new to finished with prosperity.

Grapes: Normally eaten at Midnight when the clock strikes, 1 grape at each strike of the clock for luck for each month of the upcoming year. Spain, Portugal, Peru and Cuba this is a custom. Spain then eats one additional grape for the past year.

New Years Day Menu 2016 (at the Hirlston's)

Hoppin' John with Cornbread: Contains pork for wealth, black eye peas for coins &/or luck, collard greens for cash, tomatoes for health, rice for prosperity, hominy for becoming full circle and the cornbread for gold. Countries using pork for wealth: Germany, northern United States. Countries known for eating Hoppin' John or something similar for luck: Africa, France, Southern United States, and Brazil (has a Lentil Soup similar to Hoppin' John). Italy, and Jewish customs also uses lentils (black eye peas) for coins, for wealth and luck.

Hogs Jowl: Eat poor on New Year's, eat fat the rest of the year. Hogs Jowl is considered the cheapest part of a pig, the cheapest meat. Black eye peas and collard

Apples wedges and honey: This is a Jewish custom; the honey is a symbol of sweetness of life.

Vasilopita: A special cake with a coin hidden inside. Whoever gets the coin will have luck and prosperity for the coming year. Greek custom. Coin hidden in bread (cornbread) or in other foods has been adopted in other customs.

Rice Pudding: Rice is another food that if eaten on the New Year, there will always be food for the rest of the year. This is a custom in most Asian countries. Most will eat a bowl of rice, or a rice cake, or the rice pudding. In Norway an almond is hidden in the pudding and whoever gets the almond will have luck for the year.

Olie Bollen: The round shape is a symbol for becoming a full-circle completing a year's cycle, from a new to finish and for prosperity for the coming year. Celebrated in Holland. Name means "oily ball" and looks and taste close to a doughnut hole.

Sparkling Grape Juice or Champagne is the universal New Year Good Luck Charm, used for toasting in the New Year. We substitute Champagne for Sparkling Grape Juice for our own beliefs and not to infringe on others but we ask each to make a toast.

Mercedes caught doing 126 MPH in Auburntown

Speeding at 126 mph

Cannon County Sheriff's Office personnel, participating in a statewide holiday DUI enforcement campaign, snagged an apparently deaf Knoxville motorist on felony speeding charges.

Investigator Chris Brown, was monitoring traffic on Highway 96 in Auburntown, when he clocked a four-door Mercedes at 72 mph in a 55 mph speed zone.

"As I was gaining speed I observed that the white Mercedes was gaining speed. Knowing my vehicle would not be able to catch the suspect, I advised Investigator Gullett, who was on the west end of Poplar Bluff, to see if he could get the car stopped," Brown said.

Gullett clocked the Mercedes at 126 mph.

"As we were approaching the bottom of Milton Hill, the Mercedes was already out of sight over the hill," Brown said, adding he witnessed the car pass three vehicles at a high rate of speed.

The Cannon County officers broke off highpursuit, speed but continued to follow the Mercedes into Rutherford County, while notifying

authorities there. Rutherford County officers blocked the car in at Farmington Road, just before Jefferson Pike on Highway 96.

"I then went to their location and verified this was the vehicle we were looking for. The driver was Jason Andrew Collins of Knoxville. He was deaf and was having trouble communication, so communication was handled through texting on his phone as well as writing on paper," Brown said.

Collins was placed under arrest and returned to Woodbury. His car was impounded then seized due to felony evading laws. He was additionally charged with speeding 126 mph in a 55 zone, wreckless driving and reckless endangerment.






His mother said to the servants, "Do whatever he tells you." (John 2:3-5, NIV)

Paying Income Tax on Social Security Benefits Dear Savvy Senior,

Will I have to pay federal income taxes on my Social Security benefits when I retire?

5

Approaching Retirement

Dear Approaching,

Whether or not you'll be required to pay federal income tax on your Social Security benefits will depend on your income and filing status. About 35 percent of Social Security recipients have total incomes high enough to trigger federal income tax on their benefits.

To figure out if your benefits will be taxable, you'll need to add up all of your "provisional income," which includes wages, taxable and non-taxable interest, dividends, pensions and taxable retirement-plan distributions, self-employment, and other taxable income, plus half your annual Social Security benefits, minus certain deductions used in figuring your adjusted gross income.

How To Calculate

To help you with the calculations, get a copy of IRS Publication 915 "Social Security and Equivalent Railroad Retirement Benefits," which provides detailed instructions and worksheets. You can download it at irs.gov/pub/irs-pdf/p915.pdf or call the IRS at 800-829-3676 and ask them to mail you a free copy.

After you do the calculations, the IRS says that if you're single and your total income from all of the listed sources is:

Less that \$25,000, your Social Security will not be subject to federal income tax.

Between \$25,000 and \$34,000, up to 50 percent of your Social Security benefits will be taxed at your regular income-tax rate.

More than \$34,000, up to 85 percent of your benefits will be taxed.

If you're married and filing jointly and the total from all sources is:

Less that \$32,000, your Social Security won't be taxed.

Between \$32,000 and \$44,000, up to 50 percent of your Social Security benefits will be taxed.

More than \$44,000, up to 85 percent of your benefits will be taxed.

If you're married and file a separate return, you probably will pay taxes on your benefits.

To limit potential taxes on your benefits, you'll need to be cautious when taking distributions from retirement accounts or other sources. In addition to triggering ordinary income tax, a distribution that significantly raises your gross income can bump the proportion of your Social Security benefits subject to taxes.


How to File


If you find that part of your Social Security benefits will be taxable, you'll need to file using Form 1040 or Form 1040A. You cannot use Form 1040EZ. You also need to know that if you do owe taxes, you'll need to make quarterly estimated tax payments to the IRS or you can choose to have it automatically withheld from your benefits.


To have it withheld, you'll need to complete IRS Form W-4V, Voluntary Withholding Request (irs.gov/pub/irs-pdf/fw4v.pdf), and file it with your local Social Security office. You can choose to have 7 percent, 10 percent, 15 percent or 25 percent of your total benefit payment withheld. If you subsequently decide you don't want the taxes withheld, you can file another W-4V to stop the withholding.
