Early voting approaches record

Early voting in the Cannon County General Election is proceeding at a record pace, election officials say.

As of last Thursday, (July 24) 828 ballots had been cast outpacing 2010 totals in a similar general election. The State Election



Commission has compiled a running total of votes cast thus far. For the first four

days of early voting, Cannon County had cast 550 ballots compared to 467 in 2010.

"We've been pleased with the early turn-out thus far," said Dorinda Mankin, administrator of elections, "and hope it continues."

The Cannon County Election Commission is keeping a running table on early voting results. To see the

In other election-related news, the Rutherford and Cannon County Bar Association (RCCBA) released the results of a member poll for the Rutherford and Cannon County August 7, 2014 General Election.

Copters aid major drug bust

A Hurricane Creek Road resident faces manufacture of marijuana and several other drug-related charges following a bust by the Cannon County Sheriff's Department.

William Ray Hale was also charged with possession of marijuana, possession of drug paraphernalia and maintaining a dwelling for the use, storage, or sale of controlled substances. A total of 67 pot plants and about 15 to 20 pounds of processed marijuana were confiscated.

Hale "said he had been growing marijuana four years and that he had been caught three times over the years," said Investigator Brandon Gullett.

"I was then advised by William Ray Hale in the booking room of the Cannon County Jail that he would have more plants growing in three weeks and that he would have more seeds in the mail by dark," Gullett said.

The arrest followed an anonymous call to Gullett, who notified the helicopter-equipped See COPTER on Page 9

Carpentry teacher hangs up his hammer

The man who pioneered the carpentry program at Cannon County High School is stepping down after eight years leading the course.

Ed Coates has resigned his position at the high school to dedicate more time to his private business, Coates Quality Construction (CQC); however, the decision didn't come easily.

"I have enjoyed the opportunity to serve the students and families of Cannon County at Cannon County High School," Coates said. "I consider it a privilege. I'm turning 50 and I looked at this as, 'What am I going to be doing for the next 12 years? Can I give 100 percent to our students?' My son wants to go in

business with me so I just reached a point in life where you have to decide which direction to take. It was a tough decision."

Coates started the carpentry program at Cannon County High School in 2006 and in his eight years developed young men and women who have excelled at the trade. Coates got his start in carpentry through an apprenticeship with Detroit Carpenters.

"I knew I had the experience and the background so I thought I could be an asset to the students in that way," Coates said.

Seeing students learn and grasp the trade was Coates' primary satisfaction. In fact, the carpentry shop at CCHS was primarily built by students.

"Students did 85 percent of the building on that shop," Coates said. "Even today when students come in and I tell them it was stu-

dents who built this, some may have no experience and think all of this is beyond their grasp, and then they start believing.

"When I got here we were working in that portable. It is not a very good working environment as far as teaching a skill. I knew we needed a new facility to teach and train. The building was huge for our program but seeing the pride of workmanship as the building went up was major for the students. They were the biggest part of that construction and it gave them a sense of pride."

Coates' students have built mini barns and picnic tables that have been sold in the community. The profits from those buildings go into the carpentry program and fund other projects. Students in the class also have performed concrete repair throughout campus See CARPENTRY on Page 9

Adore wonder works at Appalachian Center

A half-day excursion into the heart of rural Middle Tennessee not only offers the scenic beauty of the state's forests, farms, fields, hills, rivers and lakes, but also, in the case of the Appalachian Center for Craft, presents some remarkably handsome handiwork made by the region's professional craft artists.

Located several miles east of Smithville, the center offers world-class exhibitions of functional and sculptural fine craft throughout the year, and its retail craft gallery proves an ideal shop wherein to find unique items perfect as gifts or to brighten the décor of your home or add a perk to your wardrobe.

Nashvillian Jesse Mayo has made about 20 excursions to the center over the years, noting, "Every time I drive by on the interstate I try to stop, and I always

buy something. It's hard to resist. "The artists' works are placed where you can see all the different media types. Here you can buy something handmade for \$8 compared to something for \$5 ma-

chine made. Wouldn't you rather receive something like this," he asks as he holds up a greeting card created by a local artist. "This is so much more special." The Appalachian Center for



Craft Center sits on a 500-acre wooded peninsula surrounded by Center Hill Lake near Hurricane Bridge. A satellite campus of Tennessee Tech University, the creative "factory" features spacious studios, a library, administrative offices, student housing and meeting/audio visual rooms, while for day trippers the main

points of interest will be the its fine craft gallery, three exhibition galleries, a café and several hiking trails.

To top it off, the center is open 9 a.m. to 5 p.m. daily, and admission is free.

The craft gallery features the work of about 100 artists from the Appalachian region. Across the seasons visitors from Maine to Montana and from California to Florida drop by to be astonished at the amazing variety of items that includes jewelry, ceramics, quilts, paintings, photography, blown and forged glass and fiber wool wearables such as scarves, blouses, skirts and cardigans. Also on sale are creations made by blacksmiths and woodworkers.

"All the work here is handmade. It exposes people to an array of fine crafts that you can't see in other venues," said gallery manager Jenn Cole. "You're going to See ADORE on Page 9

THP to accept applications for new Troopers

The Tennessee Highway Patrol (THP) announced today it will soon open the application process for a new trooper cadet class slated to begin February 1, 2015.

Applications will be

accepted online only from Wednesday, July 30 through Tuesday, August 5, 2014.

All applicants must apply online through the Tennessee Department of Human Resources at agency.governmentjobs.com/tennessee beginning Wednesday, July 30. Applications will not be accepted after August 5. Once approved by the Department of Human Resources, applicants will be notified of their qualification status. There is no longer an examination portion to qualify for the State Trooper position.

Individuals interested in applying for the position of

state trooper must be at least 21 years old, a U.S. citizen, and have a high school diploma or equivalent. Two years of college or military or previous law enforcement experience is preferred. Applicants with felony convictions will not be considered.

Following the passage of the Tennessee Excellence, Accountability and Management (TEAM) Act, the hiring method for becoming a state trooper has been revised to incorporate an interview process that tests the applicant's knowledge, skills, abilities and competencies. As a result,

selected applicants will be required to successfully pass the physical agility test prior to being admitted for an interview. THP anticipates the agility test and interview appointments to begin September 3, 2014.

If hired, individuals must obtain a valid Tennessee driver license and are required to successfully complete a level II background investigation, which includes a credit check and polygraph test. Recruits must also pass a psychological and medical examination, including a drug screening.

There are currently 884 authorized commissioned

officer positions within the THP. Trooper recruits will be assigned to vacant positions across the state upon graduation. The starting salary for a cadet during training is \$2,679 per month. Upon graduation and commissioning as a Tennessee state trooper, the salary will increase to \$2,965 per month and includes other benefits such as a paid pension plan, low cost health insurance, and paid holidays. Uniforms, equipment and patrol vehicles are also provided by the THP. With regular pay increases, a trooper can earn \$52,872 per year after 10 years of service under the current pay structure. Trooper cadet training will last 20 weeks.

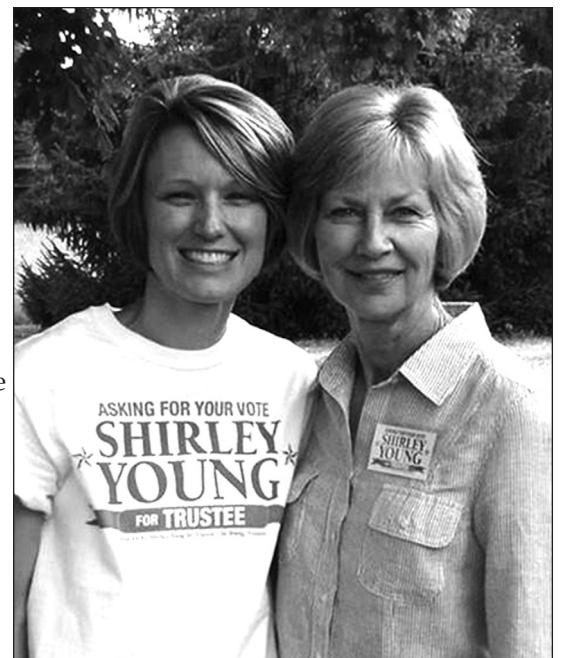

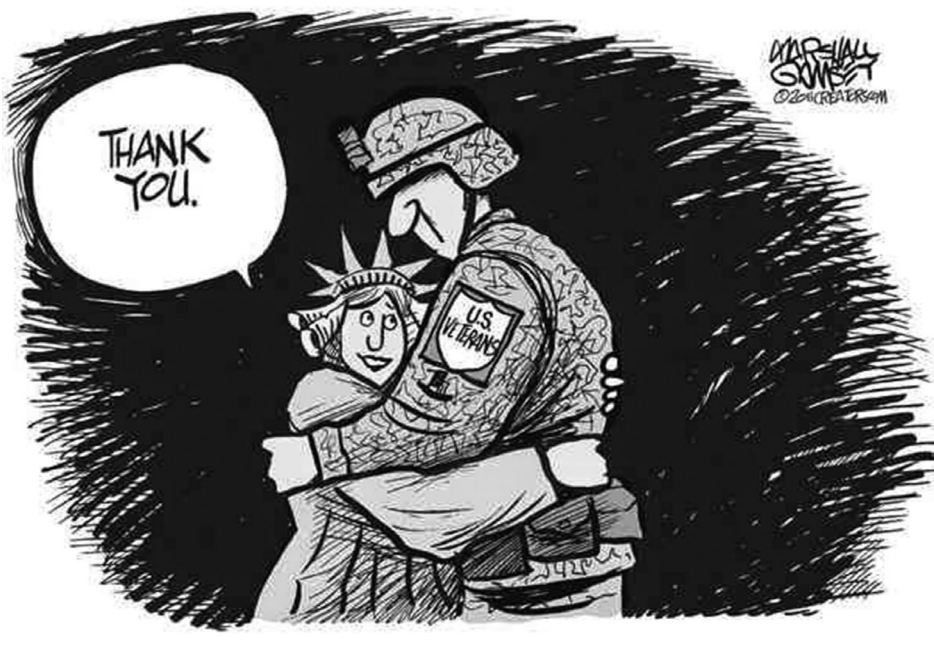

Courier Columnist Cemetery series proved Boss Ron is 'always right'

I didn't like newspaper publisher Ron Fryar's assignment. I recall thinking: "How boring this is going to be ... both to our readers, and to me, the writer."

The assignment came via email: "Whittle, I need you to do a series of stories about historic cemeteries in Cannon County."

Another initial thought popped in my now feverish, intensely-aggravated mind: "Damn, this is going to be one labor-intensive assignment ... taking lots of research and time, not to mention tiring treks in the hot summertime through countless cemeteries, some of which will be over-run with weeds and chiggers that relish invading my trousers."

In frustration, I labeled my new assignment: "I'm on the death beat now!"

However, it wasn't long before I started seeing the bright side of the assignment.

First positive thought bubbled up that a cemetery series would allow me to recount to readers my special friendship with Cannon County's overall-wearing vegetable garden growing/whopper story telling legend C.L. Vickers, who is buried in Bradyville Pike's Thyatira Cemetery, one of the region's most unique-named cemeteries.

C.L. was one my best sources for colorful stories, and I still miss him.

Being a veteran newspaperman, I have sources planted over multiple states.

Subsequent research helped me cultivate a new source, to wit, lifelong Woodbury resident Bobby Womack, who has evolved into one of my most valued friends for life.

Bobby directed me to a man who turned out to be an authoritative expert on cemeteries in the beautiful meandering rolling hills of Cannon County. Seeing those beautiful country scenes became another positive.

I keyed in the suggested source's phone number: "Mr. Joe Davenport, this is Dan Whittle. My publisher has ordered me to do a series of stories about cemeteries ... can you help me?"

Bobby had certainly channeled me to the right man, for Mr. Joe Davenport is walking/talking encyclopedia of history. "Just call me Joe," retired school superintendent/history teaching professor Mr. Davenport instructed, which put me at ease.

How much history does "Joe" know? So

much, he's the president of the Cannon County Historical Association.

By the time Joe and I had trekked through a few cemeteries, all negative thoughts about the cemetery assignment had evaporated.

I recall thinking, "Joe must have been an awesome history teacher, for he sure knows how to make cemetery history come alive" as we moseyed through numerous cemeteries.

Now, fast forward to the present: Last week, while wife Pat and I were breaking bread at a public eatery, my phone rang ... "Dan, this you're your favorite publisher: One of your stories just won first place as the best feature story, as judged by our peers in the Tennessee Press Association."

"Hey, that's exciting," I expressed in joyful shock. "Which story?"

"It was one of your cemetery series," publisher confirmed.

"Why yes, Mr. Publisher, and I might add that was one of the best assignments you ever gave me," I whimpered lamely.

"Whittle, your suck up attempt won't work," Publisher Fryar confirmed. "I remember all of your whining and belly-aching."

As it turned out, the feature was about Melton Cemetery, up on history-laden Short Mountain that gives rest to a bloody, tumultuous past when neighbors stalked neighbors, sometimes in the name of patriotism, sometimes in harsh malice and greed, but all a part of this nation's inglorious War Between the States.

In Melton Cemetery, on state Route 146 between Woodbury and Smithville, rests the remains of Confederate Guerilla Fighter Hiram T. "Pomp" Kersey.

After publisher had reminded me of my whining, I thought of another misconception I had going into the cemetery series Courier Editor Mike West and I eventually entitled: "History Lives Here."

Of all the cemeteries Joe Davenport and I trudged through, not one was over-run with weeds due to neglect, which speaks well of Cannon County folks and their respect for ancestors.

Plus, there was one other BIG POSITIVE from the cemetery series: I received not one CHIGGER BITE in all our treks in cemeteries from one end of Cannon County to the other.

How many readers are familiar with the name Rupert Murdoch? I'll guess less than 20 %.

I use a calculation of "20 %" because when I asked an eclectic mix of six people—different ethnicities, different age brackets, different eco-politico-socio backgrounds—only one of the six was even remotely close to identifying the "real" Rupert Murdoch. Regarding the other five, responses ranged from "UFC fighter" to "that old rich man [Donald Sterling] who owns the Los Angeles Clippers" to "I don't know."

With a somewhat quizzical expression, one young fellow, however, did comment: "Ain't he the guy who's all over the news, and has something to do with CNN and Fox?"

"Keith" Rupert Murdoch, 83-years-old, hails from Australia and is a business tycoon of the highest order, more like a "world-class corporation on two legs," to use an original quote.

Rupert Murdoch "rarely likes to be outdone, and his 80 billion dollar bid for Time Warner could trigger a new round of media mergers. . . . Time Warner has been the ultimate liberal establishment—East Coast and Hollywood—power bastion. Murdoch has been the insurgent, seeking not only to take power from the establishment but also to challenge its liberal bias.

"The eerie lack of protest last week to news that Murdoch had bid for Time Warner, from both his target and the greater media world—no yowls about Murdoch the defiler or Murdoch the right-wing monster out to amass more power—suggests he has won. Or that Time Warner has given up. . . . Murdoch, in the shadow of Time Warner and ever envious of it, built his own media company, combining print, movie studio and TV network" (reference: July 21, 2014 edition of USA Today, section B, pages 1-2).

Moving right along, how many readers are familiar with, have watched reruns of the popular TV sitcom The Beverly Hillbillies, which originally aired from 1962 through 1971? For those unaware, here's a brief synopsis:

While hunting for food, impoverished mountaineer Jed "J.D." Clampett accidentally fires into the ground and a stream of

black oil, a.k.a. "Texas Tea," spews upward.

"Well the first thing you know of Jed's a millionaire, Kinfolk said, 'Jed move away from there' Said, 'Californy is the place you ought to be' So they loaded up the truck and moved to Beverly.

Hills, that is. Swimmin pools, movie stars" (lyrics to theme song for The Beverly Hillbillies TV show).

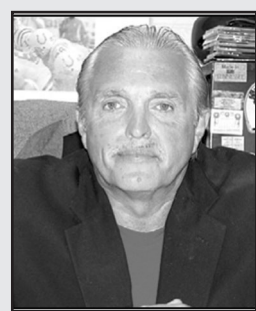
Now worth somewhere between 25 and 50 million dollars (depending on the episode), Jed moves his backwoods, non-educated family from the rugged mountains to lavish, movie-star-studded Beverly Hills, California. (NOTE: (There is ongoing speculation concerning from whence Jed and his family originally hailed: Missouri? Arkansas? Tennessee?) Jed entrusts his newly-found fortune with Milburn Drysdale, the greedy Beverly Hills banker who has no scruples in doing whatever necessary to keep Jed & clan happy and living in Beverly Hills, thus keeping Jed's millions in Drysdale's Commerce Bank of Beverly Hills.

Putting things in perspective, 25 - 50 million dollars was a heap of money back in the early '60s - early '70s. On one episode of The Beverly Hillbillies, Jed tells banker Drysdale that he/Jed wants to see and count his/Jed's money. Banker Drysdale, of course, attempts to explain to Jed that such a count is impossible, due to limited hard cash on hand, a variety of investments etc. Jed is somewhat suspicious and upset when Drysdale can't produce Jed's money on the spot.

My point is: Offering "billions" to buy out a major corporation is commonplace these days . . . far too "common" for my comfort! One is forced to ask: Is there adequate "security" to back such monetary transactions?

Kudos to Rupert Murdoch for being the ambitious tycoon he is. And though this might sound a bit cornfed, like Jed Clampett, I'd like to see the banker count out a few million in "hard cash" before someone offers "billions" to buy out a business.

You must admit, billion-dollar buyouts do cause one to question the "true state" of our world economy.



Meat 'n' Potatoes

News coverage of the first Apollo moon landing some 45 years ago has sparked a small upsurge in interest in science and technology. But the central question still seems to be, "Where were you during the time from liftoff on July 16, to return on July 24?"

But let's go back a few years, and ask if you remember where you were and what you were doing on Oct. 4, 1957? That was the day the former Soviet Union launched Sputnik I, the first artificial satellite to orbit the earth.

Newspaper headlines the next day said the public was in a state of shock and fear about this Russian "moon" flying over American cities. There is evidence, however, that the Sputnik "debacle" was more of a media-generated frenzy than an actual failure of American science and engineering.

How many of you remember those early days of the space race, when every rocket launch made the front page of the newspaper, and television coverage sometimes lasted all day? Those were heady days then, when everyone recognized project names such as Vanguard and Explorer, personal names like Gagarin, Shepherd and Glenn, and the world was thrilled by the sound of rockets with names like Delta and Atlas blasting into space.

Unfortunately, news coverage of science in general and space activities in particular, has become as adrift as our space policy itself. Space exploration, robotic and human-based, has become almost routine, and the news doesn't cover routine events.

Science news today is too often filled with pseudo-science, paranormal claims and click-bait headlines about interstellar travel and the search for extraterrestrial life.

Actually this lack of interest in the space program is simply a manifestation of the fact that science news itself really isn't a very hot topic these days. In addition, study after study shows an abysmal lack of science education in our schools and science knowledge in our students. So I guess I should be grateful for what space news does appear.

Whether or not we should even be in space is still a topic that spurs heated debate and passion among scientists and observers. But space technology benefits all of our lives, and the more we know about it, the better. And the better the news coverage ought to be.

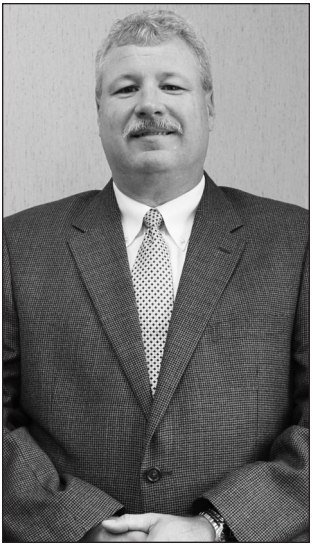
Taking statements out of context is not only misleading, it borders dishonesty. My office has always been open and accessible to every citizen of Cannon County. Along with myself, I have two

Watch your dog during dog days

As summertime begins to go into its hottest period of discomfort for southern man and beast alike, I'm reminded of the days when air conditioning was only found at J.C. Penney's in town and would give you an ice cream headache due to not being use to it. It also reminds me of one hot July night back in the early '60s when Cousin Tom received a phone call at four thirty in the morning from a neighbor down the road. The old white frame farmhouse that he and Mollie had shared for a lifetime didn't have all the modern day conveniences that we have, and it was always during the "dog days of summer" that they would have a few nights that were not very pleasant. That night was one of those and Tom had spent the night turning his pillow on a regular basis to locate the cool side to rest his head on.

There was no air conditioning, no central units and the only way they had to move the hot and humid air around the house was with a GE oscillating fan that had been in the family since their now-grown children were babies. With all the windows pushed to the top of their sashes, you could hear the frogs outside croaking in a melody that seemed to make the air even more stagnant. Tom had even moved down to the foot of the bed to get some air from the open window. The sheets of the bed had felt like they had "come in case" just like tobacco hanging in the barn does before you strip it to sell.

However, around three o'clock, the early morning air had cooled enough for the old man to finally get to sleep. But with the ringing of the huge black dial phone in the hall, his sleep had been broken and he headed to the phone stand table to answer what he assumed would be bad news, which is usually the case that time of the morning.

With a trembling voice he said, "Hello?"

Immediately on the other end of the line, Tom's neighbor Burney Leary spoke with a very loud voice saying, "Your dog has barked all night and I want you to make him stop!"

Now fully awake, Tom remained totally calm and

answered Burney in a low voice, "I'm sorry Burney, thank you for calling and bringing that to my attention. Good-bye."

It is usually about the hottest time of the year for us. Most dogs during this time become lazy to avoid overheating and man seems



After the call and explaining what all the commotion was about to Mollie, Tom went back to bed and slept a fairly restful sleep. But at four thirty he got back up and called Burney, and when Burney answered in somewhat of a frightened voice, Tom said, "You know Burney, I don't have a dog. Goodnight."

Much like Tom and Burney's long hot night confrontation during the summer's "dog days," those hottest and sultry days of summer get a lot of credit for strange things happening. They usually fall in the northern hemisphere between early July and early September, but the actual date is often open for debate. "The Old Farmer's Almanac" sets the date for Dog Days as the 40 days beginning July 3 and ending August 11. It says it coincides with the ancient helical (at sunrise) rising of the Dog Star Sirius. The ancients believed that the star was the cause for hot and sultry weather. They also believed it was an evil time when dogs grew mad, the seas boiled and man turned feverish.

I'm not to sure when the Dog Star rises around here, but I do know that most folks call the last of July to about the middle of August the Dog Days in Tennessee.

to do the same thing. If you work outside, you can become "dog tired" during the Dog Days from the heat. You also learn really fast during this time of the year that you can drive a car with two fingers due to a hot steering wheel and don't put sunglasses on too fast after first getting in a hot car if they have been setting on the dash.

There are some good things to do during this hot time of the year. Check out a local Tennessee farm for some great farm raised fresh produce. During the Dog Days there's nothing like a good fresh Tennessee tomato sandwich or honey straight from a farmer's bee stand. Your local farmers markets are really going strong right about now, so be sure to make a visit to one.

Avoid the Dog Star and stay cool. Dog Days will be over before long and fall is just around the corner, and so is the time for some good Tennessee cider and sorghum. I've noticed the sorghum fields are growing good right now and it looks like this year could be a good one for both man and beast.

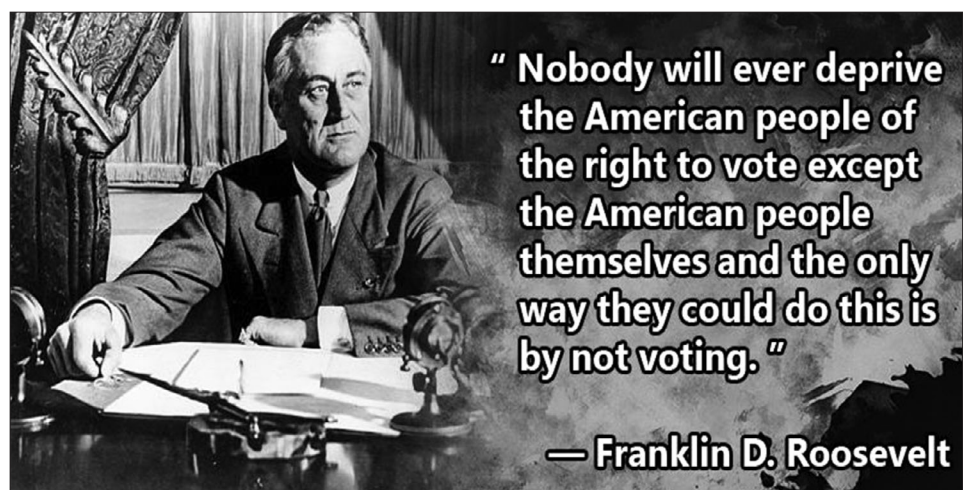

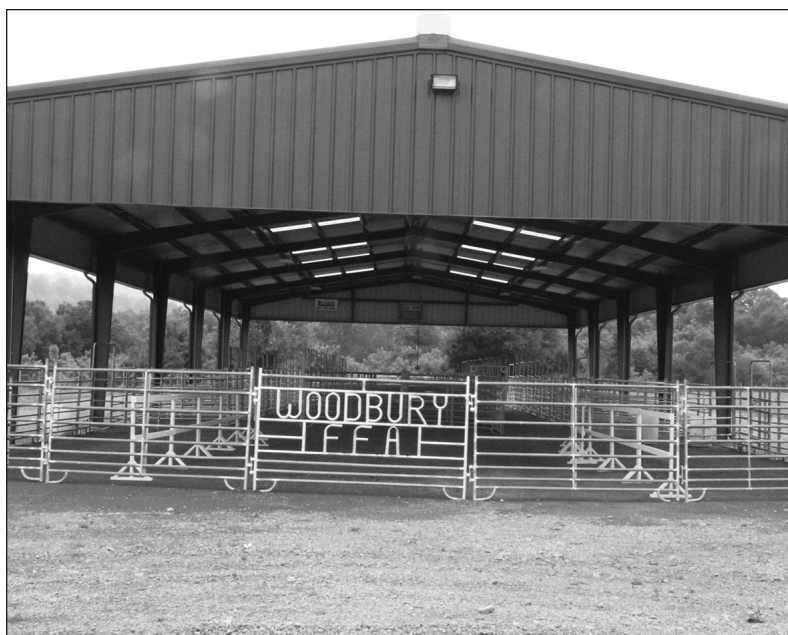

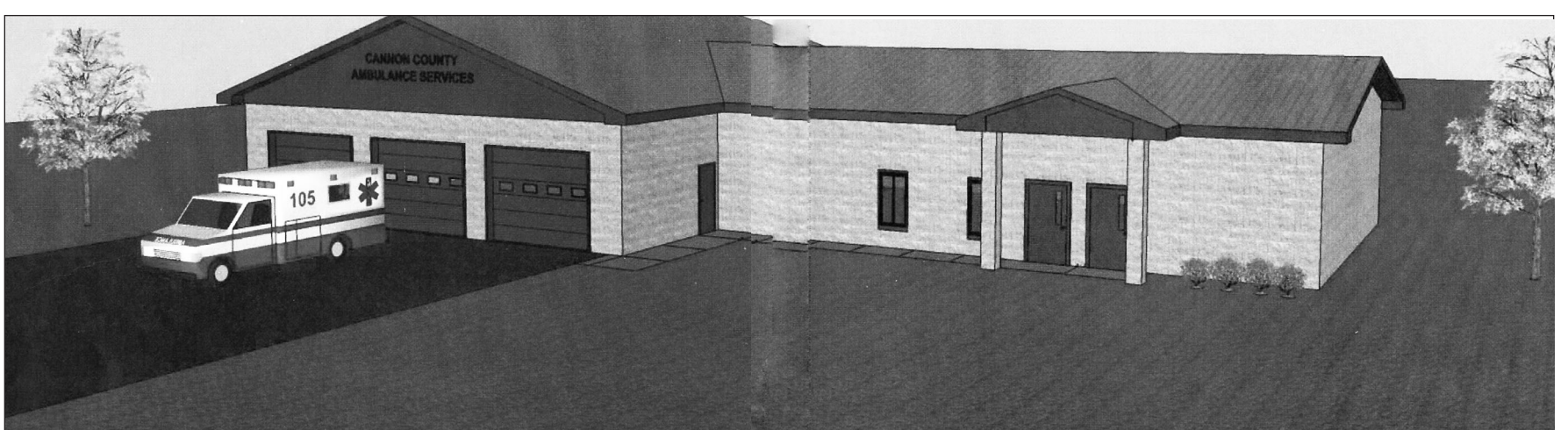

"I'm looking for high-caliber crafts, insightfully made with attention to detail. Eye-catching. Something I know my customers are going to be interested in," Cole said of the fetching pieces here that range in price from \$3 to \$3,000.

"In the gallery they do a good job of telling what we're about," said exhibitions-programs manager Lindsey Maestri, noting that the center opened 35 years ago after the late Representative Joe L. Evins secured a \$5-million federal grant to fund the campus.

"Evins wanted a place that really represented the traditions of crafts in this area and region," Maestri said of satellite campus of Tennessee Tech's Department of Fine Arts.

The center offers bachelor of fine arts degree concentrations in clay, fibers, glass, metals and wood. Also available are non-degree craft certificate programs in the five craft media. The academic programs are enhanced by an artist-in-residence program which allows emerging professional craft artists to live and work here.

During the fall and spring semesters as many as 50 college students attend classes here and some reside here in quad units. Currently about 30 are participating in four workshops.

The center boasts three galleries which annually host 20 rotating exhibitions of work by local and national artists.

Maestri suggests visitors begin in the first exhibition room and then move into the gallery before checking out the other two exhibition spaces. She also encourages

comment as to each of the candidates in one of four ways: "Highly Recommend," "Recommend," "Do Not Recommend," or "No Opinion." For Cannon County, incumbent judges received the most favorable measures.

Incumbents who face no challengers include Republican Circuit Court Judge Keith Siskin for Division III; independent Circuit Court Judge Royce Taylor for Division IV and Republican Public Defender Gerald Melton of Woodbury. Republican Jennings Jones has no

competition in the race for district attorney general.

Circuit Court Judge Mark Rogers, a Cannon County native, is running as an independent against Republican nominee Jeff Peach for the Division I judicial seat of Circuit Court in the Aug. 7 election.

Rogers got a highly recommended score from 87 attorneys to represent 79.09 of the Rutherford and Cannon County Bar Association. Rogers had another 17 attorneys recommend him.

Peach, past chairman of the Rutherford County Republican Party, only had eight attorneys highly recommend him and 12 recommend him. He also had 68 attorneys not recommend him to represent 61.82 percent of those surveyed. Another 22 attorneys offered no opinion.

Circuit Court Judge David Bragg received high marks for the Division II seat. He's seeking re-election against Republican nominee Nathan Nichols from Woodbury.

Bragg, a former owner

of the Cannon Courier, had 82 attorneys highly recommend him to represent 74.55 percent of those surveyed, and 22 lawyers recommended him.

Nichols only had five highly recommend him and 17 recommend him. He had 65 attorneys not recommend him to represent 59.09 percent of the survey while 23 offered no opinion of him.

In the race for Cannon County General Sessions Judge, incumbent Susan Melton scored better than challenger Dale Peterson.

Melton had 46 highly recommend her to represent 42.20 percent of the survey, and 26 recommended her. Only 13 did not recommend her, and 24 offered no opinion.

Gullett, along with Sheriff Darrell Young, Investigator Anthony Young and Deputy Doc Smith, set up nearby Hale's property.

"I was then notified by (the) helicopter pilot who stated that the marijuana plants were confirmed at 4826 Hurricane Creek Road," Gullett said.

A search warrant was then obtained and served on Hale.

Gullett initially found two marijuana plants next to Hale's garden and one small plant in the middle of the garden.

"William Ray Hale then walked me to the rear of the chicken pen where several more both large and small plants were recovered. I was also advised by Sheriff

Darrell Young that he had located six marijuana plants ranging in size in a grown up sport behind the residence," the investigator said.

Additional plants were discovered at the top of a hollow. Inside the barn, four pot plants were discovered drying.

"In this same room were two ammo cans, one large and one small, that both were packed full of individual bags of a leafy green substance," Gullett said.

Additional marijuana and pot seeds were discovered inside Hale's house. "Grow" rooms were discovered upstairs and in a white building outside the home.

According state officials, a fully grown marijuana plant can produce around a pound of marijuana. At street value, the marijuana is worth around \$1,000.

In 2011, the Governor's Task Force seized more than 600 thousand marijuana plants in Tennessee. The director of the task force says the plants were worth \$600 million. Last year, the task force seized almost 150 thousand plants valued at \$150 million.

Watershed rehab funding critical to public health

Communities across the nation, including many in Tennessee, will benefit from a \$262 million investment

to rehabilitate dams that provide critical infrastructure and protect public health and safety.

The 2014 Farm Bill increased the typical annual investment in watershed rehabilitation by almost 21 fold, recognizing the critical role of these structures in flood management, water supply, and agricultural productivity.

"This investment will protect people and ensure that these critical structures continue to provide benefits for future generations," said Jason Weller, chief of USDA's Natural Resources Conservation Service (NRCS). "Homes, businesses and agriculture are depending on responsible management of the dams and overall watersheds, and NRCS is continuing to provide that support to these communities."

From the 1940s through the 1970s, local communities using NRCS assistance constructed

more than 11,800 dams in 47 states. These watershed management projects provide an estimated \$2.2 billion in annual benefits in reduced flooding and erosion damages, and improved recreation, water supplies and wildlife habitat for roughly 47 million people.

More than 150 dams in 26 states will receive rehabilitation assistance for planning, design or construction through NRCS' Watershed Rehabilitation Program.

The program will also enable 500 dam sites to be assessed for safety. The projects were identified based on recent rehabilitation investments and the potential risks to life and property if a dam failure occurred. Overall, about 250,000 people will benefit as a result of improved flood protection made possible by these rehabilitated dams.

Be careful with candles in your home

Decorative and fragrances candles are a popular piece of décor in many homes, but they are also a major concern for fire service professionals and other safety organizations. When used improperly, candles may cause significant loss of life, property, and/or cause substantial injuries.

"From 2008-2012, Tennessee fire departments responded to 506 home structure fires started by candles," says State Fire Marshal and Commerce and Insurance Commissioner Julie Mix McPeak. "These fires caused nine deaths, 30 injuries, and \$14.8 million in direct property damage, all of which could have been prevented with just a few cautionary steps."

Candle fires cause damage from coast to coast. According to the U.S. Fire Administration, on average, 42 home candle fires are reported every day in the United States. Over one-third (36%) of those home candle fires begin in the bedroom. More than half of all candle fires start when something that could burn, such as furniture, mattresses, bedding, curtains, or decorations, is too close to the candle. Falling asleep is a factor in 12% of home candle fires. Young children and older adults have the highest death risk from candle fires.

The State Fire Marshal's Office offers the following tips to keep Tennesseans safe from candle fires:

Consider using battery-operated flameless candles, which can look, smell, and feel like real candles.

When using candles, place them in sturdy, safe candleholders that will not burn or tip over.

Protect candle flames with glass chimneys or containers.

Keep candles at least 12 inches from anything that can burn.

Never leave a burning candle unattended.

Avoid using candles in bedrooms and sleeping areas. Extinguish candles when you leave a room or the home or go to bed.

Keep children and pets away from burning candles. Never leave a child unattended in a room with a candle.

Never use a candle where medical oxygen is being used. The two can combine to create a large, unexpected fire. Medical oxygen can cause materials to ignite more easily and burn at a faster rate than normal. It can make an existing fire burn faster and hotter.

Always use a flashlight—not a candle—for emergency lighting.

Use only battery-powered lights in tents, trailers, motor homes, and boats.

Lit candles should not be placed in windows, where blinds and curtains can close over them, causing a fire.

If you purchased the memory storage component installed in most electronic devices known as Dynamic Random Access Memory (DRAM), you may be entitled to payments from a \$310 million settlement fund. The deadline to file (August 1) is rapidly approaching, Tennessee Attorney General Bob Cooper reminds Tennesseans.

DRAM can be sold individually or preinstalled in computers, graphics cards, video game consoles, MP3 players, printers, PDAs, DVD players and digital video recorders. DRAM is a high density, low cost per bit, memory component that stores

DRAM manufacturers over claims of price fixing. Consumers and businesses can file a claim if their purchases were between 1998 and 2002.

Purchasers of large amounts of DRAM or DRAM products could get \$1,000s depending on the amount of product purchased. The minimum payment for smaller purchases of DRAM or DRAM products is expected to be \$10. But the actual payment amount depends on the total number of claims filed and payments could be \$25, \$50 or more.

Lions ready for Camp NaCoMe

Four-day getaway all about football

 Football players at Cannon County thought they knew one another. After this week, they really will.

The Lions are spending this week at Camp NaCoMe in Pleasantville, Tenn., just outside of Centerville. Mention camp to most high school students and thoughts of swimming, fishing, or summer Bible camp or others come to mind.

There will be no such pleasantries awaiting football players from Cannon County.

This camp is all about football. It is designed to be four days and four nights of nothing but eating, breathing and sleeping thoughts of gridiron glory.

Getting closer and developing team chemistry; however, is at the top of the list of things to accomplish during this brief, but important, getaway.

"Chemistry is the big thing," said senior lineman Jake Duggin. "Becoming better teammates is important. As far as football we can get everything done here (at CCHS) but once you push the world out and just allow it to be football and team, then chemistry becomes a lot better."

Lions second-year head coach T.J. Daniel exposed

his players to the rigors of Camp NaCoMe last year. He expects this summer's foray to be much more productive in all areas.

"Last year it was somewhat of an unknown for all of us because we had not done this before," Daniel said. "This year we know what we are going to accomplish and the kids know what to expect also. The whole point of camp is to start working together as a team and go through things other don't. There are no distractions. It is just the players, coaches, support staff and football. This allows our players to focus on football for four days and get to know one another better."

Maturity should help the Lions as they go away to try and become better. More players who have been in the program should enable leadership to provide an example and sense of urgency.

"I believe we are accountable now, we are more mature," said junior Bo Bryson. "We have older players this year and that helps. We hold ourselves and one another more accountable. When we return from this camp we should be a better football team. We have to focus on what the goal is."

Camp is not just about chemistry.

It's also about players getting on the same page in terms of offensive and defensive schemes.

Cannon County's offensive line appears to be much bigger and most of the players set for action have been in the trenches before. Becoming a more fluid unit is the key now. Players such as Duggin, Daniel Davis, Terry Parker, David Fonoti, and Maika Fonoti are among linemen who bring experience to the front five.

"I think we are a better blocking team," Davis said. "Coach (John Robinson) is helping us a lot. I think he has us doing the right things. If you don't have a strong front five you are not going to move the ball or have success running or throwing it. Overall, I think our group is better and we are working harder."

Senior Wilder Mankin said understanding how to practice is also important.

"We have to practice with a purpose, focus and get things done," Mankin said. "We also have to be smart with our practices. We don't have a lot of depth so that's important. We are working as a team. This camp should make us even closer."

Cannon County will play host to Middle Tennessee Christian in the season opener at Schwartz Field, Aug. 22.

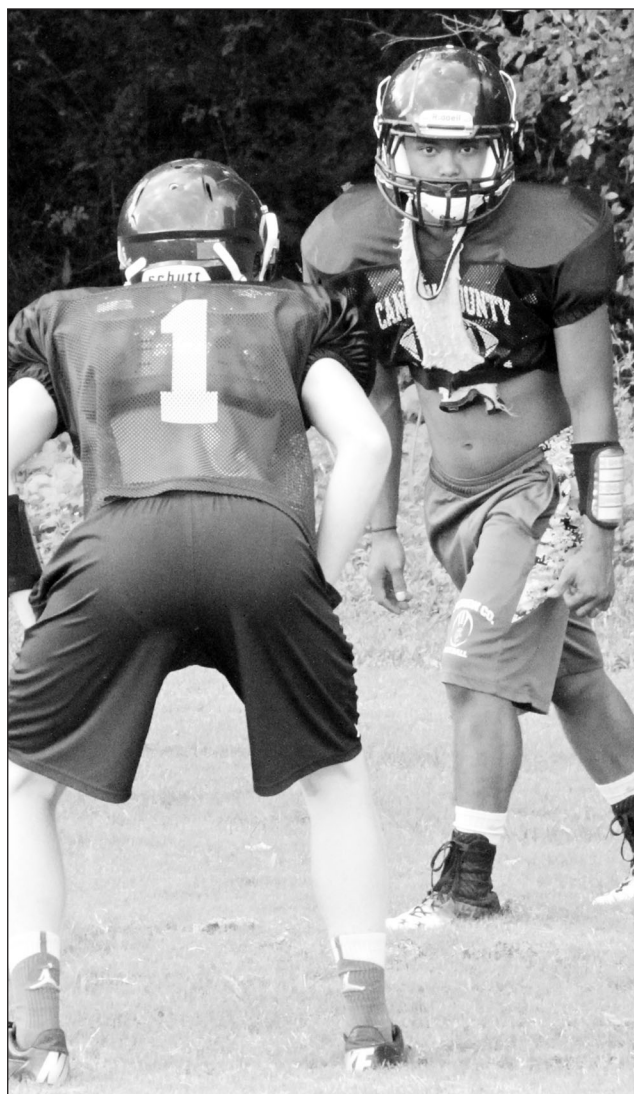

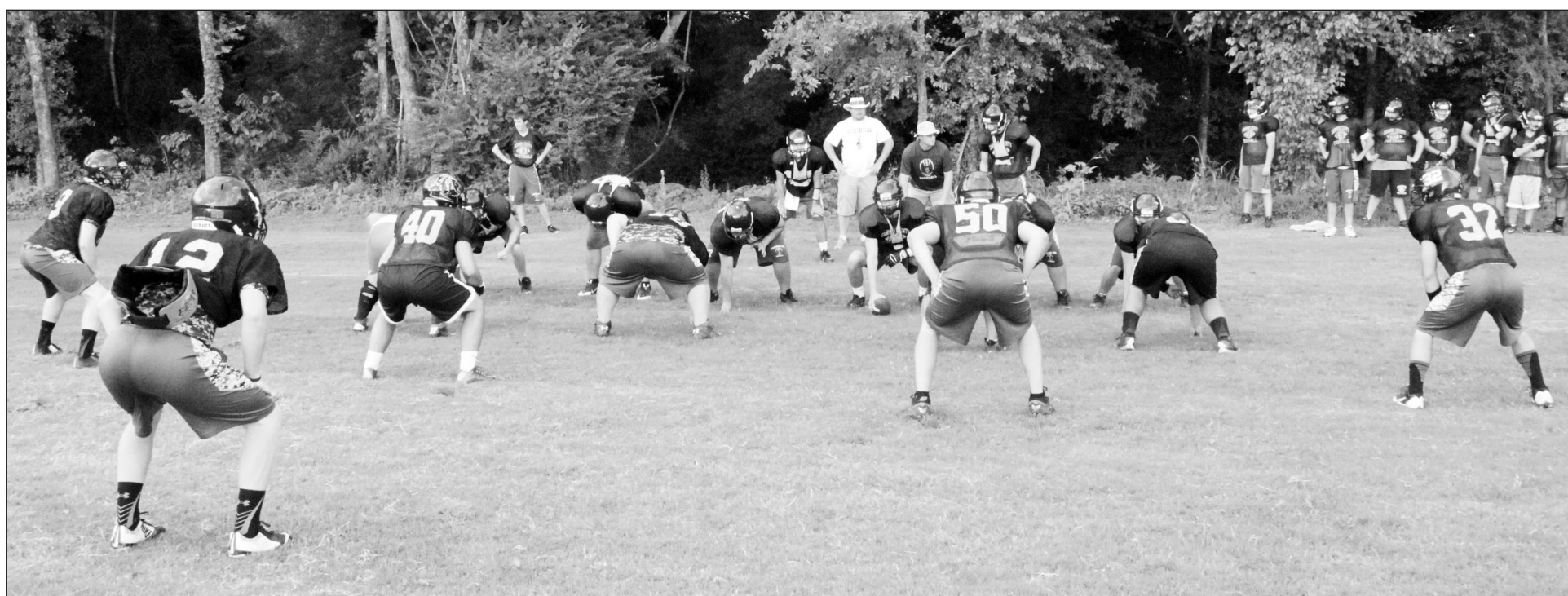

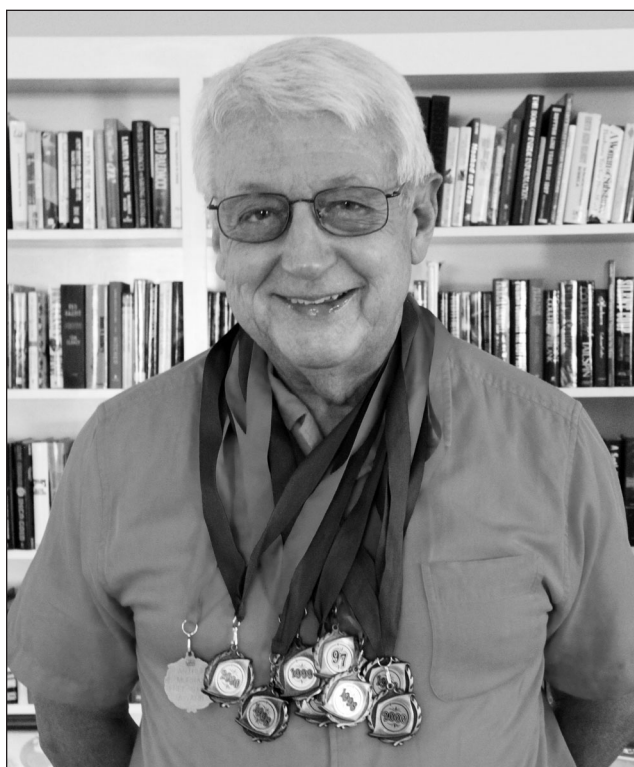
"Ballroom dancing offers a lifetime of enjoyment," Basinger said. "You will enjoy music to the fullest if you know how to dance to the rhythm."

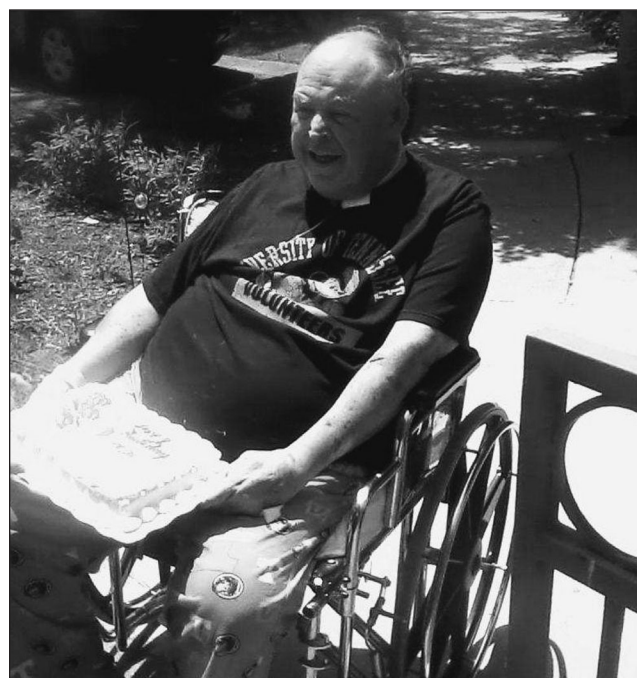

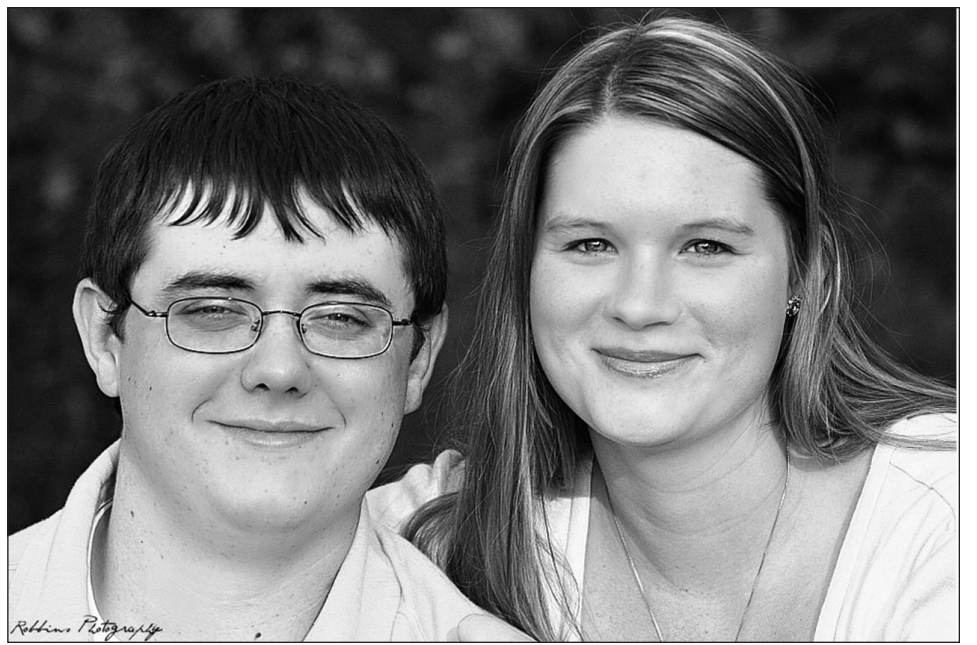

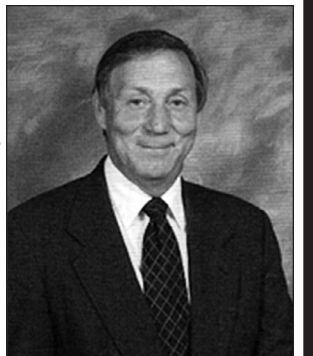

Refrigerator pickles

If you are at all like me, you sometimes run across the problem of having too much of a good thing. In this summer of plenty, I have found myself contemplating just how to preserve the luscious produce available without having to set up a full-fledged canning operation. I do have friends who think nothing of spending a hot day in the kitchen with jars and lids lined up, a pressure cooker and canning kettle steaming up the house.

For me, that's just not an option. For one thing, it's just plain too hot. Second, I am not the easy way gourmet for nothing-I am too lazy. Finally, I don't have time or the inclination to do that much work and risk getting burned in the process. But I do have friends who are farmers, dropping off bags of cucumbers and piles of dill at my door.

My solution? Use up a bunch of garden fresh cucumbers (and maybe some onions and peppers too.) Make a batch of refrigerator pickles!

A simple, fast to finish project, making refrigerator pickles is a great way to preserve the harvest and become a hero. What you really need are some clean jars (I sterilize mine on the high heat setting in the dishwasher,) a bunch of fresh cucumbers, vinegar and spices.

Everything else is optional-you can use sugar to make sweet pickles, onions and peppers to make more of a pickle mix. You could add hot peppers to the mix and make spicy hot pickle, or even pickled peppers.

I know some folks who make pickled apples and pears with the same methods just different spices. With a little experimentation, you can perfect your own signature recipe which friends will welcome as a prized part of the summer season.

Recall, however, this project is meant to be using up fresh produce you have. It should save you money and time, not cost you too much.

So my advice is to be creative both with the jars you use and the ingredients. Unless you already have a famous recipe for pickles that use pre-pickled products, start with fresh cucumbers from the garden. I have one dear friend who is well known for his special hot and sweet pickles, but he starts the whole process with a gallon of premade dill pickle slices. While I love his pickles, this defeats my purpose of preserving produce the easy way.

My favorite pickle is garlic dill, so the recipe below uses both. Right now, you can hit the garden or the farmers market to get fresh dill bunches, garlic and cucumbers.

It is a perfect way to start the journey into refrigerator pickling-while they have to cure in the refrigerator for a few days, the whole preparation takes less than twenty minutes from start to finish! You can change this recipe to fit your tastes, adding more sugar for sweetness, hot peppers for spice, even onions and bell pepper slices for variety. If you want to make fruit pickles, you can use apples or pears, cider vinegar, cinnamon, ginger and cloves for a nice refrigerator sweet pickle.



Homemade Refrigerator Pickles

Homemade Refrigerator Pickles

- 1 cup distilled white vinegar
- 3 cups water
- 1 teaspoon sugar
- 1 tablespoon kosher salt
- 1 tablespoon pickling spices
- 4 cups cucumber spears
- 2 cloves garlic, cut into big slices

1 large bunch of dill, roughly chopped with big stems removed

First, combine the vinegar, water, sugar and salt in a medium sized glass bowl. Microwave this mixture for 3-4 minutes, until you see that the sugar has dissolved and the liquid has reached a bit of a boil. Remove it from the microwave and put it into the refrigerator to cool. Arrange the pickling spices, dill, garlic and cucumber slices in sterilized glass jars. Divide the cooled vinegar solution among the jars, pouring it over the cucumbers until they are completely covered. Seal the jars tightly and put them in the refrigerator for at least three days. Enjoy!

The group arrived in Cannon County, July 9, and stayed at Short Mountain Distillery. They arrived in the Woodbury city limits July 10.

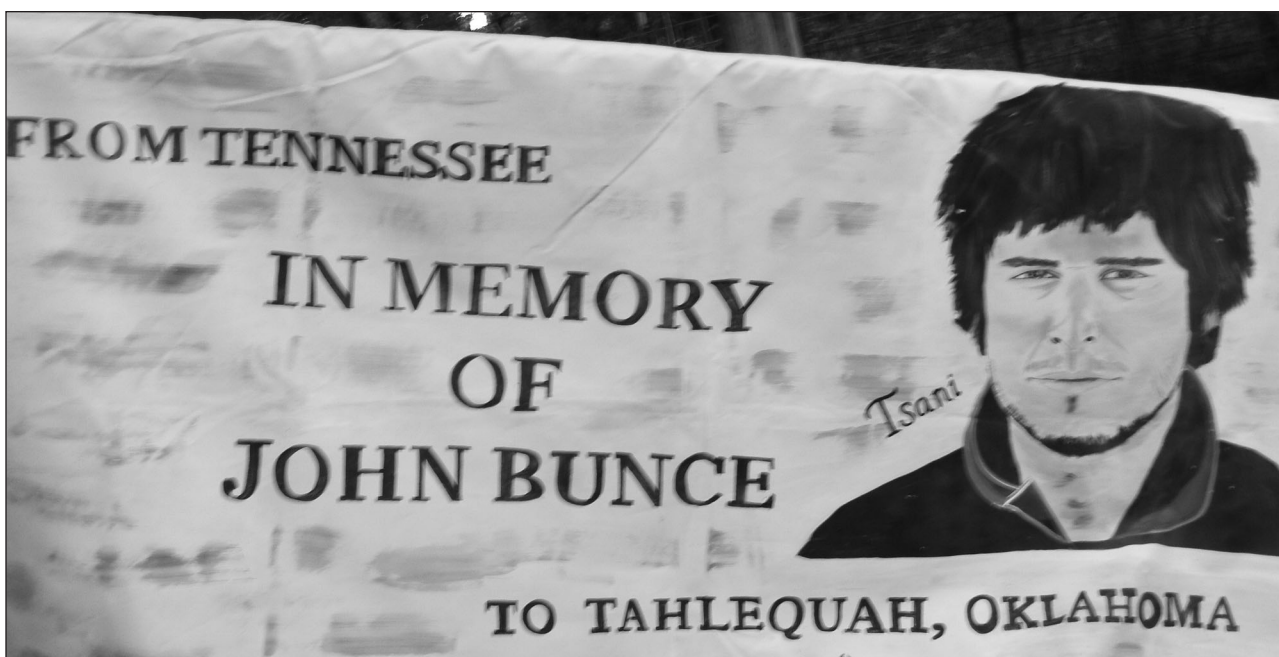
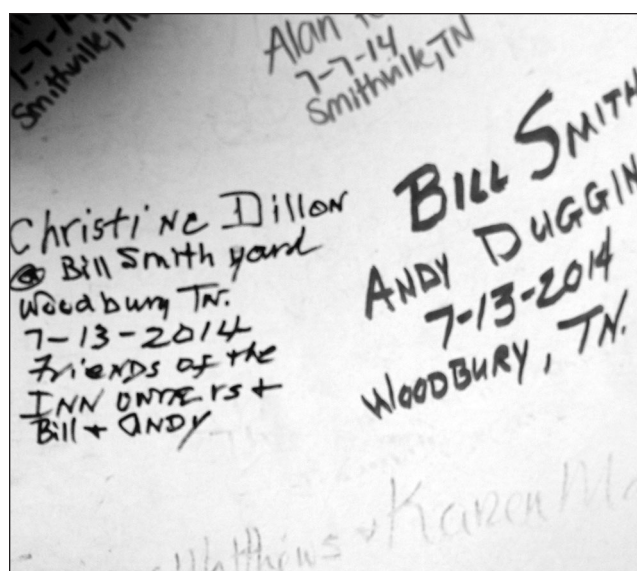

The family is staying as close as they can to the Trail of Tears as they travel cross country in their son's memory.

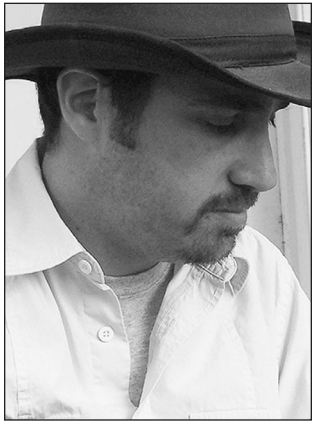

Spring Fed Records acquired by MTSU

The Center for Popular Music at MTSU has acquired the renowned Spring Fed Records from the Arts Center of Cannon County.

The Arts Center has donated the Grammy-winning label's name and rights and sold its existing inventory to MTSU, said Dr. Greg Reish, the Center for Popular Music's new director.

Founded in 2002, Spring Fed Records is devoted to issuing unique and

historically significant recordings of traditional Southern music, including old-time country, blues and gospel. Among its featured titles are music by Uncle Dave Macon, Sam and Kirk McGee, The Fairfield Four, Frazier Moss and Mississippi John Hurt.

Spring Fed's compilation of field recordings by pioneering African-American folklorist John Work III won a Grammy in 2008 for its liner notes by former CPM staffer Bruce Nemerov.

The label established a strong partnership with MTSU and the Center for Popular Music from its inception with contributions from Nemerov, former CPM director Paul Wells and the late Dr. Charles Wolfe, a venerated scholar of traditional music.

"Spring Fed's regional emphasis on traditional music fits well with the CPM's mission and will allow us to explore even

further the vast repository of historically and culturally significant recordings in the CPM archive," Reish said. The Center for Popular Music is

affiliated with MTSU's College of Mass Communication and is housed in the Bragg Mass Communication Building on campus.

Production and marketing of new Spring Fed releases will also work in cooperation with the College of Mass Communication's highly regarded Department of

Recording Industry program, giving students the opportunity to work in a specialized sector of the business. Beverly Keel, recording industry

Popular Music.

"Our students will get a chance to gain real-world experience by promoting this music and scholars everywhere will have the opportunity to study the history of Spring Fed at MTSU."

Ken Paulson, dean of MTSU's College of Mass Communication, added that the addition of "Spring Fed Records gives MTSU an extraordinary opportunity to use the recordings of the past to enhance the college's future. The label adds a new dimension to our educational opportunities and underscores the pivotal role the Center for Popular Music plays in the College of Mass Communication."

Spring Fed will be housed in the Center for Popular Music, and CPM staffer John Fabke will manage its day-to-day operations. A new marketing and sales structure, including a new website, will roll out soon.

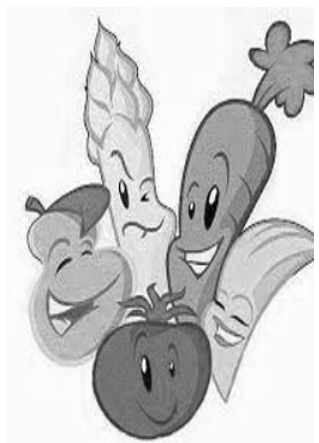


Amos
Book of Amos

Amos was a Shepherd and grower of figs and a dresser of sycamore trees from Tekoa, in Judah, the southern kingdom of the Israelites. His prophecy was to the northern kingdom, Israel.

Amos begins his condemnation by speaking of God's coming judgment to the nations surrounding Israel. He spoke against Aram, Gaza, Tyre, Edom, Ammon, Rabbah, Moab and his own country, Judah. Then he begins to denounce Israel, condemning the wealthy for oppressing the poor and for their worship of idols.

Amos illustrated his messages with situations from his farming and shepherding experiences: a loaded cart - ch. 2, v. 13; a roaring lion - ch. 3, v. 8; a mutilated sheep - ch.3, v. 12; pampered cows ch. 4, v. 1; and a basket of fruit ch. 8, v. 1,2.

These illustrated God's coming judgment upon His people who had ceased to worship Him and obey His word.

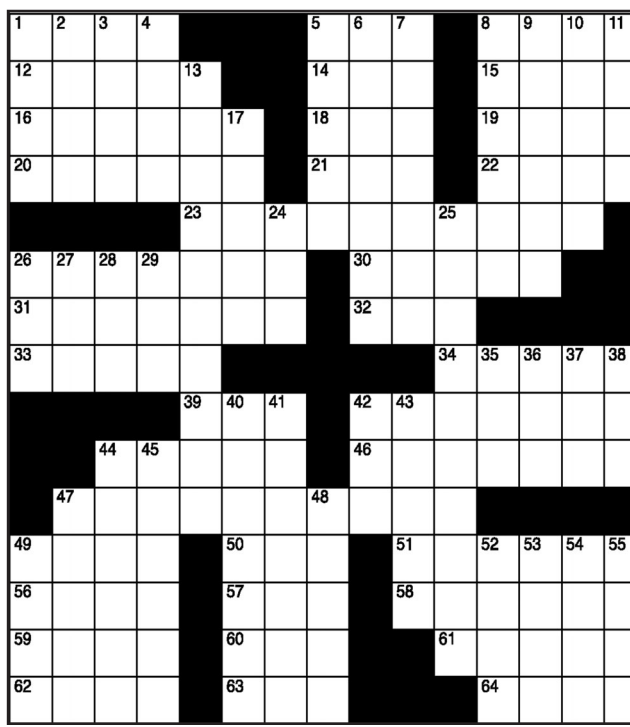
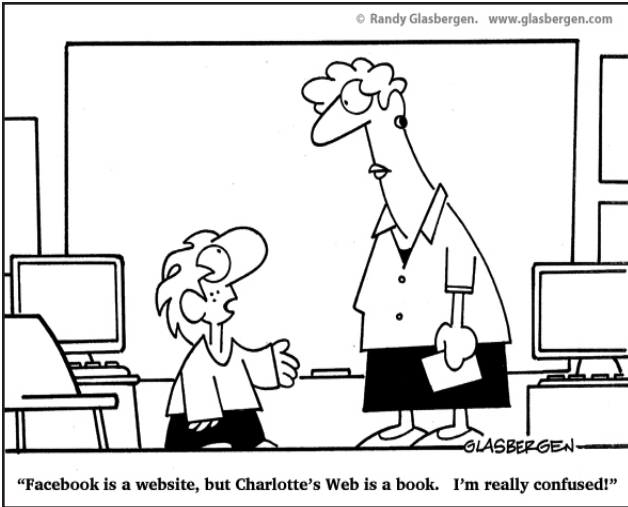

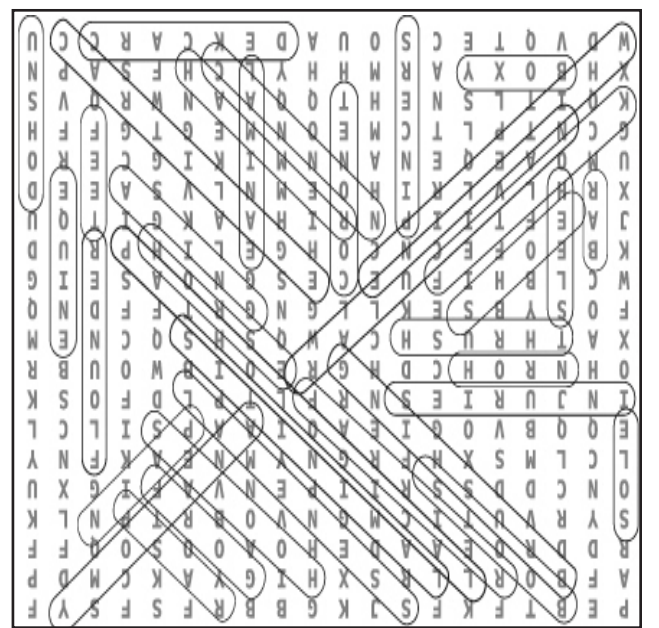

The Battle of Franklin Trust will reveal "Battle Scarred," an exhibition commemorating the 150th anniversary of the Battle of Franklin Aug. 2 in The Fleming Center at Carnton Plantation.

Covering more than 1,600 square feet, this display will capture the importance of the Battle of Franklin as part of our national heritage. The eyewitness accounts include graphics, light, sound, and more than 100 artifacts.

Fire safety important during summer vacation

As the school vacation year comes to a close, many Tennesseans are still turning their attention to family vacation plans. The State Fire Marshal's Office asks that you remember to incorporate fire safety into travel plans before hitting the road for your summer vacation.

"Hotels and motels become a home away from home for travelers, so it is important to become familiar with new surroundings and to have a plan in place should an emergency arise," says State Fire Marshal and Commerce & Insurance Commissioner Julie Mix McPeak.

Being mindful of the following safety points will help ensure that your upcoming vacation is as safe as it is fun!

Choose a hotel or vacation rental that is equipped with both smoke alarms and fire sprinklers.*

If you are deaf or hard of hearing, ask for a room equipped with a smoke alarm and accessories that will awaken you, or for a portable smoke alarm made specifically for people who are deaf or hard of hearing to place in your room. You may want to consider buying one for travel, if you need, and bringing it with you.

Read the escape plan posted in your room. These often can be found on your hotel room's door. If one is not posted in your room, request one from the front desk.

Count the number of doors between your room and the nearest two fire exits. This will assist you in the need of an emergency evacuation through smoke.

Bring a flashlight; keep it near your bed.

Never smoke in bed.

Keep your room key by your bed, and take it with you if there's a fire. If you cannot escape, you may have to return to your room.

If you hear an alarm, leave immediately, closing all doors behind you.

Use the stairs – never use elevators during a fire.

To check the hallway for fire, touch the door with the back of your hand to test the temperature. If the door is cool, get low to the floor, brace your shoulder against the door and open it slowly. Be ready to close it quickly if there are flames on the other side. Crawl low in the smoke to the nearest exit; the freshest air is near the floor.

If all escape routes are blocked, return to your room. Shut off fans and air conditioners. Stuff wet towels or bedding in the cracks around the doors and vents. Call the fire department to let them know your location. Wait at a window and signal for help with a flashlight or light-colored cloth.

If the fire is in your room, get out quickly. Close the door, sound the

alarm and notify the front desk.

While these tips are for travelers, don't forget to make fire safety in your home a priority. For information on making your home fire-safe, download and print the State Fire Marshal's home fire safety checklist (<http://tn.gov/fire/fsk/documents/checklist.pdf>).

*The Hotel and Motel Fire Safety Act of 1990 was enacted by Congress to save lives and protect property by promoting fire and life safety in hotels, motels and other places of public accommodation. Fire safety in places of public accommodation is encouraged through creation of a National Master List (NML) of hotel and motel properties that voluntarily comply with the provisions of the Act. The U.S. Fire Administration encourages the traveling public to use the list when making reservations for lodging accommodations, be they for business or pleasure. FootGolf comes to Murfreesboro

The growing sport of FootGolf is coming to a golf course near you. The City of Murfreesboro Golf Department will kick off the new style of golf this weekend at its nine-hole executive walking course on property leased from the Department of Veterans Affairs, 3400 Murfreesboro Rd. in Murfreesboro, Tennessee. The 9-hole FootGolf will be played on the existing nine-hole course on a first come first serve basis at a cost of \$5.00. Soccer balls are available to rent for \$3.00 a day unlimited play.

"FootGolf is a fun sport that virtually everyone who can kick a soccer ball can play," said City Director of Golf Tracy Wilkins. "We hope the expanding sport of FootGolf catches on in Murfreesboro as it has elsewhere with the same excitement and enthusiasm that has 30 countries around the world playing it."

The sport of FootGolf is played in the traditional format of up to four players per group with FootGolfers either walking the course or using golf carts. Each player uses a standard size #5 soccer ball and takes turns kicking through a golf course, aiming for a FootGolf hole that is 21 inches in diameter. FootGolf uses golf's basic model with tee boxes, greens, bunkers, fairways and hazards.

Most rules of FootGolf correspond with the rules of golf. The player who plays the nine or 18 holes with the fewest shots wins. While the origins of FootGolf are not clear, it's

believed that enthusiasts began playing the game in 2008.

The first nine-hole FootGolf tournament on a golf course and played as the sport known today, was organized in the Netherlands in 2009. The American FootGolf League (AFGL) was established in the U.S. in 2011. The Murfreesboro Golf Department is partnering with the Murfreesboro Soccer Club to develop FootGolf tournaments in Murfreesboro and build enthusiasm for the growing sport.

"We already have a huge support base for soccer in Murfreesboro," added Wilkins. "This new opportunity for FootGolf can be enjoyed by young and old alike and provides yet another opportunity for recreation in our city."

The Veterans Administration Golf Course is only the second course to establish FootGolf in

Tennessee. The sport debuted at Smyrna Golf Course on April 1, 2014. The Veterans Golf

Course in Murfreesboro is a public course which opened in 1950 and has a standard walking rate of \$7.00 for juniors 17 and under and seniors 55 and over. All others pay \$8.00 to walk nine holes to play regular golf. The 9-hole round of



FootGolf will cost of \$5.00 with soccer balls available to rent for \$3.00 a day unlimited play.
