Man charged with shooting his neighbor

A suspect accused of shooting his neighbor was charged with attempted murder Tuesday afternoon by a Rutherford County Sheriff's detective, a supervisor said.

Suspect Steve Leslie Smith, 42, of Cedar Bucket Road near Readyville, was charged with shooting neighbor Timothy Lonning, 44, of Cedar Bucket Road, said Detective Lt. Todd Sparks. Lonning suffered multiple gunshot wounds.

The shooting occurred about 6 a.m. Tuesday in the neighborhood located near the Rutherford and Cannon County line.

Lonning was transport-

ed to Stones River Hospital in Woodbury then flown by LifeFlight helicopter to Vanderbilt University Medical Center where he is expected to remain. See SHOOTING, Page 9

Roach sisters' reign ends at MTSU

MURFREESBORO — More than 100 friends and well-wishers — from the MTSU campus and across the region — helped celebrate Betty Smithson's final working day at the university.

On the eve of flying to California for a family visit, Smithson retired Tuesday (April 28) after nearly 50 years at the university.

There were many hugs, lots of laughter and no tears as an era came to a close in the Office of the Vice President for Student Affairs in Keathley University Center.

Smithson is the last of the Roach sisters from Cannon County to retire. She spent 49.5 years, retiring as an administrative assistant to Vice President Deb Sells and ending a combined 142 years of dedicated service by the three sisters.

Eldest sister Martha Roach Turner, who started in 1958, retired after 45 years in what became the Career Development Center. Taking a sabbatical from the university in 1960, she referred her sister Frances Roach Rich as her replacement. Rich re-

tired with 48 years of service, completing her tenure in the Office of the President.

Smithson considered all the memories a half-century of service holds.

"Working with students ... involvement with them, and being able to help people" is how Smithson recalls her MTSU years, which began in 1965 just after graduating from Woodbury Central High School. "I enjoyed all MTSU football and basketball games. This has been a great thing for my family."

Former Student Government Association presidents Shane McFarland and Toby Gilley, now respectively Murfreesboro's mayor and General Sessions Court judge — value their friendship with her.

"Betty was my mom away from home," said McFarland, SGA president in the 1994-95 academic year. "She was the go-to person if you needed advice or help. She was one of my fondest MTSU memories."

"She was like a best friend and sister and mother, all rolled into one," said Gilley, See ROACH, Page 9

Five ways adult children hurt their parents without realizing it

Most people love and appreciate their parents. We don't doubt that. The problem is, parents can't tell this unless you show it by the way you treat them. Sometimes adult children can bring heartache to their parents without realizing what they're doing. We've boiled it down to five main ways this happens. If you are a parent of adult children, you may recognize some of these. If you're the adult child, you may be in for an awakening. As parents age, their physical needs may change but their need for your love never does. Check to see if you're doing any of these.

1. You don't call them much
Time just flits by, and you

realize it's been a month since you last called your parents to check on them or to share what's happening in your life. You may be thinking, well, they can call me anytime they want. There's no question; parents need to call their children, as well.

Here's the thing, they don't know your schedule, and they don't want to interrupt you at the wrong time. Or they don't want to trouble you with their problems. And yet, they want you to care. You need to take the initiative and call them, at least some of the time. Even just a short call to see how they are feeling. Ask them what they did that day then share what you are doing. Be sure to include some good news.

Too often, the only news shared is the bad. Being in on at least part of your life will bring them more happiness than you can imagine. If they lay on a lot of unwanted advice, just say, "Thanks, Dad, I appreciate your concern. I was just thinking about you and wanted to know how you're doing." Don't forget to say, "I love you." That's music to their hearts.

2. You ask them for money
Some kids only call when they need money. Don't do that. In fact, don't ask them for money at all. You're an adult and capable of providing for yourself and family. Your parents have worked hard for what they have, and they deserve to keep it for their needs.

As their lives wind down they have no idea what expenses lie ahead. They need that retirement nest egg for the unknown. It's comforting to them to have that security. We know some children who've bled their parents dry, and then when the day came and the parents needed the money

to live on it was gone. That's not fair. Don't ask your parents for money.

If you owe them for some you've already "borrowed," pay it back as soon as you can. Lovingly help them protect what's theirs. They need to be able to enjoy it in their later years.

3. You forget their birthdays

Parents love to be remembered on their special day. It doesn't have to be a fancy celebration, just a remembrance. You know how you feel when you receive a gift from them. They aren't much different. They like it, too. Find out the things they enjoy. A young couple we know gives their parents a gift card to their favorite restaurant, and they thoroughly enjoy it. If you don't have the money for a gift, you surely have the money for a card. Receiving a card in the mail from an out-of-town child brightens any parent's day. A phone call is great, too. If you live nearby, drop by with a hug and good wishes. Let them know you're thinking of them, and wish them a happy birthday. You might even add, "I'm sure glad you were born. I love you, Mom." Some children invite the family over to celebrate a special birthday. Turning 70 is a lot more fun when you're surrounded by those you love.

4. You don't offer them your help

You may be thinking, hey, I told Dad to let me know if there's anything I can do for him, but he hasn't told me of anything. He's probably hesitating because he thinks you're too busy, or he's afraid you didn't really mean it. How about suggesting something to him? Look around and see the needs. Older people are



advised to stay off ladders because their balance is impaired, and it's too risky. How about offering to come over, climb that ladder and clean out their rain gutters. A friend's son recently did that for his parents, and they were extremely grateful for the help. A little help from you will go a long way in helping your parents feel loved.

5. You don't include them in your family events

They don't need to be included in everything but for the main events, invite them. They want to be part of special occasions, such as holiday dinners, a baptism, a concert your child is in, weddings or a vacation. Let them enjoy being with you and your family when it fits. Sometimes just an invitation to Sunday dinner at your house will brighten their day. If they invite you and your family over for dinner, accept the invitation and show up.

Is this what you want?

Look at how you are treating your parents and ask yourself if this is the way you want your children to treat you when they're grown. They are learning how by watching the way you treat your parents. It's a lesson they won't forget. If you're not measuring up, it's not too late. You can make a change this very day. Begin by picking up the phone and calling your parents right now.

Even if you run smack into a wall on your way to making a life change, then at least you will have gained some insight and knowledge. You may even find this knowledge gives you courage to tackle more risks. No matter what the scenario, you will have gained the power and influence to decide your own response.

Imagine the best

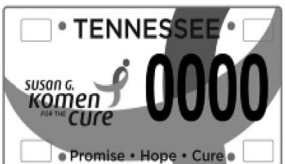

How were 'Yanks' described to young London females?

"Over sexed ... over paid ... over here!!" was a popular warning British parents recited to impressionable young daughters about 'Yanks' (American soldiers) during World War II.

Did the warning work? Not very well, for more than 70,000 U.S. soldiers brought British wives to America in wake of WW II.

"That's what our parents and grandparents warned when the 'Yanks' came to help us defeat Germany," confirms England native Diana Brockton. "We heard that warning 'over sexed, over paid and over here' over and over as warnings to stay away from those dashing handsome Yanks."

"Any gum chum?" was another chatty and cool question young Brit girls would ask American soldiers.

"Yanks, so handsome in their uniforms, usually had their shirt pockets and trouser pockets stuffed with gum and candy," recalls London native Helen German, who now resides in Rutherford County. "Before the Yanks would hand over a treat however, young Brit girls had to share their name and a personal note or two."

Don't let the "German" name fool you. "I've been in America now for 48 years, but I'm still a Brit through and through," noted Mrs. German, who heads the Middle Tennessee Chapter of the Transatlantic Brides and Parents Association, a British Heritage Society formed in 1946. "However, it wasn't until I moved to Middle Tennessee 11 years ago that I learned of and got involved in the Transatlantic Brides and Parents Association."

Today, the group has 18 members throughout Middle Tennessee who are planning on attending a national convention in Chattanooga. In the local groups' latest monthly meeting at Mrs. German's daughter Lorraine Petty's home in rural Rutherford County, they had displays showing Queen Elizabeth's picture, and a special display counting the days until Princess Kate (Windsor) gives birth to her second Royal baby. "Kate could give birth any day, any hour," noted daughter Lorraine, the second of four generations in Helen's family as members of the on-going Transatlantic Association and the national general secretary for the British Brides and Parents Association.

London native Fran Rosenthal, age 88, was 11 when World War II broke out in Europe.

"I try not to miss our monthly meetings," Fran shared.

For six years (1939-1945), Fran slept in a bunker (bomb shelter) after German Fuhrer Adolph Hitler ordered the bombing of London ... known in history journals as the "London Blitz!"

"My family had a backyard bomb shelter, made out of corrugated steel, and that's where we slept for six years," recalls Mrs. Rosenthal, today a resident of Adams Place in Murfreesboro. "Most bomb shelters had bunk beds; actually, we didn't think much about it. As a citizenry, we pulled together and got on with our lives the best we could. I hope Americans don't mistakenly assume the American homeland can never be attacked by foreign invaders."

When walking during daylight hours throughout bombed out London, Brits knew to organize their steps according to locations of public bomb shelters, Rosenthal recalled.

She described the biggest danger faced by London citizens? ... "Buzz bombs that were launched on us from across the English Channel. As long as we could hear the 'buzz' of the bombs, we didn't panic. We worried when the bombs stopped

'buzzing,' for that's when we knew the bombs were about drop out of the sky."

"I recall being evacuated multiple times due to the buzz bombs," noted Mrs. German, at age 80.

How severe was the danger and damage?

"As a young girl, I saw all of London in flames, and in rubble," Fran Rosenthal recalled.

So, how did British children pass the time of day when bombs were not raining down on them?

"We collected shrapnel, much like a hobby," Mrs. Rosenthal accounted. "It was a different way of living. But, we took the buzz bombs in stride ... you had to get on with life."

Did Fran know any "heroes?"

"My parents (Lewis and Marie Lipman) were heroes, especially Mother, who somehow kept us fed, although such things as eggs were rationed to one every three weeks. We were rationed to two ounces of meat. And we grew a lot of vegetables during the war when Dad, an engineer, was also a designated 'air watcher' who searched the sky for enemy aircraft and buzz bombs."

What was their primary pastime when not going through rubble and collecting shrapnel: "We often listened to Prime Minister Winston Churchill, and his 'blood, sweat and tears' inspirational talks on the radio. He was such a great man. While listening to him on the radio at night, all windows in London were blacked out."

Rosenthal and German are Jewish. "Hitler's Nazis never made it across the English Channel," German stepped back in time. "I've never understood why he and the Nazi Army never crossed the channel, but if they had, we could have been in one of the Nazi death camps."

The British ladies referenced more than 6 million Jews murdered in holocaust death camps the Nazi Army operated throughout Europe in German-occupied nations.

"At the start of WW II, my aunt and uncle back in England took in a Jewish refugee girl out of Germany, to save her from the Concentration Camps," Rosenthal recalled.

Rosenthal shared how she became a bride to an American soldier.

"My husband (Henry) was in the 8th Air Force, working in communications," she danced back in time. "We met at a social event for soldiers. No, Henry was not a good dancer, but he got my phone number. We were married for 64 years. It took us 15 days to cross the ocean to get to America."

Henry Rosenthal, who died five years ago, initially taught high school when bringing his bride to America.

"But, he hated that. He ultimately became a nuclear physicist, and we lived at Oak Ridge, Tenn., for a while," Rosenthal related. "He also served in Antarctica for a year. We moved to Murfreesboro nine years ago."

The Middle Tennessee-based Transatlantic Association recently held a mini-convention in nearby Chattanooga, where a big national convention is slated in 2016, for the organization's 70th anniversary.

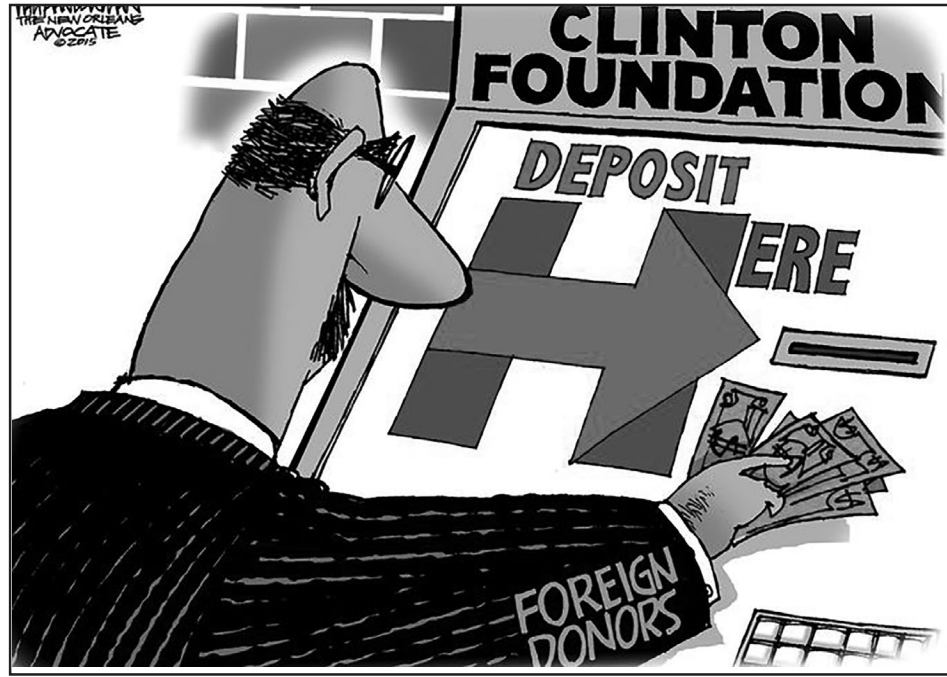
"We originally were formed for support of the young British brides who came to America," German noted. "Now, descendants can belong."

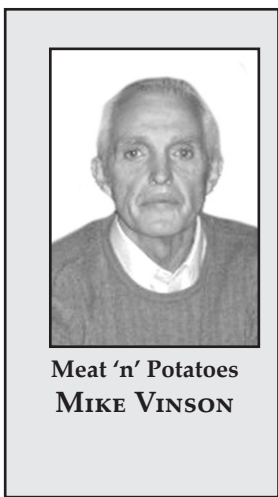

Hiding in the closet in TN

As of this writing, "gay marriage" is being argued in the U.S. Supreme Court, in Washington, D.C., with many Tennesseans in attendance. Current Tennessee law upholds a marriage consisting of one woman and one man. However, Tennessee law does not recognize same-sex marriage.

According to reports, U.S. Supreme Court Justices have "sharply questioned" both sides of the case. Ultimately, the Supreme Court will consider and make a decision on two issues: whether states must license gay marriages and, also, whether states must recognize gay marriages licensed out of state.

As reported in the April 29 edition of "The Tennessean" (page 9A), here are a few of the questions U.S. Justices must ask and answer in reaching a decision:

*Why to change a definition of marriage that has been accepted for "millennia"?

*Whether the court or the voters should decide the issue of gay marriage?

*How, as some states had claimed, allowing gay marriage hurts heterosexual marriage?

*Whether banning gay marriage was discrimination based on sex?

*What other types of marriage could be allowed, such as polygamy, if the court redefines marriage?

Most will agree the above questions are relevant and appropriate. However, at the epicenter of this gay marriage debate—for advocates, adversaries, and lawmakers, alike—is "family dynamics," which translates to: Would children raised by a lesbian female couple or a gay male couple have as good a chance at becoming healthy, productive citizens as would children raised by a traditional heterosexual couple, a man and a woman?

One could argue a potentially athletic male would have a greater chance turning out feminine if raised by a lesbian couple. Still, a potentially feminine female might have a greater chance at turning out masculine if raised by a gay male couple...and the arguments are exponential.

All this hype about the pros and cons of gay marriage forces me to recall my days as an active duty soldier in the U.S. Army (many decades ago). Back in those days, if a male soldier, regardless his ability

and potential, displayed even the least bit of femininity, he was immediately pounced on by superiors and, in most cases, run out of the Army. On the flipside, though, if a masculine lesbian soldier—"butch" being the derogatory term—could compete with the regular male soldiers, she was accepted as "one of the guys," to pun a bit. In all brutal honesty, I think a primary reason behind the lesbian soldiers being readily accepted was many of their male superiors "fantasized" about a having a tryst with the lesbian soldier and her female partner.

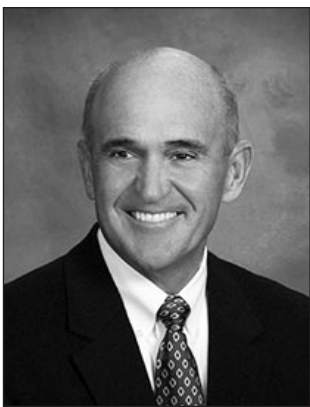

New Options Offered with 2015 Ag Enhancement

TAEP is a cost-sharing program. Producers fulfill requirements to defray the costs of strategic investments in their operation. Farmers can qualify for up to 50 percent cost share, with a maximum reimbursement of up to \$15,000, depending on the project. Producers may apply online or submit an application by mail, which must be postmarked June 1 through June 7.

A few of the Changes for 2015/16 include:

- Bull cost share program increased to \$1,600 for eligible bulls with enhanced EPDs
- Limit to 4 lifetime grain bin reimbursements
- Reimbursement documents can be uploaded online
- Eligibility rules simplified to one application per person per schedule F
- New bred beef heifer cost-share

Remember, the application period is June 1st thru June 7th 2015. Applications completed online or mailed prior to June 1st or after June 7th will not be accepted.

pected to recover. Deputies responding to the scene were unsure of Smith's location. As a safety precaution, deputies evacuated neighbors. The Felony Arrest Search Tactical Team, the Special Operations Response Team, Emergency Medical Services and Emergency Management Agency responded.

Patrol Lt. Rhett Rankin made contact with Smith and convinced him to surrender peacefully.

Sheriff Robert Arnold said Lt. Rankin and all the emergency responders did an "outstanding job."

"We are glad there was a peaceful ending

and everyone is safe," Sheriff Arnold said.

Lt. Sparks said detectives interviewed Lonning and other witnesses.

"There was a recent history of problems between them," Lt. Sparks said. "We are still trying to determine what hap-pened."

Detectives processed the scene, served a search warrant and collected evidence. They are still investigating.

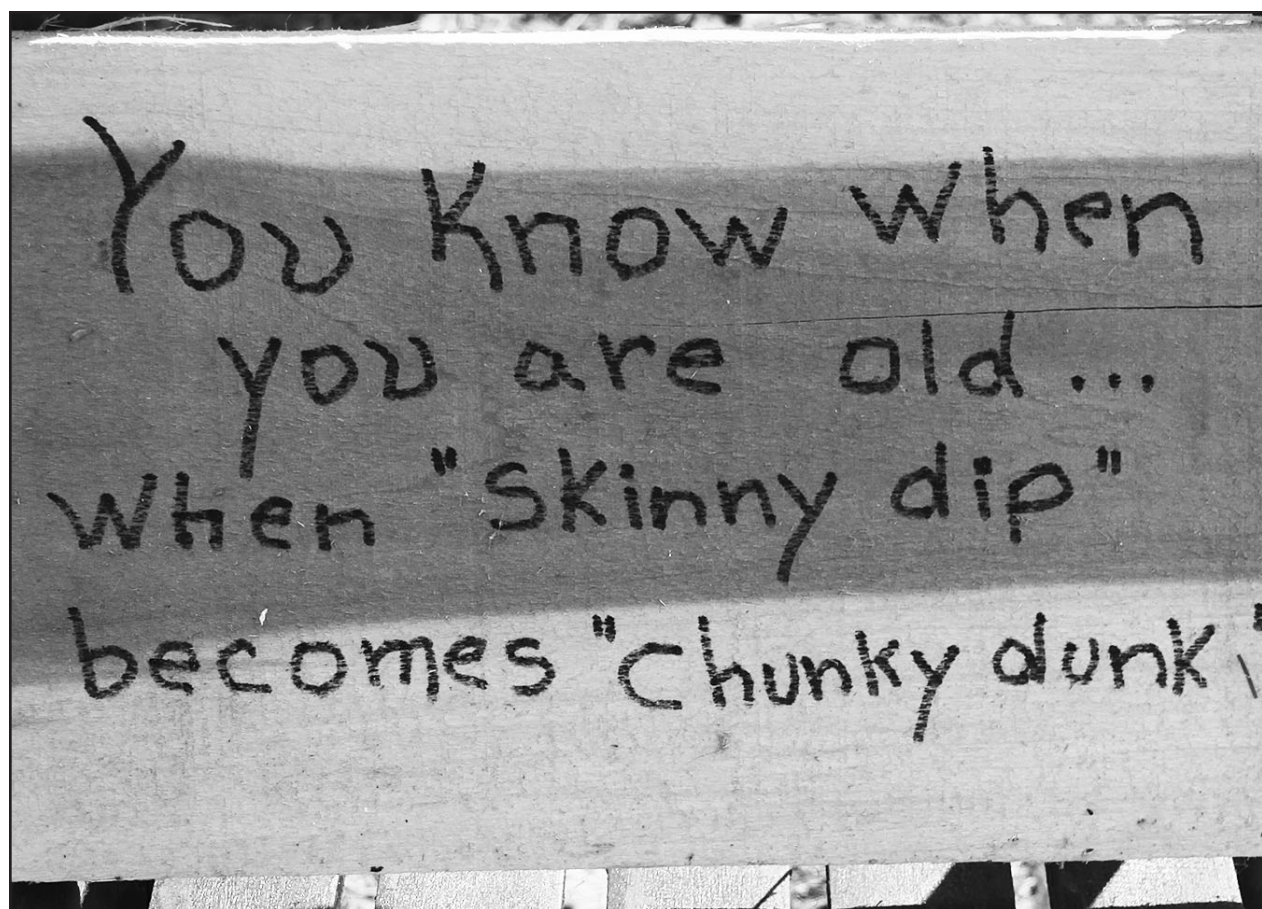
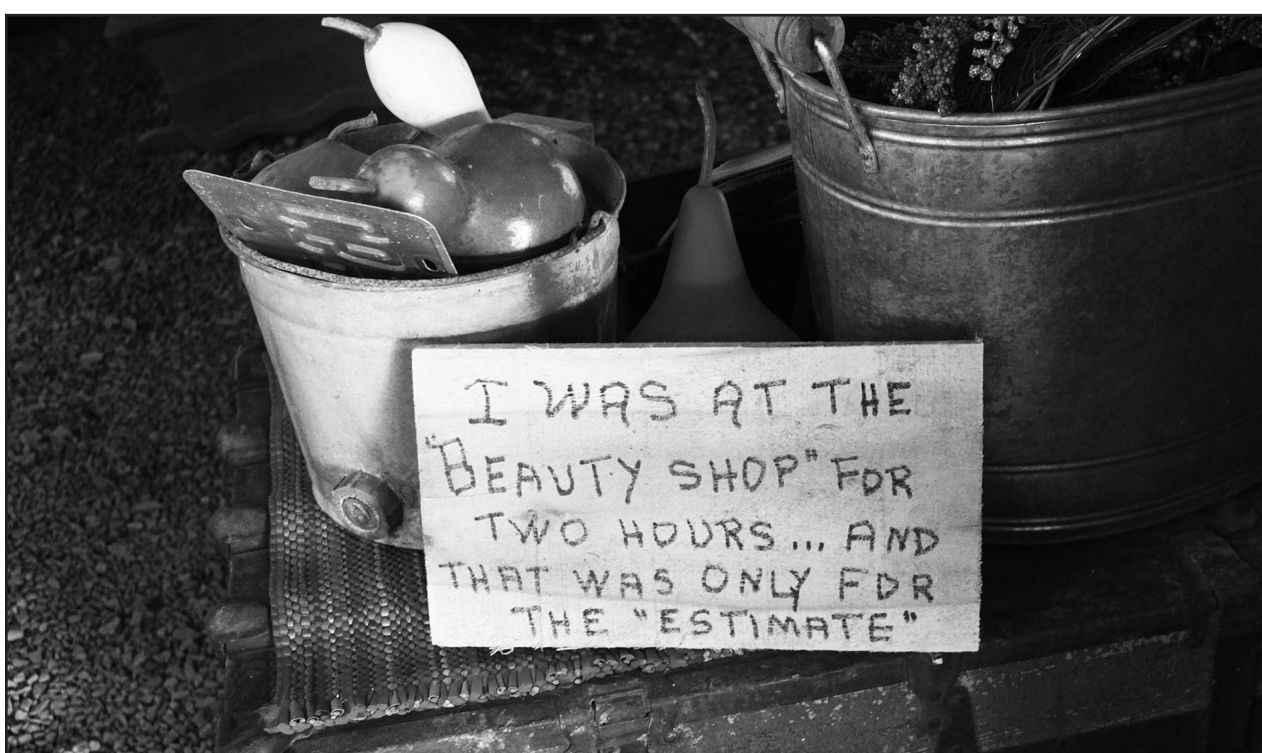

Ag Crime Unit charges two

NASHVILLE — Investigators with the Agricultural Crime Unit of the Tennessee Department of Agriculture have charged a man and woman in connection with theft and bad checks written for 298 cows valued at \$428,010.66.

Captain Phil Fedun and investigator Mike Whaley learned that a man and woman were writing worthless checks at Middle Tennessee stockyards to purchase cattle. Most of the cattle were then transported to Kentucky and sold.

On April 28, Johnnie Andrew Fisher, 33 of Lawrenceburg was arrested and charged with Theft of Property for a writing a check on a closed account totaling \$151,454.50 to Tennessee Livestock Producers.

On April 30, Casey Delaney, 27 of Russellville, Ky. was

arrested at a family member's home in Springfield. Delaney faces Worthless Check charges in Lawrence County and Maury County for writing bad checks totaling \$276,556.16 at the Lawrence County Stockyard and Tennessee Livestock Producers.

The Kentucky Department of Agriculture investigation unit and Kentucky law enforcement provided assistance in the case.

Fisher was bonded out of jail. Delaney remains in custody. The investigation is ongoing and additional charges may be pending.

Breech pregnancy corrected with chiropractic - A case study and literature review

On January 13, 2015, a study was published documenting the case of a pregnant woman with a transverse breech pregnancy being corrected under chiropractic care. The study also reviewed a number of other such cases documented in research adding to the body of evidence showing chiropractic helping with this issue.

A Transverse Breech Pregnancy is when a fetus is lying across the womb with the spine perpendicular to the mother's spine. Later in pregnancy, the baby should be head downward in preparation for birth. The authors report by the 28th week of pregnancy, about 4% of women have a breech pregnancy. Of these, it is expected 86% will deliver via cesarean section. Nationally, the rate of cesarean birth continues to rise, being at 31.6% in the year 2010.

In this case study a 31-year-old pregnant woman went to a chiropractor for help. She had been diagnosed by her obstetrician with transverse breech malposition, confirmed by ultrasound, at 30 weeks gestation. She was also suffering from lower back pain.

A chiropractic examination was performed involving a postural analysis which showed imbalances in her posture. Additionally, palpation showed tight lumbar musculature and spinal malpositioning. Static electromyography, or sEMG, along with thermographic scans were performed revealed areas positive for the presence of subluxations. Based on the examination, it was determined that the woman had subluxations at the top and bottom of her spine.

Chiropractic adjustments were begun to correct the subluxations along with a specialized technique called the Webster technique. This technique addresses the

subluxations in the base of the spine as well as easing tender nodules in the round ligament of the pelvis, thus addressing in-uterine constraint. This care was given to the woman twice per week for the remainder of her pregnancy.

On her eighth visit, the woman reported



her baby was no longer in the breech position and had turned into the normal vertex presentation. As a result the study noted, "The patient continued care and was able to have a natural, assisted homebirth and healthy vaginal delivery of a baby boy, in the presence of her midwife and family."

The author summed up this study in their conclusion by saying, "This report of a 31 year old multiparous [having borne more than one child] female patient presenting with transverse breech presentation utilizing Webster technique during her pregnancy proved to be effective. Receiving chiropractic care during pregnancy, specifically utilizing the Webster technique, helped to reestablish normal sacral alignment and biomechanics of the female pelvis."

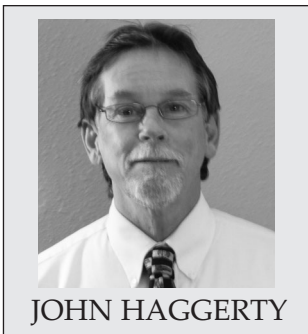

401K's Panacea or problem?

For many years, Americans relied on two basic forms of retirement: pensions and social security! The former was tied to your job, the latter a federal program enacted after the great depression in 1935.

In 1978, a new retirement vehicle was born; the 401k. In essence, the 401k changed the retirement landscape by shifting the burden (risk) from the employer to the employee. As a nation we went from a defined benefit plan to a defined contribution.

Genesis 17 and 18

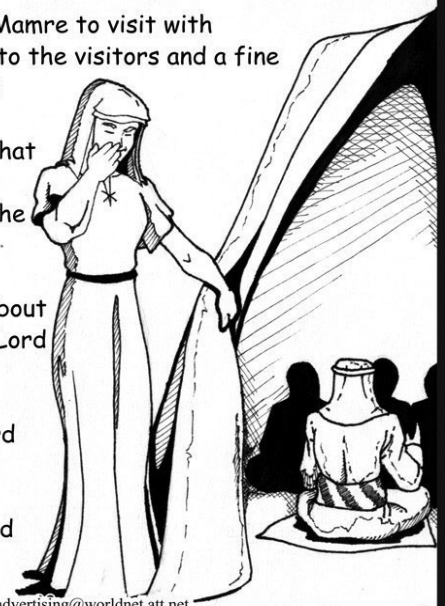

Then Jesus was led up by the Spirit into the wilderness to be tempted by the devil. And after fasting forty days and forty nights, he was hungry. But he answered, "It is written, 'Man shall not live by bread alone, but by every word that comes from the mouth of God.'" He also offered Jesus an easy way out...to take the world's kingdoms from Satan...showing that Satan is the god of this world (2 Cor 4:4) otherwise how could he offered them to Jesus? What Satan was really trying to do was to get Jesus to go around the cross which meant we would not have been saved from our sins. Like Israel in the wilderness, they needed the daily bread and so do we and the Word of God because as Jesus said, physical bread (or food) is never enough to keep Satan away. He needed the Word of God and so how much more do we need it. We need the daily Bread of Life which is Jesus and the Word of God, the Bible to resist temptation and memorize it when we are tempted like Jesus was. Do you really think getting fed at church once a week for less than an hour is enough to keep temptation away? No, you need to be into the Word daily.
