Are you a horse fan? Then you need to add Saturday, Nov.21 to your calendar

Ferrell Hollow Farm, senior horse sanctuary, will have a rare open house on that day from 10 a.m. to 3 p.m. The farm is located at 323 Ferrell Hollow Road, Readyville, 37149. "Our mission is to advocate and care for special needs senior horses that require a permanent sanctuary setting, who are not afforded adequate care if left in their current situation," said Cindy Daigre, executive director.

Ferrell Hollow Farm are big, draft horses rescued from the kill pen.

"We have 14 horses here and that's just about all I can take care of," Daigre said. Many of them were draft horses and others were carriage horses.

One horse, a big Clydesdale named Liz, was a victim of the PMU industry,

urine," Cindy explained.

They are then released to have their colt, only to be impregnated again in a cycle that only ends with the horse's death. "It's just back and forth, back and forth," she said.

This process left Liz fearful of people, Cindy said. "For me to touch her was a no-no," she explained.

tle TLC, the Percheron has gained a good feel for the big paddock where he stays with Liz much of the day.

"Dealing with a blind horse was a learning experience for me. We kept him fairly confined at first, but he began to learn the area with only an occasional mishap," Cindy said, laughing as Liz tried to hide behind the big white horse at the approach of a photographer.

Most of the horses at Ferrell Hollow are "elderly" with the oldest more than 30 years old. Most of them were acquired out of state.

"All of them are very laid back and gentle," she said.

Some of them have had a hard life and were injured doing heavy work. Many of them wear padded, rubber shoes to reduce the strain of their hooves. Others have jaw and tooth troubles. Some arrive at the farm emaciated, just skin and bones.

Heroin, pot & pills seized

At least four individuals face multiple drug offenses following a raid in Bradyville by the Cannon County Sheriff's Department.

Arrested were Daniel Glen Myers, Darcy Simpson, Benjamin Poteet and Terry Wayne Morton. They were charged with possession of drugs and possession of drug paraphernalia. Myers, Simpson and Morton were also charged with possession of a fire arm.

Officers, accompanied by representatives of the National Guard Counter Drug Task Force, raided a home at 10342 Jim Cummings Highway in Bradyville.

"I had started an investigation into this location and its habitants around one month ago after receiving information that drug activity was taking place along with the male subject that lives at this residence being a convicted felon in possession of firearms," said Investigator Brandon Gullett.

Gullett learned that the home was owned by Daniel Glen Myers and Nicole Foster, Myers' wife.

Veterans Day is quickly approaching with a weekend of events set for Nov. 13-14.

It will be a day of continued mourning by the friends and family of the late SSG Frank Walkup III, who passed away suddenly on Monday, Nov. 2. Walkup served in the U.S. Army from 1986-1994 during the Operation Desert Storm era.

Of Frank's 9 children, whom he considers to be his greatest accomplishments, four of his sons served or are still serving in the U.S. Army. Three were/are officers, and one was enlisted like his Dad.

The annual Veterans Day Program at the Cannon County High School is set for 8:30 a.m. Friday, Nov. 13 and the Veterans Day Parade is at 1 p.m. Saturday, Nov. 14.

It's the 23rd year for Col. Jim Stone to lead the Veterans Day Program at CCHS and the Veterans Day Parade.

"These 23 years have been a wonderful experience and a great honor for me and all of wonderful folks who have supported these events over the years," said Stone.

"All the credit goes to brother Tom Nichols. Brother Tom called me 23 years ago and asked if I would help honor our Veterans in Cannon County. I said that I would give it a shot. Through the years brother Tom always would laugh and say, look at all the fun we are having," the colonel said.

"But, the amazing thing about this story is, brother Tom Nichols is not a

veteran. He wanted to be one and tried to enlist but medical reasons kept him from being able to sign on. He remembered the soldiers when they were on maneuvers in the 40's, all over Middle Tennessee, and he wanted to be a soldier, like many of the young boys. We wanted to defend this great country," Stone said.

If you look at the right-hand circle, and check it carefully, you will learn that it is on every National Cemetery in the United States .

A TRIBUTE TO WILLIAM B. (BILL) SMITH

My first memories of Bill Smith was when I would go to the old Bank of Commerce on the west side of the town square. Bill was a teller and he would take my money that I had made selling eggs and deposit it to my savings account through the teller window for "Little Savers." I also remember my great uncle Sheila (Bush) Hawkins working at the bank with Bill. We would always go and ask him a question. He would always get excited and say, Bush! Bush! Then maybe he would answer. But we would laugh because he would say Bush! Bush!

To jump ahead a little, I remember when they moved from the old bank location to the new location where Regions Bank is today. I remember them moving some of the money in a mule drawn wagon, with Mr. George Gilley (Charlie Brown's father) driving the wagon, and Mrs. J.F. Adams riding shotgun with the Town's only policeman, Jack Rains, riding in the back of the wagon with a shotgun, guarding the money.

One story Bill always told, was when a gentleman came to him one day and asked him, "How did you get all of the money moved from the old bank to the new bank?" Bill just smiled and said, "Well that was easy, we just wrote a check for all of the money we had in the bank and when we got to the new bank, we cashed it".

Another early memory of Bill, was when he oldest son, Mike, who was about 6 years old, got run over getting off his school bus in front of their house on Highway 70. The whole town was just crushed by the sad news. Back in them days all of young boys would gather in the front yard of the old hospital (Now the Cannon County School Board) and we would play football. I remember one evening we were playing and it was getting late and turning dark. I looked up at the hospital, and I could see Mike's hospital room, the shades were drawn, but I could see Bill's silhouette through the shade, as he was standing at the foot of Mike's bed, with head down, praying. I remember that image just like it was yesterday. The good news

was that Mike was going to pull through. The town folks rejoiced. Then tragedy hits again. Some months later Mike came down with Polio or Muscular Dystrophy. Again, the good news was, Mike pulled through. I can still see Mike cutting those cedar trees and selling them at their home on old 70S. Mike was younger than me, but he was always an inspiration to me. I always said, "When things get tough, the tough get going. And, when things are too tough for everybody else, they are just right for me". - That is what Mike Smith taught me. I also remember Bill's wife Dot Smith. She was a beautiful young woman who loved Bill and her children Mike and Steve. She was very athletic, as I would see her and Christine Dillon always playing basket ball together, having fun and having a great time.

Bill always had a story to tell. He said that he was plowing with mules in a corn field one day, and R. D. McBroom stopped and said, "Bill I just bought a brand new truck from Alexander Chevrolet, and that he needed a driver." Bill, said give me a couple hours to find someone to finish plowing and I will get cleaned up and be right there. That started his trucking with the McBroom Truck Lines

in McMinnville. Bill also told the story, that they were coming back from Chattanooga one night with a truck load of pies, apple pies, still hot right out of the factory. Well he said the highway patrol stopped them around Monteagle, and wanted to know what they had in the truck. Bill and his partner opened up the back of the truck and reached in there and pulled out one of those hot pies, and said here try this. He said they both took a bite, and a couple more pies, and said, well you boys can go on now.

Mr. Tip McBroom and his sons R.D. and Sam, sold the old McBroom Truck Lines when the union moved in. R.D. and T McBroom moved back to Woodbury, next to the Bill Smith farm, where WT McBroom and I are still neighbors. Bill told me that as a young boy he would plow, using a team of mules, the field where our house is located. He always said that field was the best farm land in the county. After the trucking business, Bill still trucked a little and began his career in the banking business. The McBrooms started a milk barn operation, milking about a 100 cows twice a day, 365 days a year. Frances always said those were tough years, after the good years in McMinnville. I always told her, that it was really a blessing. She said how can that be a blessing? I said well, just think, if you had not moved back to Woodbury, you would not have met me and married me. So she was alright after I told her that story. Frances loved Bill and had many stories they would tell when they were all at McBroom Truck Lines and living as neighbors, and having Bill's brother, George, living next door also. Bill and George would help R.D. and

WT. I can still see George rounding up the cows on that spotted horse, riding like the wind, and sitting high in the saddle like John Wayne. As a young boy we worked with for Bill Smith and would haul hay all day, for several days, in the hot July, August, and September months. We all worked hard, but we had fun and a lot of laughter. Bill always reminded me of Paul Bunyan, the lumber jack, who owned Babe the Blue Ox. He was a tough, rough, and a strong man, always working hard, with great enthusiasm, and having fun and laughing. Nothing was too tough for him. Bill was like Paul Bunyan, a true work horse

A big event for the community was the, "Beans and Cornbread Day", Bill was always doing great things for the town and county folks. I came home from the wars one day and called my mother, "Granny Stone", who was not at home. I said where are you? She said I am in the basement of the Bank picking beans. I said good, I will be there in a minute, to see what picking beans meant. She was preparing to cook the pinto beans, but first she would have to pick out all of the little rocks and gravel that were mixed in with the beans. I remember there was a small pile of rocks and gravel on the table that she had separated out. I was shocked that there were rocks and gravel in the bags of store bought pinto beans. Just think of the people who broke their teeth off eating pinto beans. So, after that I always looked for rocks when preparing dried pinto beans, and especially when eating pinto beans. And believe me, they are there. Granny dearly loved Bill Smith and the ladies that worked at the Bank of Commerce, she

and Tootsie and Hayden Scott cooked and prepared the beans and cornbread for Bill for over 20 years. They also cooked many meals for the bank. And, that same team cooked meals for the Lions Club for over 20 years. They had fun and a lot of laughter working together.

I told Bill at his retirement reception at the bank, that I had listed him on my military records as a Character Reference when I signed up for the military 35 years ago and had kept it updated all those years.

Bill Smith did a lot of good and great things for our community. Beans Cornbread and Day, Cannon County Good Old Days, restoring the Brevard House, Smith's Funeral Home, working and helping to produce the 1995 Cannon County Pictorial History book, and others, because he didn't want us to forget our past, our proud heritage, and our proud history. Bill Smith was a great ambassador for Woodbury, Cannon County, Tennessee, and the United States of America. Bill Smith was a true example of a model citizen, one for all to emulate. He was more than a great character that we will always remember. He was a great supporter of the Veterans of Cannon County. He was a good Christian man. I always said, "If everyone was like Bill Smith, just think what a great country we would have". And, I also think about what is written in the Bible, that there are Angels walking amongst us on earth. I believe that with all of heart. Well, in my opinion, Bill Smith was one of those Angels. And I know that he will keep an eye on us back here in dear old Woodbury and Cannon County.

'Bridge of Spies' linked to the MLK Assassination?

Regarding the pivotal '60s, two catalysts forever altered our society: (1) America's "Cold War" with Russia. (2) The Civil Rights Movement. With that in mind, the recent release of Steven Spielberg's movie "Bridge of Spies" highlights a "connection" between U.S. intelligence services and the assassination of Reverend Martin Luther King Jr. November 1957, Rudolph Abel was imprisoned for being a Russian spy operating in New York City. From 1954-1975, James Jesus Angleton headed the CIA's Counter-Intelligence/ CI unit. A plausible assumption is Angleton's CI group played some role in uncovering Abel's true identity, and subsequent arrest. Abel was defended by New York-based Attorney James B. Donovan (Hanks' character in "Bridge of Spies"). In the late '50s, the CIA developed the U-2 spyplane program to gather intelligence on Russian activity. May 1, 1960, U.S. Air Force Captain Francis Gary Powers was shot down in his U-2 plane by a Soviet surface-to-air missile. Powers was taken prisoner by the Russians, and considered a valuable captive. Arguably, Reverend Martin Luther King Jr., a black Baptist minister from Atlanta, Georgia, was the most influential force, ever, for the Civil Rights Movement. Though King's platform was one of "nonviolence," many of his marches resulted in violent rioting. An orator of near-celestial bearing, King openly denounced American presence in Vietnam. Certain governmental entities felt King posed a threat to national security. At approximately 6 p.m., April 4, 1968, in Memphis, Tennessee, Martin Luther King Jr. was fatally struck

by a single .30.06 bullet as he leaned across the railing of the second-floor balcony of the Lorraine Hotel & Motel, where King and entourage were lodging. April 11, 1968, the

FBI announced it was looking for "Eric S. Galt" in connection with King's murder. Richard Ober worked directly under James Jesus Angleton in the CIA's CI unit. April 18, 1968, Richard Ober opened a 201 File (Person of Interest) on Eric S. Galt (a Canadian-based alias used by Ray). April 19, 1968, the FBI publicly announced it now was looking for James Earl Ray in connection with the King assassination. The manhunt for Ray was the largest in the Bureau's history, a reported 3,000 agents assigned to apprehend him. A white, career criminal and a fugitive from the Missouri State Penitentiary, James Earl Ray was arrested in London on June 8, 1968. Jailed in Memphis for nine months under harsh conditions, threatened with the electric chair, Ray entered a "guilty plea" on March 10, 1969, receiving a 99-year sentence. James Earl Ray died April 23, 1998, at age 70, going to his grave denying he shot Reverend Martin Luther King Jr. Expectedly many are convinced Ray was the triggerman, while many are convinced Ray was not the triggerman. The "connection" between King's assassination and "Bridge of Spies" is a man named Fred T. Wilkinson, who, on the cold night of February 10, 1962, was hand-picked by the CIA to walk sideby-side with Russian spy Rudolph Abel across the Glienicke Bridge, in Berlin, Germany, and trade Abel to the Russians for American U-2 pilot Frances Gary Powers. In 1965, Wilkinson was appointed Director of the Department of Corrections

for the state of Missouri. Wilkinson still was Director of Corrections for Missouri when Ray escaped from the Missouri State Penitentiary, April 23, 1967.

In his historically edifying book, "The Martin Luther King Congressional Cover-Up: The Railroading of James Earl Ray" (pages 95-98), author John A. Emison sheds light on dark facts: Though there is mention of the CIA attempting to help the FBI "locate" Ray, Ober's 201 file on James Earl Ray indicates the CIA was mostly interested in whether Ray would get a "full trial" – both before Ray was arrested and after he was arrested. Why would the CIA have been interested in whether James Earl Ray received a "full trial," and seemingly nothing else? Emison further states, for the record: "I argued in my book that the CIA likely ran the operation to murder Dr. King; that James Earl Ray was a CIA intelligence 'asset' controlled by a man known only as 'Raoul'; that Fred T. Wilkinson was almost certainly connected to the CIA's James Jesus Angleton. Though I challenged the accuracy of Gerald Posner and Hampton Sides, both of whom wrote books adamantly claiming James Earl Ray murdered Reverend Martin Luther King Jr., neither of them have ever disputed my assertions about Angleton, Ray, Raoul, and Wilkinson." Rudolph Abel... Gary Powers...U-2 spy plane...James Earl Ray allegedly assassinating Martin Luther King Jr.... CIA keeping a 201 file on Ray...Fred T. Wilkinson... it is sufficient cause to pause, ponder, and wonder: Is there a bridge "connecting" the above?

Flu Shots Available

at Health Department

Seasonal influenza vaccine is now available at the Cannon County Health Department. A flu vaccine clinic will be offered Nov. 4, 9, 16, 25 from 9 a.m. to 1 p.m. and Nov. 18, 23, 30 from 1 p.m. to 4 p.m. at the Cannon County Health Department. No appointment is needed to get flu vaccine. Flu shots will be provided during the vaccination clinic. The cost of the flu shot at the health department is \$30. Payment can be made in the form of cash, check or credit card. The health department will file insurance claims for flu vaccination for patients with traditional Medicare, TennCare,

Community Health Alliance, Cigna private insurance or marketplace plans or BlueCross BlueShield private insurance or marketplace plans (Networks S, P and E). Adults with other private insurance or other marketplace plans will be charged the full amount for vaccine and vaccine administration and given a receipt to file their own claims with their insurance providers. Children through 18 years of age who are uninsured or have private insurance plans that do not cover flu vaccination are eligible to receive flu vaccine with a nominal charge for administration of the vaccine, based on income. Uninsured adults will be charged for the flu vaccine and vaccine administration on a sliding fee scale based on income.

Outdoor Burning Permits

It's again fire season in Tennessee, and the Division of Forestry is reminding everyone in Cannon County that if they intend to do any outdoor burning they are required by state law to obtain a burning permit. The free permits are required October 15th through May 15th and can be obtained by telephone or online. A poorly prepared or unattended burning debris pile can, under the conditions common in autumn, escape control and become a destructive wildfire. The Tennessee Division of Forestry asks

everyone to be cautious when doing any outdoor burning. Before doing any outdoor burning: First call the Division of Forestry for a burning permit at 615-765-7373 between 8 a.m. and 4:30 p.m. Monday through Friday (call on Friday for the weekend) or obtain a permit online at www.burnsafetn.org. If weather conditions permit you will be issued a burning permit. If the permit is obtained by phone they will also advise you of any weather conditions such as predicted wind, low humidity or other factors which might call for extra precaution.

Red Cross Offers College Scholarships.

This winter high school and college students can help save lives and be eligible to win a scholarship of up to \$2,500 by hosting an American Red Cross blood drive. Registration is now open through Nov. 15 to host drives between Dec. 15, 2015, and Jan. 15, 2016. The Leaders Save Lives program encourages community-minded high school and college students to host blood drives to help maintain the blood supply around the winter holidays. Blood donations made at high school, university and college blood drives account for as much as 20 percent of blood donations through the Red Cross. Around the winter holidays, when school is not in session, blood donations often decline.

Students who host a drive can be eligible to win a scholarship up to \$2,500 for higher education and earn a gift card. A total of six scholarships will be awarded to students who host a blood drive collecting 25 blood donations or more. The poll began by "Of all the asking, currently candidates running for president, can you please name the one person you would most like to win the election?" The question offered specific candidate no names. The poll's sample registered of voters responded:

Carson (R): 19 percent

- Hillary Clinton (D): 16 percent

 Donald Trump (R): 14 percent

- Bernie Sanders (D): 5 percent

The field's remaining candidates posted in the lower single digits.

Most Tennesseans opposed to allowing same sex marriages

Most Tennessee voters remain opposed to letting gay couples marry legally, according to the first MTSU Poll taken since this summer's U.S. Supreme Court decision declaring same-sex marriage а constitutional right.

Meanwhile, about half of Tennessee voters think abortion should be against the law in most or all cases, and attitudes on both issues break sharply along religious and political party lines.

"Reflecting patterns in previous MTSU Polls, opposition to the legality of both same-sex marriage and abortion runs highest Tennessee's among evangelical Christian and Republican voters," said Ken Blake, director of the poll at Middle Tennessee State University. "In both groups, sizable majorities think it should be unlawful for same-sex couples to marry and think abortion should be illegal in most or all cases."

The poll randomly surveyed 603 registered voters statewide by telephone Oct. 25-27 and has a margin of error of 4 percentage points.

Same-sex marriage

On the question of samesex marriage:

57 percent say they either "oppose" (18 percent) or "strongly oppose" (39 percent) permitting samesex marriage.

29 percent either "favor" (18 percent) or "strongly favor" (11 percent)

allowing such unions. A substantial 14 percent don't know or decline to answer.

Opposition to the legality of same-sex marriage is especially strong among state voters who are evangelical Republicans, Christians, and age 60 or older. In each of those groups, about two-thirds of voters express opposition.

Same-sex marriage finds majority support (62 percent) among nonevangelical voters in Tennessee and falls just short of majority support (49 percent) among those age 18 to 34.

The 57 percent opposition to same-sex marriage found among Tennessee registered voters in this latest poll is statistically equivalent to the 55 percent opposition found in this past spring's poll of all Tennessee adults.

It is significantly higher, though, than the 38 percent opposition recorded nationally by the Pew Research Center when it fielded the same question this past July. In that poll, a 54 percent majority expressed support for same-sex marriage, with only 7 percent undecided.

Abortion

Regarding abortion:

53 percent of the state's voters think abortion should be against the law either in "most cases" (31 percent) or "all cases" (22 percent).

percent think it 39

should be legal in either "most cases" (25 percent) or "all cases" (14 percent).

Around 8 percent don't know or decline to answer. As with opinions on same-sex marriage, opinions on abortion break sharply along religious and political lines. Šixtytwo percent of evangelical Christians, and 70 percent of Republicans, think abortion should be against the law in most or all cases. By contrast, 58 percent of non-evangelicals, and 59 percent of Democrats, think abortion should be legal in most or all cases.

Methodology

Interviews for the poll were conducted by Issues & Answers Network Inc., which completed 603 telephone surveys among a random sample of registered Tennessee voters aged 18 and over.

Data was collected using Tennessee statewide voter registration sample with a mix of 60 percent landline and 40 percent cell phones. The average interview length was nine minutes.

Quotas by gender and geographic region were implemented to ensure the sampled respondents representative were of Tennessee's adult population. U.S. Census Bureau data were used to determine the gender distribution each of Tennessee's Grand Divisions: East, Middle and West.

Following the Civil War, it deteriorated from a majestic mansion to virtual ruins and, in the 1950's, its very existence was threatened. The mansion was brought back from the brink of destruction, saved from the wrecking ball when a group of concerned ladies created Oaklands Association in 1959. Since that time, the Association has worked tirelessly to restore Oaklands to its original splendor and preserve its unique history.

Today, local residents and visitors alike enjoy the mansion that has been lovingly restored and brought back to its former glory. The proceeds of the Candlelight Tour of Homes go toward the continuing preservation of this historic treasure. Shadrach, Meshach, and Abednego

About 600 years before Jesus Christ was born, King Nebuchadnezzar of Babylon besieged Jerusalem and took captive many of Israel's finest citizens. Among those deported to Babylon were four young men from the tribe of Judah: Daniel, Hananiah, Mishael, and Azariah.

In captivity the youths were given new names. Daniel was called Belteshazzar, Hananiah was called Shadrach, Mishael was called Meshach, and Azariah was called Abednego.

These four Hebrews excelled in wisdom and knowledge and found favor in King Nebuchadnezzar's eyes. The king put them into service among his most trusted wise men and counselors. When Daniel proved to be the only man capable of interpreting one of Nebuchadnezzar's troubling dreams, the king placed him in a high position over the whole province of Babylon, including all of the wise men of the land

As was common at the time, King Nebuchadnezzar built a huge golden image and commanded all the people to fall down and worship it whenever they heard the sound of his musical herald. Anyone who failed to bow and worship the image would be thrown into an immense, blazing furnace.

Shadrach, Meshach, and Abednego were determined to worship the One true God only, and thus were reported to the king. Courageously they stood before him as the king pressured the men to deny their God. They said, "O Nebuchadnezzar, we have no need to answer you in this matter. If this be so, our God whom we serve is able to deliver us from the burning fiery furnace, and he will deliver us out of your hand, O king.

Furious with pride and rage, Nebuchadnezzar ordered the furnace to be heated seven times hotter than normal. Shadrach, Meshach, and Abednego were bound and cast into the flames. The fiery blast was so hot it killed the soldiers who had escorted them.

But as King Nebuchadnezzar peered into the furnace, he marveled at what he saw: "But I see four men unbound, walking in the midst of the fire, and they are not hurt; and the appearance of the fourth is like a son of the gods." (Daniel 3:25, ESV)

Then the king called the men to come out of the furnace. Shadrach, Meshach, and Abednego emerged unharmed, with not even a hair on their heads singed or the smell of smoke on their clothing. Needless to say, this made quite an impression on Nebuchadnezzar who declared, "Blessed be the God of Shadrach, Meshach, and Abednego, who has sent his angel and delivered his servants, who

Understanding Reverse Mortgages: Dear Savvy Senior,

Can you give us a rundown of how reverse mortgages work? I've see actors Fred Thompson and Henry Winkler pitching them on TV, and they sound like a good deal. What can you tell me?

Need the Money

Dear Need,

When it comes to celebrity spokespeople pitching reverse mortgages on TV, don't believe everything you hear. Many of these ads are misleading and don't always give you the whole story. In fact, the Consumer Financial Protection Bureau recently issued a warning to seniors to watch out for these deceptive advertisements. With that said, here's the lowdown on reverse mortgages.

The Basics

A reverse mortgage is a unique type of loan that allows older homeowners to borrow money against the equity in their house that doesn't have to be repaid until the homeowner dies, sells the house or moves out for at least 12 months. At that point, you or your heirs will have to pay back the loan plus accrued interest and fees, but you will never owe more than the value of the house.

It's also important to understand that with a reverse mortgage, you, not the bank, own the house, so you're still required to pay your property taxes and homeowners insurance. Not paying them can result in foreclosure.

To be eligible, you must be at least 62 years old, own your own home (or owe only a small balance) and currently be living there.

You will also need to undergo a financial assessment to determine whether you can afford to continue paying your property taxes and insurance. Depending on your financial situation, you may be required to put part of your loan into an escrow account to pay future bills. If the financial assessment finds that you cannot pay your insurance and taxes and have enough cash left to live on, you'll be denied.

Loan Details

Around 95 percent of all reverse mortgages offered today are Home Equity Conversion Mortgages (HECM), which are FHA insured and offered through private mortgage lenders and banks. HECM's also have home value limits that vary by county, but cannot exceed \$625,500.

How much you can actually get through a reverse mortgage depends on your age, your home's value and the prevailing interest rates. Generally, the older you are, the more your house is worth, and the lower the interest rates are, the more you can borrow. A 70-year-old, for example, with a home worth \$250,000 could borrow around \$136,000 with a fixed-rate HECM. To estimate how much you can borrow, use the reverse mortgage calculator at reversemortgage.org. You also need to know that reverse mortgages are expensive with a number of fees, including: a 2 percent lender origination fee for the first \$200,000 of the home's value and 1 percent of the remaining value, with a cap of \$6,000; a 0.5 percent upfront mortgage insurance premium (MIP) fee, plus an annual MIP fee that's equal to 1.25 percent of the outstanding loan balance; along with an appraisal fee, closing costs and other miscellaneous expenses. Most fees can be deducted for the loan amount to reduce your out-of-pocket cost at closing. To receive your money, you can opt for a lump sum, a line of credit, regular monthly checks or a combination of these. But in most cases, you cannot withdraw more than 60 percent of the loan during the first year. If you do, your upfront MIP fee will be bui

The history behind German wind tunnels at AEDC

The story of the German wind tunnels at AEDC begins in July 1944 somewhere in the air over Germany.

That is when our Air Force bomber pilots first encountered high speed German aircraft flying without the aid of propellers. These jet aircraft were faster than anything in the skies and they tore apart many an allied bomber formation in the summer of 1944.

The German Messerschmitt ME-262 jet aircraft was just one technological breakthrough for Germany during WWII. Two other advanced weapons, the V1 and V2 missiles, appeared almost simultaneously with enemy jets. The German military fired thousands of the missiles across the English Channel at targets near London.

The most feared weapon was the V2 supersonic missile. The V2 arrived at a target without warning, carried a large explosive payload, and was virtually unstoppable. All three weapons were advanced beyond American technology with capabilities that rendered our ground test facilities inadequate. Had Hitler realized the full potential of this weaponry earlier, he could have mass produced them to win the war or sue for peace. These were the

V-1 buzz bombs and the devastation caused by the V2s. Realizing America had fallen behind in missile and jet technology, Hap ordered the confiscation of German weapons. Specifically, he wanted to capture an intact missile and have it reverse engineered in America. The operation was a success and led to America's first cruise missiles and long range rockets based on German technology.

In addition to capturing wayward missiles, Gen. Arnold sent a small team of scientists into Europe just behind the advancing line of our troops. Their mission, known as the Karman Mission, was to discover German Air Force technologies and locate the research facilities used for their advancement.

Mild mannered scientists disguised as high ranking military officers made their way into Europe searching for the German secrets. To be sure, the mission included an element of danger. There were armed pockets of resistance one could stumble across, and many German civilians, whose cities had been bombed to rubble, were Wattendorf learned that our Military Government in Germany had agreed to surrender the BMW vehicle plant to Russia, he recommended the quick dismantling of the jet engine facility.

The facility was crated up piece-by-piece and shipped to America before the Russians took any equipment. The crated plant, 42 train car loads, eventually made its way to Tullahoma, Tenn., where it was reused in our own AEDC Engine Test Facility. While many of the parts have been replaced over the years or are just no longer used, some of the original German parts, including two test chambers, are still used.

Another German wind tunnel found at Kochel, Bavaria, was capable of producing wind speeds in excess of Mach 4 and the Allied advance interrupted construction of a Mach 10 hypersonic tunnel at the same location. The captured tunnels were sent to the U.S. Navy laboratories at White Oak, Maryland, which is now a geographically separated AEDC facility. The original German tunnels remained in use at White Oak for some time. The T-1 supersonic tunnel was used for calibrations until 1997. American engineers used the captured plans from these tunnels to build our Gas Dynamics Facility later renamed the von Karman Facility. A third 18 x 18 cm supersonic tunnel from Kochel went to White Oak, but was given to the University of Maryland. Engineers took the basic plan of that tunnel and expanded it to build our 16foot supersonic tunnel at Arnold AFB.

none too cooperative. Dr. Theodore Von Karman, for whom the mission adopted its name, and his close associate Dr. Frank Wattendorf were two of the scientists scouring Europe to capture advanced weapons, research facilities,

and German scientists.

Dr. Wattendorf explained what he found, "The Germans kept these facilities very well secreted. One whole installationa complete, up-to-date aeronautical establishmenthad been built in the middle of a forest. The buildings all had trees on top of them so that, from the air, it just looked like a forest."

In Munich, hidden deep inside the Bavarian Motor Works (BMW) military vehicle plant, the scientists found the world's most advanced jet engine test facility. Here the Germans could test advanced jet propulsion units at simulated altitudes.

Because America had focused on mass production of existing technologies to win the war, we had not invested in testing facilities that could produce the quantity of air required by jet engines. When Dr. In addition to the tunnels, 8 German scientists came to AEDC and 12 more went to the Navy at White Oak. These scientists helped rebuild and operate these facilities. Dr. Wattendorf's suggestion to dismantle and reuse the German facilities to build a new Air Engineering Development Center for the USAF saved millions of dollars and about 10 years of design and planning.

With the coming cold war and the need for advanced jet aircraft and ICBMs, those 10 years were crucial for America's defense.



Cannon Co. returns to TSSAA

Returning to the TSSAA State Cross Country meet at Percy Warner Park in Nashville Saturday, November 7th for only the second time in school history, the Lionettes completed a very successful season recording a 12th place finish.

Last year, CCHS finished sixth in the Class A-AA 5,000 meter race, and were hoping for more of the same in 2015. The 12th place finish, out of 24 teams in the final overall standings, was led by Hannah Whited with a 26th place finish with a final time of 21:27.64.

"I thought they did great," CCHS head coach Marc Larson said after the meet. "It was a big accomplishment, and we had a bunch of girls have their best time at this course. They all ran their best. I was really proud of them. Whited and Elva Magana were making their third appearance at the event, while Alayna Reed made it two consecutive years. Samantha Gaither, Tyger Kennedy, Flor Magana, and Isabella Russo all made their debut at the state meet.

In 2014, Whited narrowly missed ranking in the State Top 10 with an 11th place, while Elva Magana was 68th, and Reed was 103rd.

2015 saw Elva Magana 99th (24:14.57) and Reed in 113th (24:42.65), with the remaining first timers completing the race with Russo in 61st (22: 41.65), Samantha Gaither in 132nd (25:22.77), Kennedy in 160th (26:56.15) and Flor Magana in 165th (27:28.72). "They settled them down by doing a shakeout run about an hour before," Larson said. "I think it gives the people who have run these races a chance to check in with the girls and tell them a little bit more

about this race. I think they were all in pretty good shape to run, and the people who ran before did a good job of getting them ready."

However, each of the members of the 2015 team had already raced the Steeplechase course during the season on October 8th in the Brentwood Invitational. At that meet, the Lionettes completed the race in third overall with Whited leading the way with a ninth place finish, while Russo also finished in the Top 20 in 17th.

A month later, with the state title on the line, the competition was tougher, but CCHS only competed against Class A-AA squads this time. The weather was perfect for running with temperatures in the cool 60s with cloudy skies and shower. The course was sloppy resulting in slowing their times from when last they ran. This course is known for its slow, rolling
