Commission heats up

Community grant raises tempers

Fourth of July is just around the corner but fireworks were already going off during the Cannon County Board of Commissioners meeting at the Cannon County Courthouse Tuesday (June 12).

The meeting, which lasted more than two hours, featured a heated argument regarding the status of a Three-Star Community grant, the passing of numerous budget amendments, and citizen concerns

ranging from mud bog traffic to the owner of the OK Shooting Corral "not being a good neighbor" to citizens in the Pleasant Ridge Community.

Item No. 19 on the agenda was "3-Star Confirmation Letter." This was a letter to verify Cannon County confirmed Cannon County government had taken action on certain items. Before a vote was taken, Commissioner Jim Bush recognized Corey Davenport in the audience.

Davenport, chairman

of the Republican Party in Cannon County and secretary of the Industrial Development Board (IDB), informed the Commissioners that Cannon County had lost a \$10,000 grant through the Three-Star Community Program due to what he called lack of cooperation from the County Executive's Office

Davenport had told the Commissioners that he had been in contact with Amy New, Three Star Director, and she had informed him Cannon County had missed out on a \$10,000 grant because of failure to meet an application deadline.

County Executive Mike Gannon had a completely different take on the issue.

Before the dust had settled, Davenport entered into a heated exchange with Gannon that required Chairman Mark Barker restoring order at least three times as he attempted to silence Davenport

"Corey, (Gannon) let you talk, now let him talk," Barker said.

Davenport told the Commissioners he had received a call from Rep. Mark Pody regarding the IDB missing out on a \$10,000 grant. That information was inaccurate and it was actually a \$10,000 grant for the Three-Star program.

"Amy New said she was trying to get the Three-Star Grant Program going in See HEATS on Page 9

Asphalt plant trouble slows down Hwy 70S

Trouble with an asphalt plant has caused a delay in completion of the four-lane project running from Warren County to a point outside of Woodbury, state officials said.

"The project's completion date is Sept. 30, 2014. It is true that the project is behind schedule because of some problems with an asphalt plant," said Jennifer A. Flynn, regional community relations officer with the Tennessee Department of Transportation.

"But we believe that these problems have been solved and the contractor has begun a push to try and make up some time," Flynn said.

During the next several months, multiple paving crews will be working on state Route 70S at all times, including weekends, she

said. "If the weather cooperates, they should make some good progress. We will know more later this summer about how much progress has been made and whether the original completion date can be met," Flynn said.

Once that link is complete, all that remains of the project is the route through or around Woodbury. Cannon County and the town of Woodbury have failed _ thus far _ to make an official recommendation on the project. Up for consideration are paths directly through Woodbury or either north or south of the town.

Last November, Wes Hughen, TDOT project manager, told county commissioners that Cannon County needs to make up their minds before funds See ASPHALT on Page 9

Are you confused by election lineup?

The upcoming Aug. 7 Cannon County General Election has some voters confused about two separate races, County Commissioner and County Road Commissioner.

"The County Commission has five districts with two seats in each district," explained Dorinda Mankin, Administrator of Elections. Voters will be able to vote for only two of the candidates listed in their particular district.

When it comes to the Road Commissioner race, all three zones are listed on each countywide ballot.

"You can vote in all three races," Mankin explained, no matter where you live in Cannon County.

Tuesday, July 8 is the last day to register to vote. The Cannon County Election Commission office is located at 301 West Main St. in room 244. Office hours are 8 a.m. to 4 p.m. Monday through Friday.

Early voting begins Friday, July 18 and continues through Aug. 2

Aug. 7 is election day. You must be registered to vote.

That's what's wrong with journalism today. We need more grumpy old professors armed with red grease pencils.

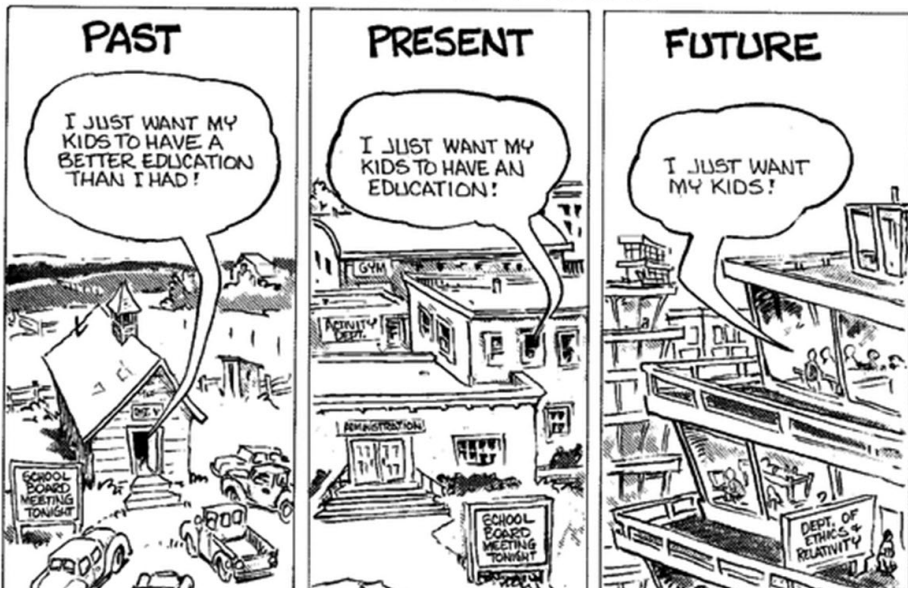

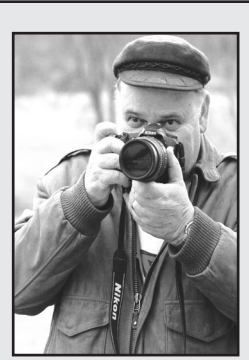
I realize that, compared to famine and pestilence and the designated-hitter rule, the over-use of "actually" is not that big a deal at the window of the world's Complaint Department.

Courier Columnist Father's Day: Good day for recalling glories from past

Daddy Whittle was a pistol and as his youngest child, he'd boast to his farm neighbor buddies... "Little Danny is my last golden bullet."

I didn't know what Daddy meant by that, but it made my little boy overall galluses swell with pride.

Daddy, the farmer, would get sweaty and dirty when toiling in the soil of our farm, but when plowing the fields, slopping the hogs and milking the cows were over, he got cleaned up and dressed nice, and not just on Saturday go-to-town nights.

"Your Daddy is a dude," is how farm neighbor boy Harold David Bryant assessed my father's image as he would oftentimes dawn his best suit and tie, especially in winter non-farming months.

When those fancy store-bought suits and highly-shined Buster Brown dress shoes came out, you could bet that Daddy didn't have farming on his mind.

That generally meant he was either headed to a funeral or over to nearby Cairo, Ill., where they had the Club 18 and floating riverboat casinos on the mighty Mississippi River.

You see, Daddy was a gambling man. I know these things, for Daddy sometimes used Little Danny as his excuse to leave the farm and go gamble in our little farm town's two hidden gambling rooms at Moore's Mercantile and Nath Hewitt's Barber Shop.

Mother, who didn't approve of Daddy's gambling, liked it when he took his youngest son to town, because that generally meant he wouldn't venture to Cairo, Ill., to do his most serious gambling.

I knew about Daddy's gambling up close and personal, for when he took Little Danny to town, that meant I got to sit on his knee while he played some serious "stud poker."

Daddy had two rules for Little Danny: "Don't say a word while I'm holding cards in my hands, and don't tell your Momma where we've been."

And I never violated Daddy's two gambling rules.

Although I was only 6 when Daddy perished in a grinding car crash on Oct. 25, 1950, I vividly recall Daddy's unusual sense of humor.

Sometimes during winter months, Daddy would earn extra cash by tearing down houses for rich folks who lived in nearby big city Sikeston, Mo.

One day, Daddy came home toting two

slightly-used commode lids. And since we knew he had been tearing down a house belonging to this Catholic family, Daddy let us young'uns go to town bragging that we now had two smooth-sitting Catholic commode lids in our outdoor shack out back at the end of the path.

Being 1947, it wasn't long before some neighbors, who hadn't been to our farm house in months, would show up either in their farm trucks or on wagons pulled by mules.

"We've never seen Catholic commode lids before," was how farm neighbor boy Kenneth Abernathy assessed our new farm outhouse status symbols.

"Why, they ain't coming to see us," assessed older brother, H. Van. "They're just coming to sit their fannies on our smooth-sittin' new-fangled Catholic commode lids."

Daddy's unusual brand of humor really surfaced in 1946, when this rich Sikeston family donated a dog to us farm folks. Being half bulldog and half German shepherd, needless to say it was one well-built stocky and stout-looking canine.

Coming in the wake of World War II, Daddy decided to name our new dog "Hitler," which drew some consternation from farm neighbor A.J. Neel.

"Why do you want to name him after that German tyrant Adolph Hitler, who doesn't deserve to have a good farm dog named after him," A.J. Neel pleaded.

"With a name like Hitler, he'll have to be one tough and mean dog to get through this world in wake of World War II," Daddy assessed.

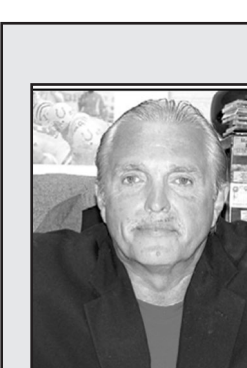
Well, the name must have worked for it was "Hitler" that Daddy credited with saving his life in 1949 when an enraged male boar hog took Daddy down out in the pasture.

Courier Columnist Jailhouse brawl: Ranks as matter of 'perception?'

A few months back, I went to a local jail to visit a good friend, at that time incarcerated for a driving infraction. It had been several years since I had visited anyone at this particular jail, so I had to re-acclimate to the current protocol for those visiting inmates.

The last time I'd visited someone at this jail—which was years ago—visitors and inmates could visit face-to-face in an open-space area, with a deputy/jailer monitoring the situation, of course.

However, due to increased attempts at exchanging contraband, weapons, and more egregious acts of violence (husband assaulting, and seriously injuring, a wife who just told the husband she's filing for divorce, for example), this jail, as have most others, had updated security measures regarding visitation.

As of my first visit to my friend at this jail, February 2014, here's how visitation was (and still is) set up: Once inside the jailhouse, I had to sign in on a "log" book. Next, I told the lady/secretary working in the front office, behind the Plexiglas window, the name of the inmate I wished to visit. The secretary then called a jailer to "bring up" the inmate out of his pod for visitation, which had been pre-scheduled, by the way.

After making the call, the secretary pointed straight ahead and instructed me to walk "that-a-way," take the "second door on the right," and go to "phone-D."

As I walked past the "first door" on the right, I noticed several people sitting in seats and talking on telephones—it then loomed obvious to me how visitation now worked: Via telephonic hook-up, the visitor and inmate could talk, while being able to see each other's face on a desktop-size computer screen.

As I entered the second door on the right—as instructed by the secretary at the front desk—there was only one lady in the visitation room, sitting at the first phone, talking to whom I took to be her boyfriend or husband. Around 6 ft. tall and 200 lbs., tattoos up-and-down both arms and on her neck, she was visibly angry and loudly

using some cuss words that would make even hardcore types blush!

After entering the visitation room, I walked past the large woman doing the cussing, and, again, as instructed by the lady up front, went to "phone-D," which was the last phone/slot in the visitation room.

The seat on which the visitor sits, while talking to an inmate, is a hard, round seat, similar in appearance to a round stool one would sit on at the counter of an old-timey soda shop. The biggest difference, though, the seat in this jailhouse visitation room was small—about 10 inches in diameter—with no back.

So, I casually plopped down on the small round seat with no back . . . and the next thing I knew: My butt landed on the concrete floor, pivoting me backwards, the back of my head hitting the concrete wall behind me, making a "cracking" sound, and adding me in the process!

As I rubbed the back of my head, and weakly rolled around on the floor, the large, tattooed woman jumped up from her phone, ran to me, and bent over to offer assistance, holding me by the arm.

About that time, a deputy walked by and assumed there was a "brawl" in progress! Reaching for his can of mace, he told us to "break it up!" I quickly told the deputy that I'd accidentally slid off the back of my seat and cracked my head against the wall, and the lady merely was trying to help.

The deputy realized such was the case, and proceeded to ask if I was "okay." I replied "yes," and he left the visitation room.

For me, it was good lesson in human perception: On first glance, it appeared that, indeed, there was brawl taking place inside the jailhouse visitation room, and, further—and even more embarrassingly—I was getting "whupped" by a woman!

Several other counties in Tennessee have County Government Websites and I will model our website based on the best ideas I find from the other counties. Example: www.coffeecountytn.org/.

2. I will require **full compliance with both the letter and the intent of the Open Government (i.e. Sunshine) Laws of the State of Tennessee** for all County Government meetings, actions and decisions; including, the publication of a notice of meeting, identifying the Title of the Government Entity holding the meeting, the names of the voting members and/or public representatives expected to attend the meeting, and a complete agenda of the topics to be discussed and/or decided at that meeting. These Public Notices shall be published in the Cannon Courier (print and web), advertised through WBRY (radio and web), and posted on the Cannon County Government Website at least ten (10) days prior to the date of the meeting. Any additions, deletions or modifications of the agenda will be announced no later than five (5) days prior to the meeting, using the same methods of distribution / notification listed above. The minutes of each of these meetings will be posted on the Cannon County Government website with copies furnished to the press.

3. I will prepare and post a **Weekly Activity Report** on the Cannon County Government website and furnish copies to the local press. The Weekly Activity

Report will include the status of actions being worked by your County Government, a list of current contract solicitations, contract award announcements, a list of upcoming County Government Meetings, and other information regarding actions the County Government is taking to enhance the **Quality of Life and Opportunities** for the Citizens of Cannon County.

4. In addition to the Cannon County Government Website, I will establish an **On-line and Telephonic Forum** for citizens of Cannon County to submit ideas and recommendations for enhancing **Opportunity, Quality of Life** and the **Operation** of county government and services; ask questions; voice concerns; identify issues; and engage in the development of viable solutions to issues facing Cannon County. This forum will enable **greater opportunity for interaction between Cannon County Government and Citizenry**.

5. I will host **Monthly Community Forums** for the Citizens of Cannon County to submit their concerns, complaints, and ideas for improving **Quality of Life and Opportunities**. Legislation sponsored by Beavers protecting electronic privacy rights signed into law

Legislation sponsored by Senator Mae Beavers (R-Mt. Juliet) prohibiting state and local police agencies from accessing or retrieving the location data of residents by surveillance of an electronic device without a court warrant was recently signed into law. Governor Bill Haslam signed the bill at a ceremony last week in Nashville. The new law helps to ensure the government does not take advantage of technological advances in cell phones, laptops and other electronic devices to spy without appropriate judicial oversight.

"This helps to ensure that the government does not trample on the constitutional rights of our citizens as technological advances have changed the way in which the government and law enforcement agencies collect information," said Senator Beavers. "We must

have checks and balances as put into place by our founding fathers through judicial oversight to keep the government from overstepping its bounds."

Law enforcement made 1.1 million requests to wireless carriers for cellphone data information in 2012 according to a report delivered to Congress in December. The three largest wireless companies, AT&T, Sprint and Verizon reported they have received 56,400 "emergency" requests from police departments which did not have a warrant or court order. One company reported their requests from police have doubled in the past five years.

In addition, public records obtained by USA Today and Gannett reveal that about one in four law enforcement agencies in the U.S. have used "tower dumps." This is a surveillance tactic which

covers multiple towers and wireless providers to give police a multitude of electronic data about a targeted cell phone user. The digital dragnets also capture information on other persons using wireless devices in the area who are not suspected of wrongdoing.

The electronic privacy bill, which is modeled after a Montana law, allows exceptions in order to respond to a possible life-threatening situation, an emergency call by the user, when a device is reported as stolen, or other exigent circumstances, unless there is informed consent by the owner. The legislation prescribes a Class C misdemeanor for violation.

"Law-abiding citizens should not be subject to this kind of overreach of government power," added Beavers. "I am pleased this bill is now law in Tennessee."

After the hoopla about the implementation of the Affordable Care Act last winter, many people never want to think about health insurance again. But others who have health insurance for the first time are just learning to use their new policies and services. In case you are in the latter category, you may still be confused by the health insurance landscape, which can be very complex.

Health insurance is essentially a contract between you and an insurance company designed to protect you from health care expenses exceeding what you might be able to pay out of your pocket. In the contract, the health insurance company specifies the percentages or amounts of charges they will pay and how much will be your responsibility for different health care services.

These are some of the terms and definitions associated with health insurance:

"The amount the insurance company charges you for a policy is called the premium. The premium is determined by the level of coverage you have—generally, the more medical expenses that are covered by the insurance company, the higher the premium. (The Affordable Care Act requires that all policies now cover at least 60 percent of expenses.)"

"The deductible is the amount that you must pay for expenses other than preventive services each policy year before any insurance coverage kicks in. The Affordable Care Act designates which basic preventive services are covered by your premium with no deductible. Preventive services may

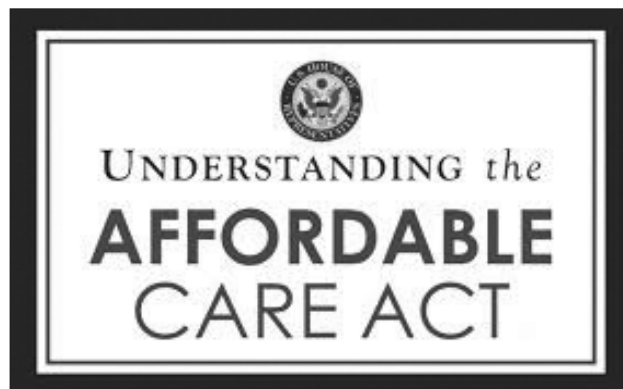

Understanding your new health insurance



include annual physicals, immunizations and screenings that can keep you from getting sick.

"For every medical service not a part of your preventive care, you will be charged a co-pay (co-payment). A co-pay is a fixed fee (such as \$15) that you are asked to pay, usually at the time of service. The co-pay is subtracted from the amount filed with your insurance company. The amount may vary from doctor to doctor.

"Coinsurance is the percent of the cost of covered health care services paid by consumers. The level of coverage you have determines your coinsurance. For example, your coinsurance at different levels might be 10, 20, 30 or 40 percent. Obviously, a policy with 10 percent coinsurance would have a higher premium than a policy with 40 percent coinsurance.

"The Affordable Care Act places a cap, or limit, on your out-of-pocket expenses, currently at \$6,350 for one person and \$12,700 for a family. If you reach that amount, then deductibles and coinsurance will no longer be charged, although you will continue to pay co-payments.

"A claim is a request for payment that a consumer or healthcare provider submits to the health insurance company for

items or services rendered.

For example, once you have completed a doctor's appointment, the doctor's office will submit the information to your health insurance company to process (if the doctor is an out of network provider you may be responsible for submitting the paperwork to the insurance company yourself). The health insurance company will make a determination and send payment to your healthcare provider if applicable. The insurance company will also send a claim statement to you for your records explaining what services were covered.

"An allowed amount is the maximum amount allowed to be paid for covered health services by a health insurance company. This may also be called "eligible expense," "payment allowance," or "negotiated rate." In most cases your doctor will accept the allowed (maximum) amount paid

by the health insurance company as 'paid in full' and you will not be responsible for the difference.

"Balance billing is when the provider bills the consumer for the difference between the provider's charge and the amount allowed by the health plan. For example, if your doctor does not accept the maximum allowed then you may receive a bill from them charging you the difference between the doctor's charge and the maximum allowed by your health insurance company. You will then be responsible for making this payment.

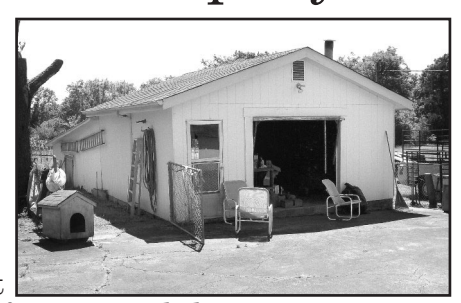

Cat owners must beware of cytaux

All cat owners need to be aware of an infection that is occurring all too often to cats in Cannon and surrounding counties.

The infection is called cytauxzoonosis (common name is bobcat fever). The infection is a protozoal agent that harbors in bobcats. It is picked up from the bloodstream by a tick. The tick falls off and attaches to a wandering feline.

The cat then slowly develops a systemic infection and soon becomes extremely ill. To my knowledge all infected cats that are untreated will die.

If treatment is started early in the infection the cure is about 60 percent. The only defense against the disease is using a tick preventative since there is no preventative vaccine. All cat owners should be aware and seek veterinary treatment is their cat shows any symptoms, such as lethargic, not eating, moving slow, high fever, just lying in one spot and not getting up.

This is a very serious disease that will result in death if not handled correctly.

Cannon County," Davenport told the Commissioners. "She said 'I am getting no response from the County Executive's Office and I can't get anything done.' She also said we were the only county in the UCD that did not apply for this grant and that we had lost it. She said (Cannon County) was the only county that lost its grant. We can't get that back for any reason."

Davenport also reported that Cannon County was Three-Star certified; however, he said that could also be in jeopardy, according to New.

Following Davenport's report to the Commissioners, Gannon tried to explain that Cannon County did receive the grant.

"The reason we didn't originally apply was because we still had \$7,000 in hold on the previous grant," Gannon said. "We can't apply for more until that has been used."

That's when the fireworks started.

"That is not what (New) told me," Davenport said.

"I work with Amy New's office often," Gannon said.

"That is also not what she told me," Davenport said.

"I don't know who you are talking to," Gannon said.

"Her," Davenport said.

"I know what I am talking about and we are not de-certified," Gannon said.

"That's funny because I have e-mails (suggesting otherwise)," Davenport said.

"Would you let me talk?," Gannon asked.

"No," Davenport said. "You work for me."

At that point, Chairman Barker told Davenport to allow Gannon to talk.

"We will have order,"

Barker told Davenport. "We are not going to have this back and forth exchange."

"We are not decertified," Gannon said.

"You can't get the \$10,000 grant," Davenport said.

"I just told you the (grant) is for exercise equipment," Gannon said.

"No, that was for last year," Davenport said.

"I am not going to argue with you," Gannon said.

"I know. You can't because I am right," Davenport said.

As it turns out, follow-up indicated Gannon was accurate.

The Cannon Courier contacted New's office Wednesday to verify this information.

Correspondence then began with Laura Elkins, who is communications director for the Tennessee Department of Economic and Community Development.

Elkins said Cannon County was not in jeopardy of losing its Three-Star certification. She also said the rural development team "has been in contact and is working with (administrative assistant) Diane Hickman in the Cannon County Executive's Office."

Davenport told the Commissioners "Cannon County lost out" and "could not" receive this grant; however, Elkins said Cannon County had applied for the grant and will be receiving \$10,000.

Davenport provided e-mails between he and New from previous months to support his claim. Those e-mails suggest Cannon County had originally missed a deadline to apply; however, Rep. Mark Pody was instrumental in getting an extension in April.

Gannon said a required reading was going to take

place at the May County Commission meeting; however, only four commissioners were present and the meeting did not take place due to lack of a quorum.

Davenport contends Cannon County would have lost the grant if not for Pody's assistance in getting an extension in April. On the other hand, Davenport told the commissioners Cannon County had lost the grant and could not "get it back" at the June meeting - two months after Pody had sought an extension.

"The majority of the credit belongs to Rep. Pody for making an extra effort on behalf of Cannon County and its citizens by reaching out to the Commissioner of the Three-Star Program and asking for an extension to re-apply for the \$10,000 grant, even though the deadline had passed," Davenport said.

"With Rep. Pody's involvement it is my understanding that Cannon County would have in fact lost the grant."

Davenport did not tell the commissioners about an extension or Pody's involvement at the June meeting, only that Cannon County had lost the grant.

Earlier in the meeting Gannon had informed the Commissioners there was \$7,000 remaining from the previous grant. He had originally wanted to approach the commissioners about using the grant money for exercise equipment for citizens of Cannon County. Instead, Gannon asked the commissioners to allow him to donate the \$7,000 to "We Care Cannon." The commission approved the request unanimously.

We Care Cannon is a non-profit organization that provides free backpacks, school supplies, haircuts, and other back-to-school necessities.

Gannon's contention is Cannon County could not apply for the additional grant funding until it had used the \$7,000 remaining from the previous grant. His office was already working with New on the issue. By donating the remaining grant money to We Care Cannon, Cannon County could apply for the current grant with the extension.

Davenport said the matter is over as far as he is concerned.

"The matter is finished and I hope that more diligence will be given by (the County Executive's) office to any grants that are available for the citizens of Cannon County in the future."

Gannon said the County Executive's Office is always diligent in its pursuit of grant money for Cannon County. He pointed out Cannon County recently obtained a HOME grant of nearly \$500,000 to assist low-income families with housing needs.

"Diane Hickman and our office do a tremendous job and we have been on top of this," Gannon said. "We are always looking out for our citizens. Despite what was reported to the commissioners, we have not lost that grant. In fact, we are getting it."

Gannon said he would like the County Commission to consider using the funds for exercise equipment that would be used by Cannon County citizens at a to-be-determined location.

discussion regarding the OK Corral Shooting Range located in the Pleasant Ridge Community and owned by Grady Parker. Under new business, Commissioner Kevin George said he had been receiving complaints regarding shooting in the late evening.

Pleasant Ridge resident Gene Mason and his wife were in the meeting and George asked Mason if he would like to comment. Mason told the commissioners the noise was a problem and shooting takes place all hours of the day and into the evening.

Mason asked for compromise on behalf of

neighbors in the community.

Commissioners discussed many options including allowing no shooting during specific hours in the evening and also to adjust range times seasonally. There was also discussion to draw up a nuisance law.

The final decision was to send to letter to Parker asking him to attend the July meeting of the County Commission in order to address the issue and work out a compromise.

Dalinda Parton addressed the commissioners regarding mud bog traffic on Pleasant View Road. She says it is a problem that needs to be resolved.

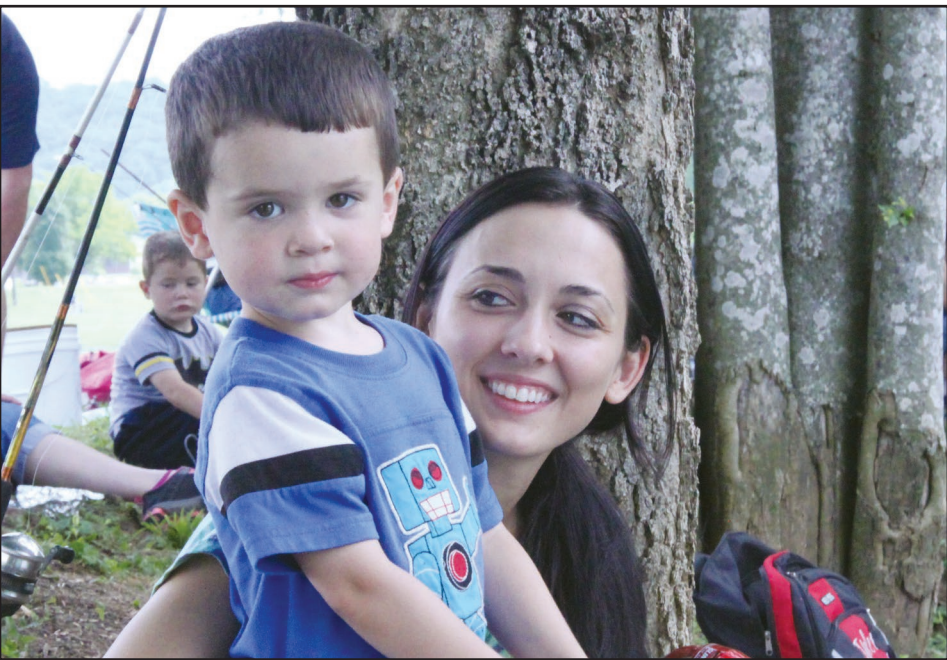

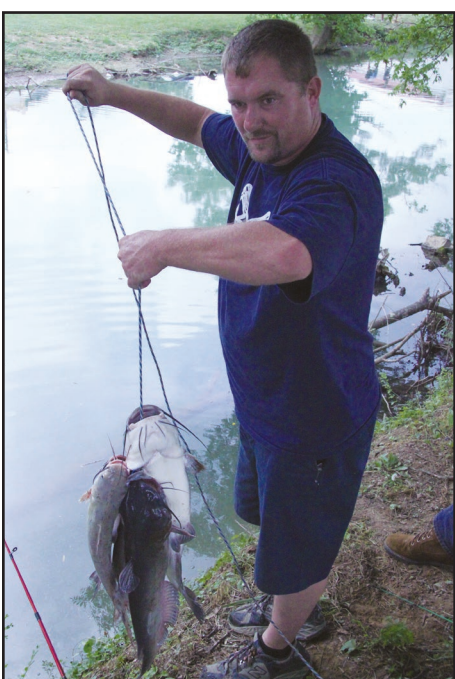

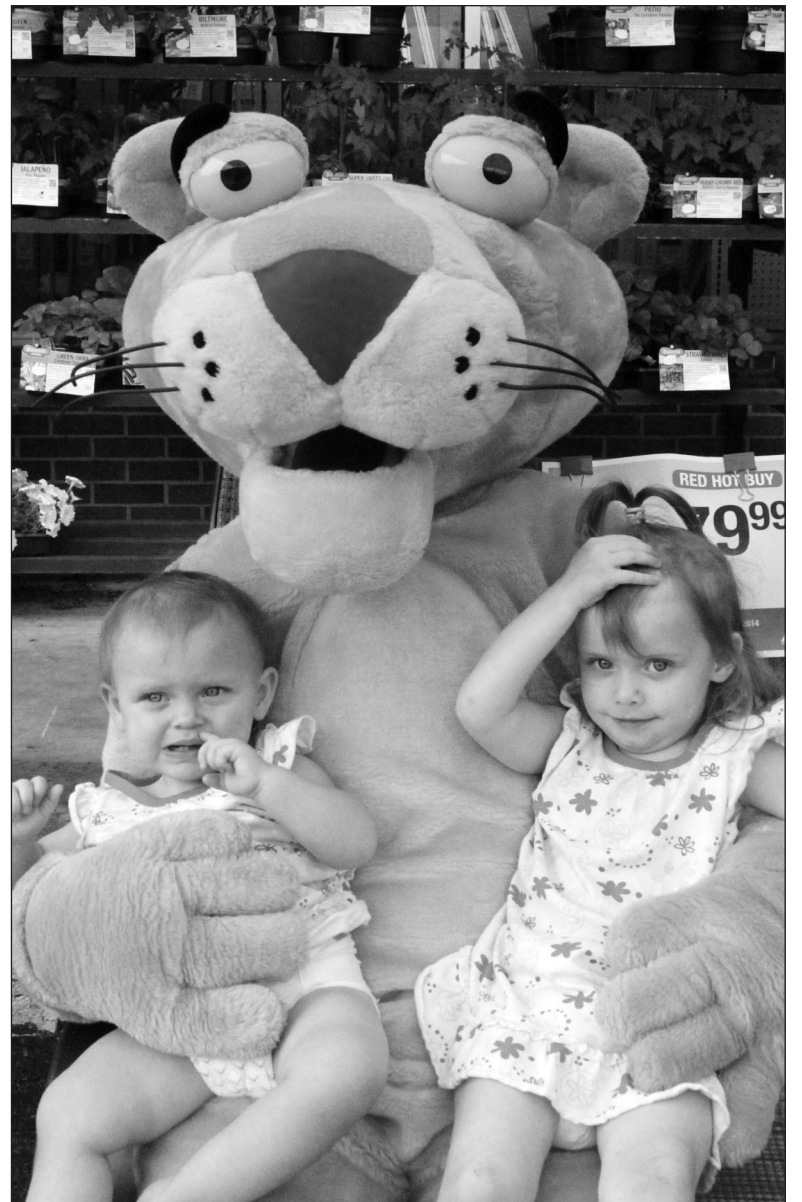

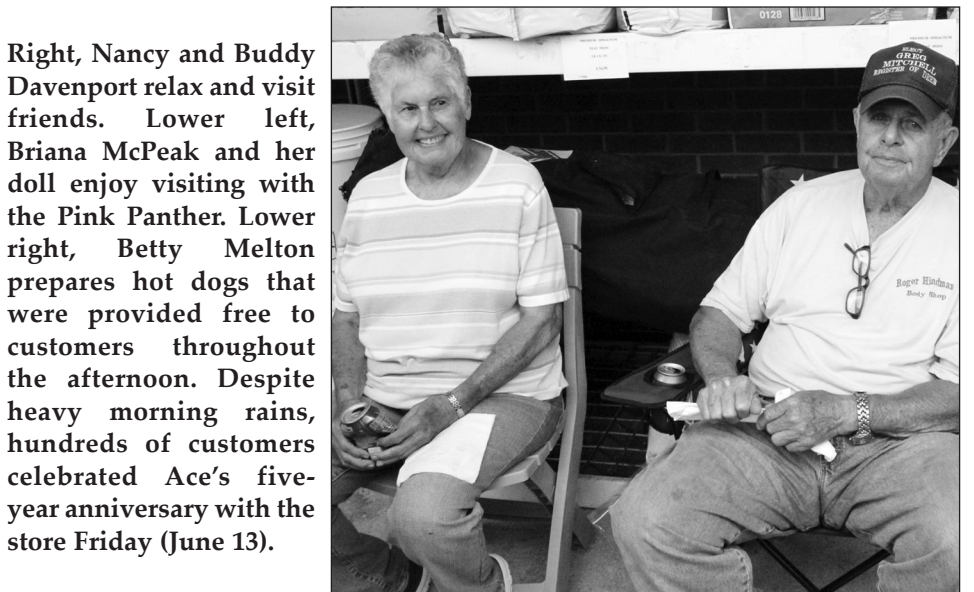

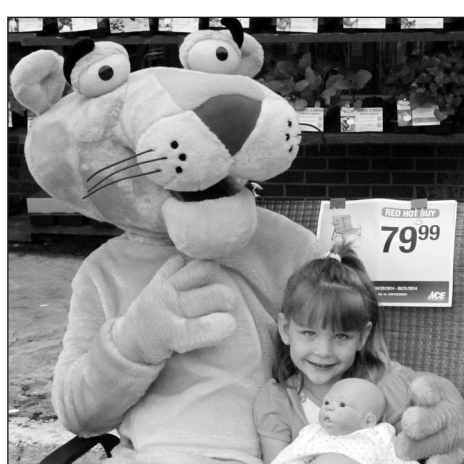
