Cannon unemployment drops to 7.4%

The unemployment situation in three-quarters of Tennessee's 95 counties continued to improve in July following business closures earlier in the year due to the COVID-19 health emergency.

Seventy-two counties had lower unemployment in July compared to the previous month. Rates in four counties mirrored their rates from June. Nineteen counties did experience a slight uptick in unemployment during the month. Cannon County's unemployment rate was among the counties whose unemployment rate dropped in July.

Cannon County people eligible for work were unemployed. This gave Cannon a 7.4 percent unemployment rate figure for the month of July which was a 1.5 percent decrease from June's 8.9 percent figure. A year ago, however, Cannon had a 3.8 percent unemployment rate.

All surrounding counties dropped in their unemployment rate for the month of July as well. Rutherford reported a 9.1 percent unemployment rate. Wilson County's unemployment rate for the month of July is 9 percent. Warren stands at 9.9 percent. Coffee County reported 8.7 percent and DeKalb was the highest of the surrounding counties at 10.3 percent.

The statewide seasonally adjusted unemployment rate in Tennessee decreased for the third consecutive month in July from 9.6% to 9.5%.

Out of an estimated workforce of 6,098 people, 5,646 were employed while 450
