Celebrating 70 years

Ann and Bryson Johnson celebrated their 70th wedding anniversary on October 18, 2023. The couple have been members of the Woodbury Seventh-day Adventist church since 1992 and have been an invaluable fixture there for the past 31 years.

Bryson was born in 1930 and grew up in Bowling Green, Kentucky. He was the youngest of 13 children and was baptized into the Seventh-day Adventist church in 1944. Ann, the next to youngest of six children, grew up in Indiana and was also baptized into the church as a child. The two met at Highland Academy when Ann was a freshman and Bryson was a senior. They stayed in touch through letters after Bryson graduated and joined the military. Over the next two years, Bryson wrote Ann over 600 letters.

While in the army, Bryson spent 14 months in Korea. When he was discharged from the service, he went to Indiana, where he reconnected with Ann, and the two were married on October 18, 1953.

Bryson and Ann spent the first part of their marriage in Nashville, Tennessee, where Bryson worked for Southern Publishing as a bookbinder and an assistant foreman, and Ann worked as a registered nurse. They had two sons, Danny and David. In the 1980s, the

family moved to Hagerstown, Maryland, where Bryson worked for Review & Herald. When Bryson retired in 1992, the couple moved to Woodbury where Ann's sister and brother-in-law, Macy and Martin Davis, had been living.

Woodbury and the Woodbury Seventhday Adventist church have been a large part of the couple's lives. Over the years, Ann served as head deaconess and taught Cradle Roll, Kindergarten, and Primary Sabbath School classes. Bryson served as head deacon, and the couple served together as board members for the church school. Bryson and Ann have always taken a special interest in keeping the church and school beautiful. They have taken part in church beautification projects and managed flowerbeds at the church and the school every spring and fall since 1995.

The couple credits their years of staying together to the church. When asked what marriage advice they would give, they said, "Settle differences with the Lord's help" and "Always love each other." The couple, who now have three grandchildren and four greatgrandchildren, enjoy bird watching and traveling. They continue their legacy in Woodbury through faithful church attendance and support, church beautification projects, and delicious potluck dishes.

had her game plan laid out. It's the same plan she approaches any hurdle in life. She also uses it to advise other women who joined her in her path of fighting cancer. "Never focus on yourself. Pray, pray, pray and never give up," she said. "Have a purpose and do for others.

Her support group consisted of her family. They also stayed strong as a result of her inspiration. The road was rough through all the radiation treatments and the partial breast removal surgery. Then, to top it all off, Hale contracted the COVID-19 virus shortly after her surgery. Nothing stopped the determined 76-year-old though.

The light at the end of the tunnel produced a cancer free diagnosis in 2022. "Every morning when I was going through radiation, I told my doctors 'God's got this'," Hale said. "Radiation would have been a tough thing to go through, but it was okay for me. Dr. Lee, the radiation doctor, saw me every Tuesday. He was so excited because I followed his directions and he'd tell me how well I was doing. I don't have any scars or anything."

Smith also added, "I know Stella was probably a highlight of their day just like she is for me. If she's anything with them like she is with me, it's a joy to see a patient like Stella who has a great outlook.'

She has withstood not only cancer with a positive attitude, she also has depended on her faith to help her through cancer diagnoses in other family members, reunifying with family members, and going through other members who passed away.

Because the need for early detection is so important. Ascension Saint Thomas Stones River put in a 3-D mammogram machine. "As a provider it opened the door for more screening opportunities," said Smith. "I did give them a call, as I was interested to see about on average how many clients they screen, and they told me about 350 a year."

The new 3-D technology takes it to another level and makes getting a mammogram a significantly less uncomfortable experience than the older 2-D models.

Smith's office follows the US Preventative Service Task Force (USPSTF) recommendations. She also stresses the importance of the yearly screenings and mammograms. "You can complete a mammogram without a doctor's order. They will ask you if you have a partner physician we can send the results to. You need a partner in case something happens," she explains. "It's why we see you when you're sick, but lets us see you when you're well because one of these days you're going to need us and we want to know what you look like well."

Smith recommends a website which helps those who are underinsured or uninsured afford a mammogram. "The site is called mdsave.com. People can search their local zip code, pick a facility they can go to, and it will tell a person what the exact costs for specific services.'

There are recommendations of reducing breast cancer risks according to the world renowned Mayo Medical

Clinic. To lower risks, they suggest:

Limit alcohol. More alcohol you drink, the greater your risk of developing breast cancer. The general recommendation based on research is to limit yourself to no more than one drink a day as even small amounts increase risk.

Maintain a healthy weight. If your weight is healthy, work to maintain the weight. If you need to lose weight, ask your doctor about healthy strategies to accomplish this.

Be physically active. Physical activity can help you maintain a healthy weight. The recommendation is for healthy adults to participate in at least 150 minutes a week of moderate aerobic activity, or 75 minutes of vigorous aerobic activity weekly plus strength training.

Breast-feed. Breast feeding might play a role in breast cancer prevention. The longer you breast-feed, the greater the protective effect.

Be vigilant about breast cancer detection. If you notice any changes in your breasts, such as a new lump or skin changes, consult your doctor. Also, ask your doctor when to begin mammograms and other screenings based on your personal history

If you are diagnosed with cancer remember Stella Hale's tips, including figuring out your purpose along with being positive.

"I had a purpose of helping others who already had cancer and it played a major part in helping me overcome it," she stated.
