RESOLUTION 2023-25

LEVYING ADDITIONAL SALES AND USE TAX IN CANNON COUNTY

WHEREAS, the official tax rate of the County is the number used by the State of Tennessee to determine the equitable division of sales tax revenue in Cannon County and the cities within Cannon County; and,

WHEREAS, The State of Tennessee recognizes the official Cannon County local option sales tax rate as 1.75%, the rate previously set by the Cannon County Board of Commissioners by Resolution Number 130 of April 14th, 1984, and;

WHEREAS, the Cannon County Board of Commissioners, in an attempt to ensure the continuation of equitable distribution of tax revenue for the benefit of all citizens residing within the unincorporated portions of Cannon County, Tennessec, seeks to alleviate the need for sizable future increases in the Cannon County property tax rate.

THEREFORE, BE IT RESOLVED that the Cannon County Board of Commissioners hereby proposes to levy and set a local option sales and use tax at a rate of 2.75% and directs the Cannon County Election Commission to place upon the ballot in the next regularly-scheduled election for a vote of "For" or "Against" by all voters of Cannon County the following: "Resolution No. 2023-25, passed by the Cannon County Board of Commissioners, setting the local option sales tax rate at 2.75%, shall become operative."

SECTION 1. The resolution of the county legislative body of Cannon County.

Tennessee, imposing a local sales and use tax as authorized under the provisions of *Tenn. Code Ann.* §§ 67-6-701-712, adopted by the county legislative body at a regular metting of record is amended to levy a local sales and use tax at a rate of 2.75%, not to exceed the maximum percentage as stated in the RETAILERS TAX ACT. *Tenn. Code Ann.* § 67-6-702, as amended, except as limited or modified by statute.

SECTION 2. If a majority of those voting in the election required by *Tenn. Code Ann.* §

67-6-706 vote for the increase in the tax imposed by this *Resolution*, collection of the increased tax levied by this *Resolution* shall begin on the first day of the month occurring thirty (30) or more days after the county election commission makes its official canvass of the election returns.

SECTION 3. The Department of Revenue of the State of Tennessee shall collect the additional tax imposed by this *Resolution* concurrent with the collection of the state tax and the

local tax now being collected for Cannon County, Tennessee, in accordance with the rules and regulations promulgated by said Department.

SECTION 4. The Cannon County Executive is hereby authorized to contract with the Department of Revenue for the collection of the additional tax imposed by this Resolution, and to provide in the contract that said Department may deduct from the tax collected a reasonable

amount or percentage to cover the expense of the administration and collection of the tax.

SECTION 5. In the event the tax is collected by the Department of Revenue, suits for the recovery of any tax illegally assessed or collected shall be brought against the Tennessee Commissioner of Revenue and the Cannon County Executive.

SECTION 6. A certified copy of this Resolution shall be transmitted to the Department of Revenue by the Cannon County Clerk forthwith and shall be published one (1) time in a newspaper of general circulation in Cannon County, Tennessee prior to the election called for in Section 2 herein.
