One (1) 13CFM 6KPSI 10HP Open Vertical Compressor/Purifier configured for 13.0 scfm, 6000 SPIG, 4-Stage compressor, 10hp single phase motor and 67,000 scf capacity purifier, integrated purification system that meets NFPA 1989 requirements for firefighting and CGA Grade E air for SCUBA, purifier includes steel mechanical separator chamber, as well as purifier safety vent port to prevent operating system w/o cartridge. Standard with long-life, well-cooled, oil-pressure lubricated compressor block with stainless steel intercoolers, high-temperature and low oil pressure shutdowns. Mounted pressure gauges or oil, final stage and purifier. Must include PLC, lighted on-off switch, hour meter, emergency stop button, safety over-time timer, motor controls/protection and UL rated electrics. Must include auto condensate drain system with timed automatic drain, including silencer and collection reservoir and user display indicator if full. MTD Interstage pressure gauges securus purifier monitor system with built-in, continuous monitor for purification cartridges. Must include user display indicators for safe high moisture, cartridges expired and contact fault. Must include automatic system shutdown for faults; fail-safe (cannot be over-ridden); no warm up required.

One (1) Two position CFS equipped with inlet pressure gauge adjustable regulator, regulated pressure gauge, fill control valve and fill pressure gauges.

One (1) cascade system, 6000psi, 4 cylinders with interconnecting plumbing with fill house

One (1) monitor, carbon monoxide, includes control panel and test gas

One (1) single high-pressure air test kit to be taken at time of start up by installing technician.

One (1) cascade 6000psi slide in unit with 4 cylinders, equipped to cascade portable SCBA cylinders. All gauges, fill lines, and safety cage included.
