Cannon County have been awarded a Tennessee Housing Development Agency HOME Rehabilitation grant for the purpose of improve the safety and structural correctness of homes. Applications will be taken for those interested in improving their homes at the Cannon County Courthouse on Thursday, October 13, 2022 at 5:00 p.m..

To be eligible you must have owned your home for a period of one year and presently live in the home. You must be low-income (information on income guidelines will be available). In addition, your home must need repairs to bring it up to local standards. This is not a remodeling program and only those in need will be considered for this grant.

• A copy of your homeowner's insurance which provide the amount of your coverage.
