Commission holds final meeting

The Cannon County Commission held a final meeting before the end of the fiscal year Monday, June 29th to approve the usual budget amendments. County General, and County Schools had budget amendments all approved by the commission. The special called session ended with an annual report by audit committee chairman David Faulkner. According to Faulkner, the audit committee held one public meeting this year. Due to COVID-19, the committee, comprising of Faulkner, Jennifer Coppinger, and Donna Williams, performed an electronic review of the Annual Financial Report

of Cannon County. The group developed a plan of action to address the findings during March and April 2020. The public meeting, called on June 9th, was to discuss with the county executive, sheriff, and the director of finance the sole finding of the state audit that competitive bids were not solicited for food and custodial supplies at the jail. Diane Hickman, County Finance Director, explained the actions they had taken to resolve this issue may have been identified too late to be included in the 2019-2020 fiscal year and may reappear. However, it should be remedied for the 2020-2021 period.

The Cannon County Board of Commissioners will meet in regular session, Saturday July 11, 2020 at 10:00 A.M in the courtroom of the Cannon County Courthouse.
