Homeless man faces 17 criminal charges

According to the booking report, 49-year old Larry Todd Montgomery, who is listed as homeless, was arrested July 29th by Cannon County Sheriff's Department (CCSD) and charged with eight counts of aggravated statutory rape, three counts of contributing to a minor and six counts of sexual battery by an authority figure. His bond has been set at \$230,000.

was arrested July 30th by sheriff's deputies and charged with manufacture, delivery, sale and possession of schedule II methamphetamine and unlawful use of drug paraphernalia. Nunley was released later the same day on \$13,000 bond.

*Jesse Dale Burgess of Ricon, Georgia was arrested July 31st by CCSD and charged with violation of probation. He is currently being held on \$5,000 bond.

*Micah Lee Crowley of Murfreesboro was arrested July 31st by Tennessee Highway Patrol and charged with driving under the influence 2nd offense and driving on revoked, suspended license. Crowley was released August 1st after posting \$4,000 bond.

*Daniel R. Matheny of Woodbury was arrested August 1st by CCSD and charged with vandalism, simple possession, casual exchange and aggravated assault. Matheny was released August 2nd after posting \$13,500 bond.

Other arrests made from July 28th - August 3rd:

*Caitlin Elise Wesenberg of Woodbury was arrested by the Woodbury Police Department (WPD) and charged with driving under the influence, assault and resisting arrest. She is currently in jail on \$4,000 bond.

*Sharon Lynne Haley of Woodbury was arrested July 29th by WPD and charged with domestic related assault, child abuse and neglect. Haley was released August 3rd after posting \$8,000 bond.

*James Lee Heath of Woodbury was arrested July 30th by CCSD and charged with violation of probation.

*Eric Cox pled guilty to casual exchange schedule VI drugs. He was placed on probation for 11 months, 29 days, ordered to pay \$250 fine and court costs and undergo drug screens. A charge of unlawful possession of drug paraphernalia was dismissed.

*Scottie Lee Young entered a no contest plea for a domestic assault. He was placed on probation for 11 months 29 days, ordered to pay court costs and undergo a DVI assessment.
